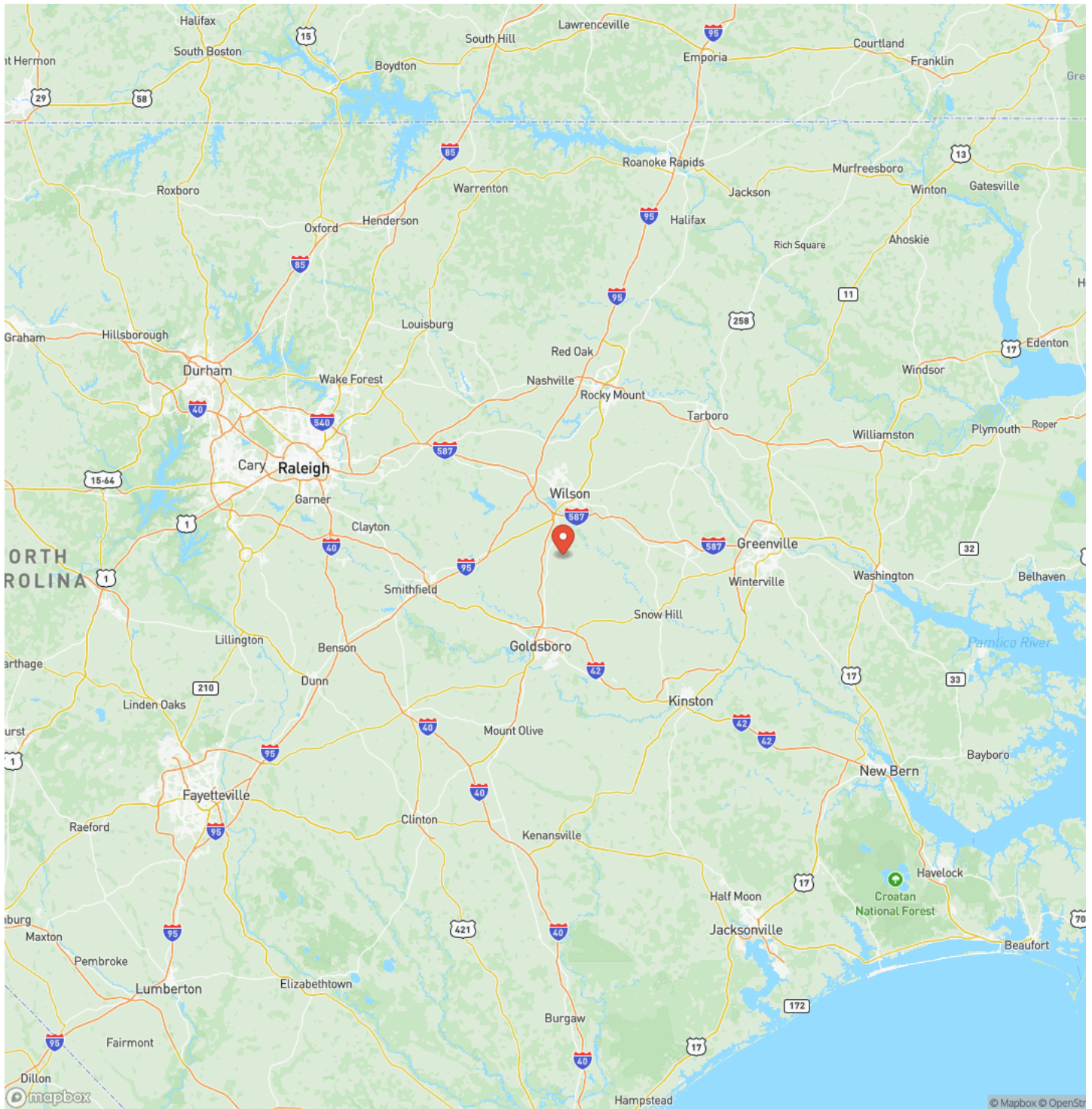


Locator Map



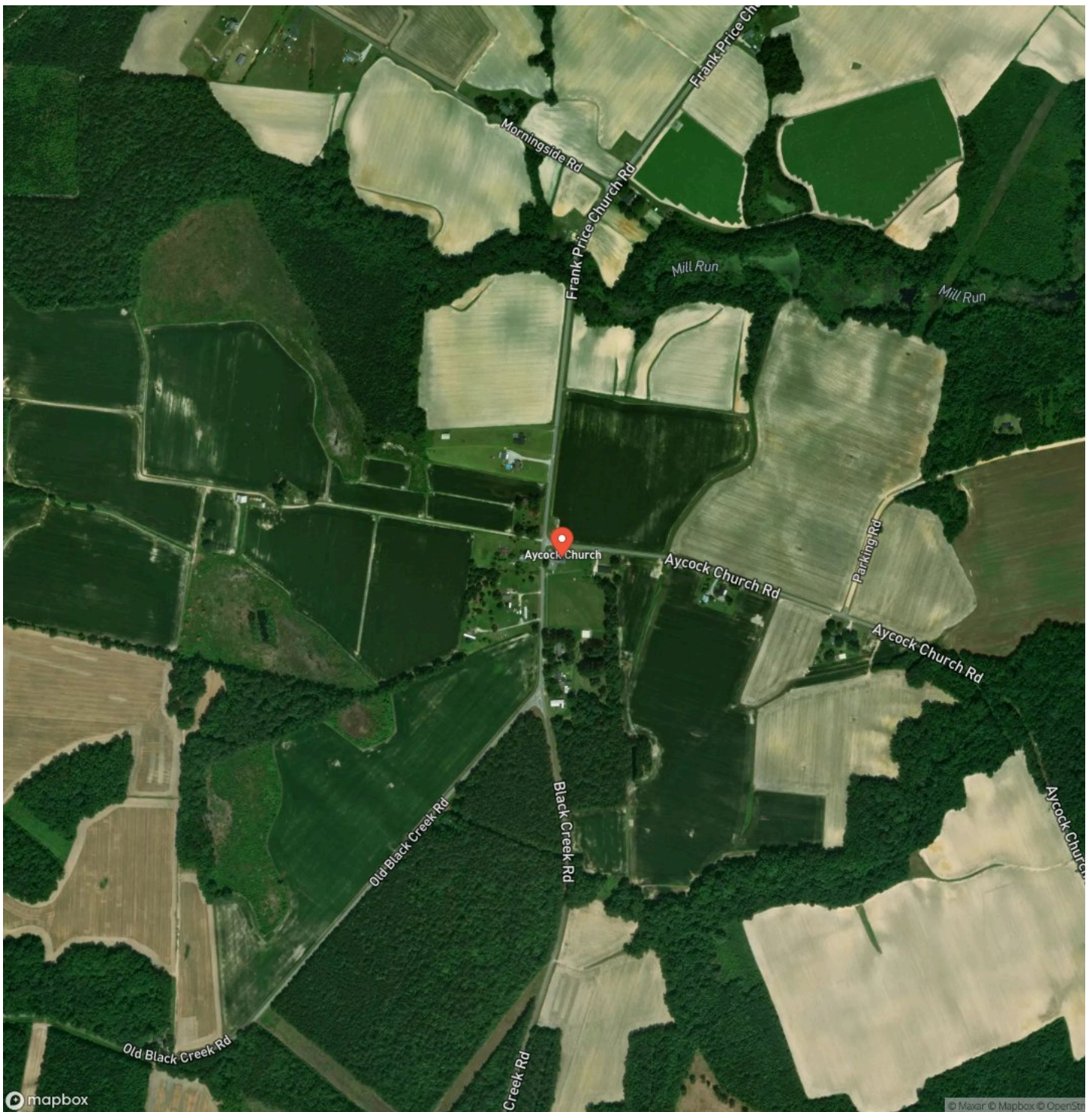
