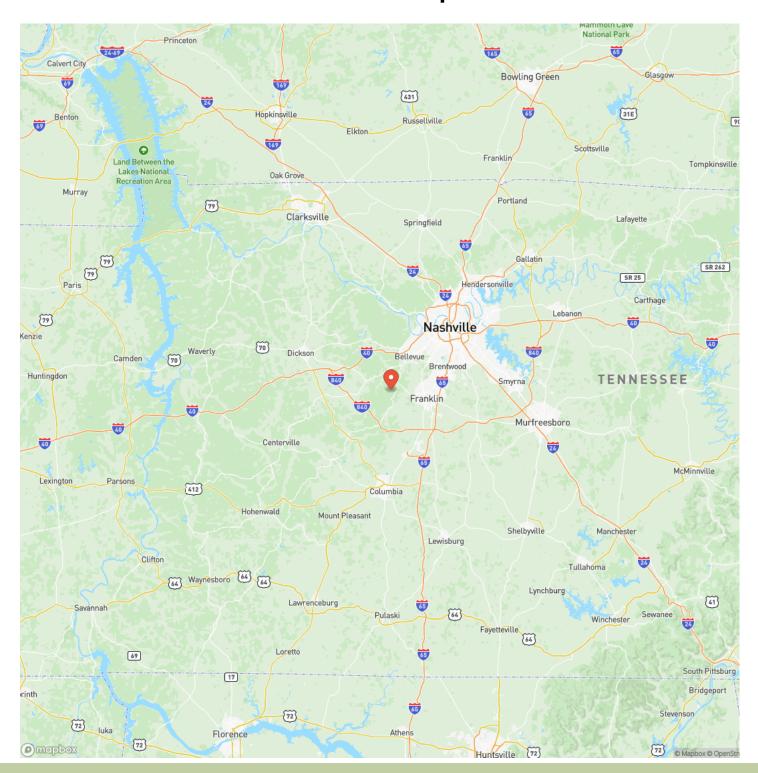


Locator Map





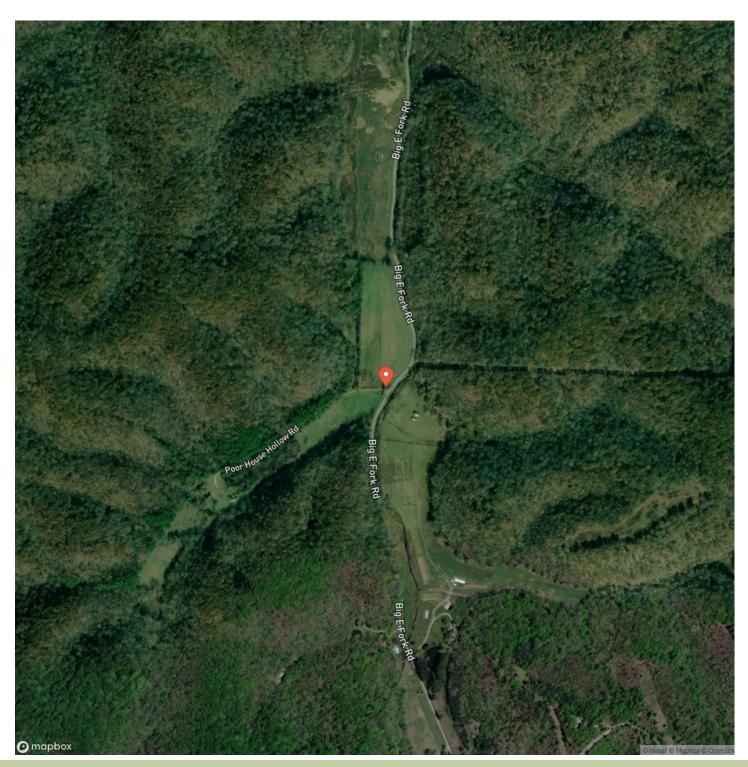
