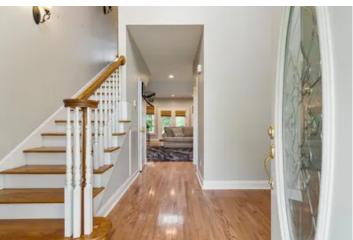

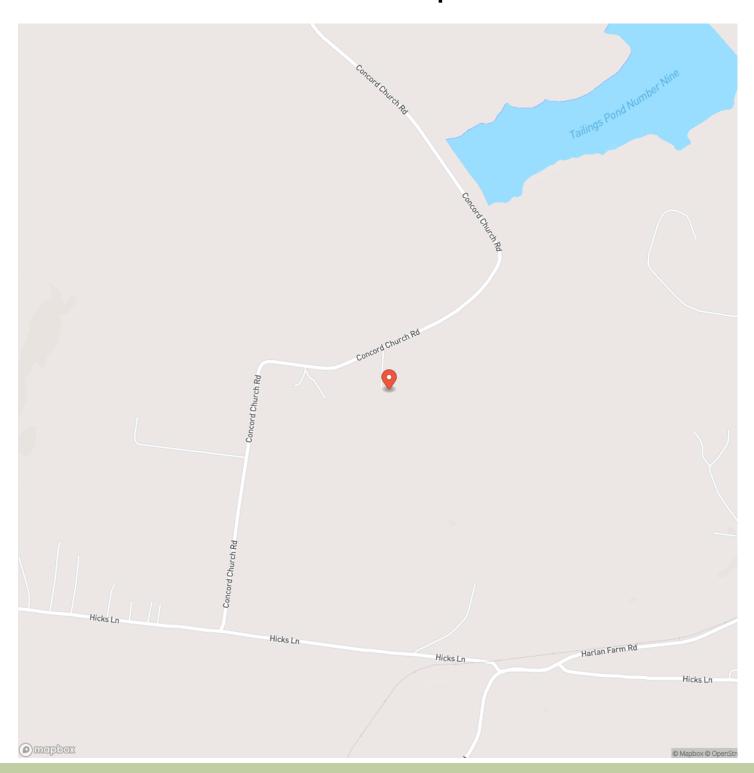






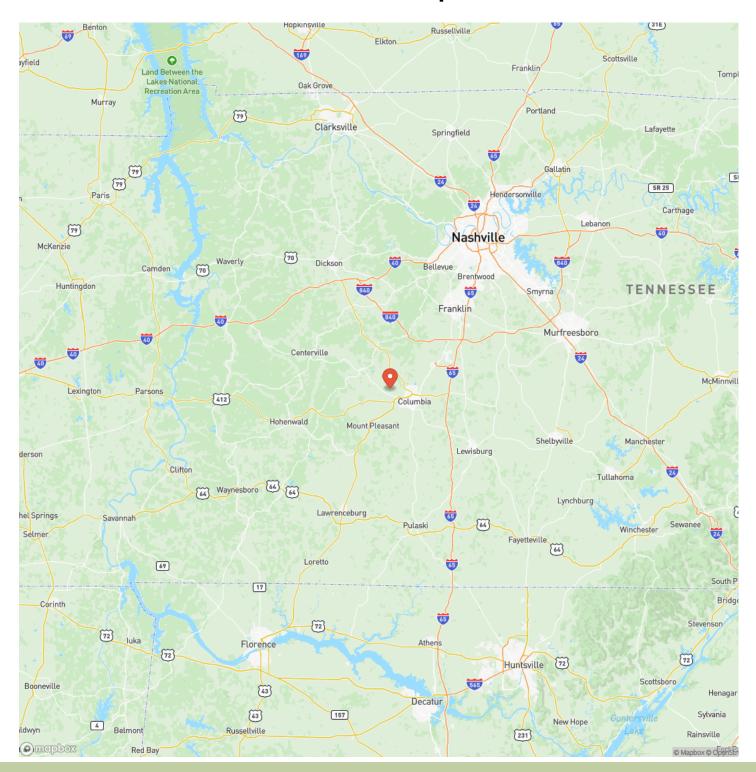


Locator Map



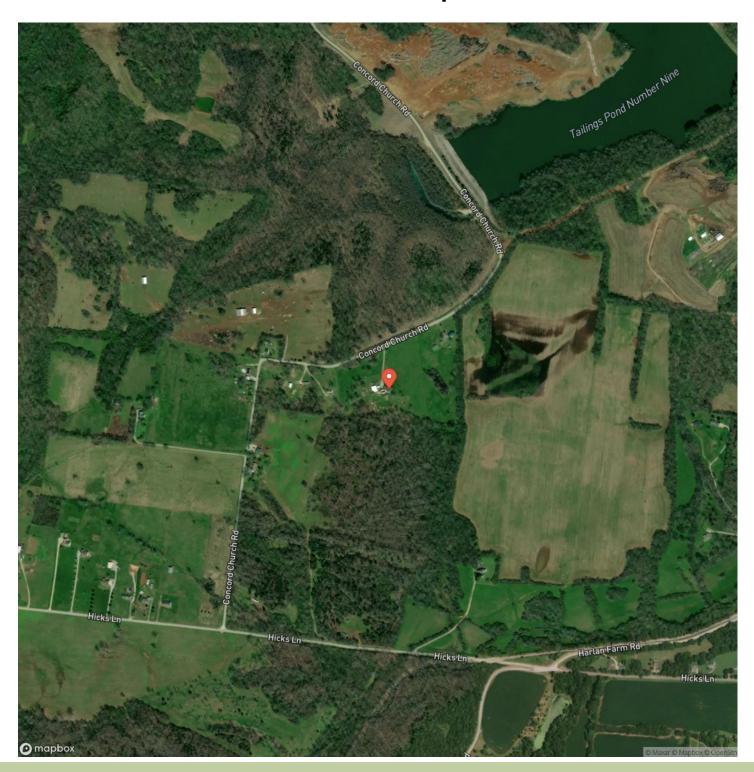
