PROPERTY DESCRIPTION

Located off River Bend Road in Marion County near Columbia, Mississippi, this approximately 113.5-acre tract offers an excellent opportunity for someone looking to develop a hunting and recreational property at a competitive price.

The property consists primarily of approximately 99 acres of recently clear-cut ground, along with roughly 12 acres of mixed hardwood timber. The recently harvested acreage provides a great starting point for a buyer who wants to shape a property around their own hunting and recreational goals.

The open and regenerating areas can provide valuable early-successional wildlife habitat, including natural browse and thicker cover as vegetation begins to return. With additional work, portions of the property could be opened and developed into larger food plots, shooting lanes, bedding areas, trail systems, and other wildlife habitat improvements. Rather than paying a premium for improvements designed by someone else, this property offers the opportunity to develop the land according to your own hunting strategy.

The remaining mixed hardwood areas add diversity to the tract and provide additional cover and habitat. The combination of hardwood timber, regenerating clear-cut acreage, and the ability to establish food plots could make this property especially attractive to deer and turkey hunters looking for a recreational project with plenty of room to work.

Another strong feature of the property is that it is located outside of the FEMA flood zone, while still being in close proximity to the Pearl River. This gives buyers the advantage of being near natural corridors while avoiding the limitations often associated with FEMA designated flood-zone property. The property also includes naturally low-lying areas that may offer additional recreational potential. With proper evaluation and development, these areas could provide opportunities for pond construction, fishing, duck hunting, or wildlife water sources adding another dimension to the property's hunting and outdoor appeal.

At 113.5 acres, there is ample space for multiple hunting locations, ATV riding, hiking, shooting, camping, and other outdoor recreational activities. The harvested acreage may also offer future options for timber reforestation or wildlife-focused land management depending on the new owner's objectives.

For buyers looking for less acreage, the property also offers the possibility of being divided into smaller tracts, including approximately a 55-acre tract and a 49-acre tract, providing additional options for hunters, recreational buyers, or those looking for a more manageable-sized property. Acreage and division are subject to final survey and seller approval.

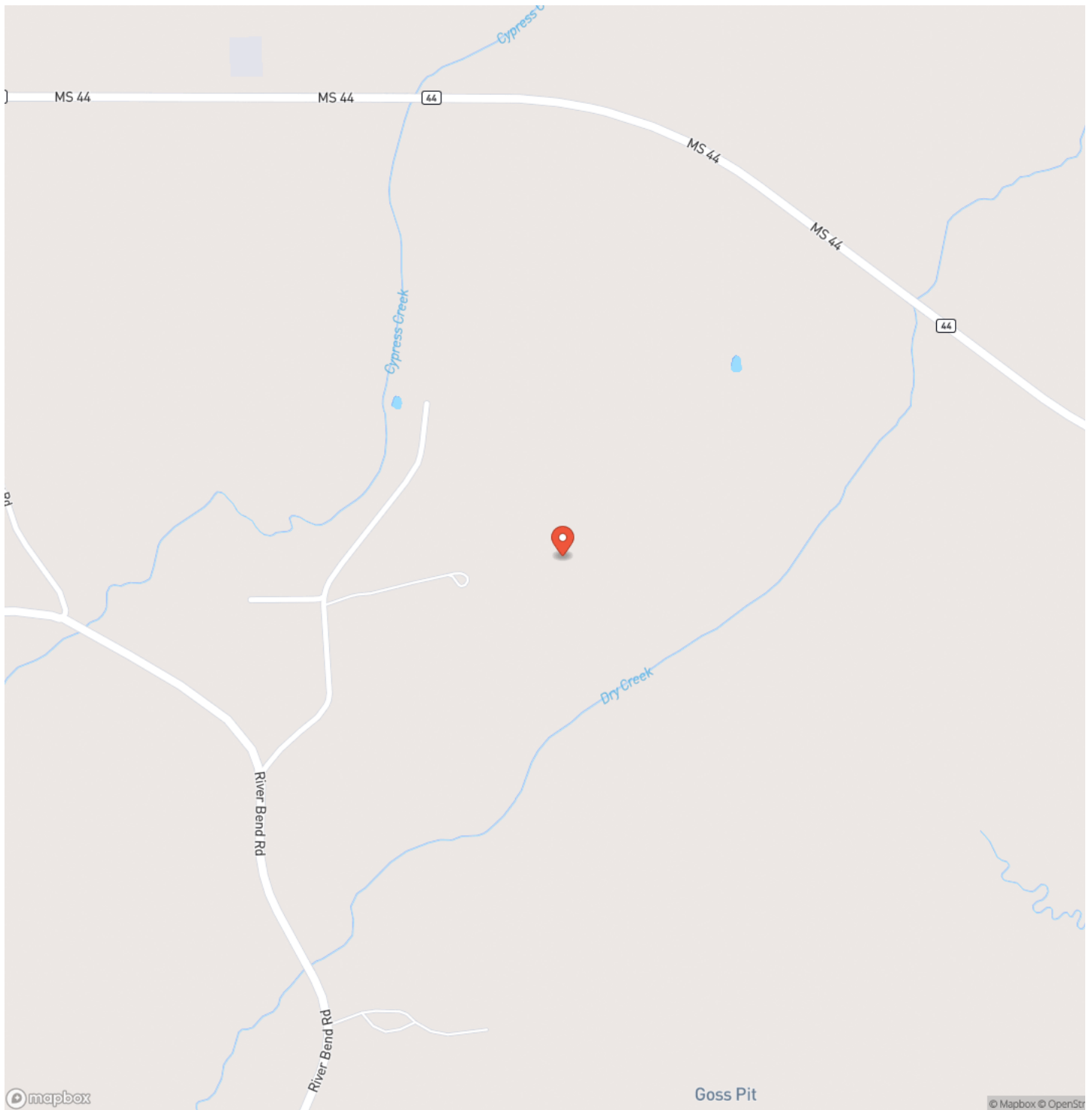

Access from Nedra Pittman Road with additional easement access provided from Hwy 44.

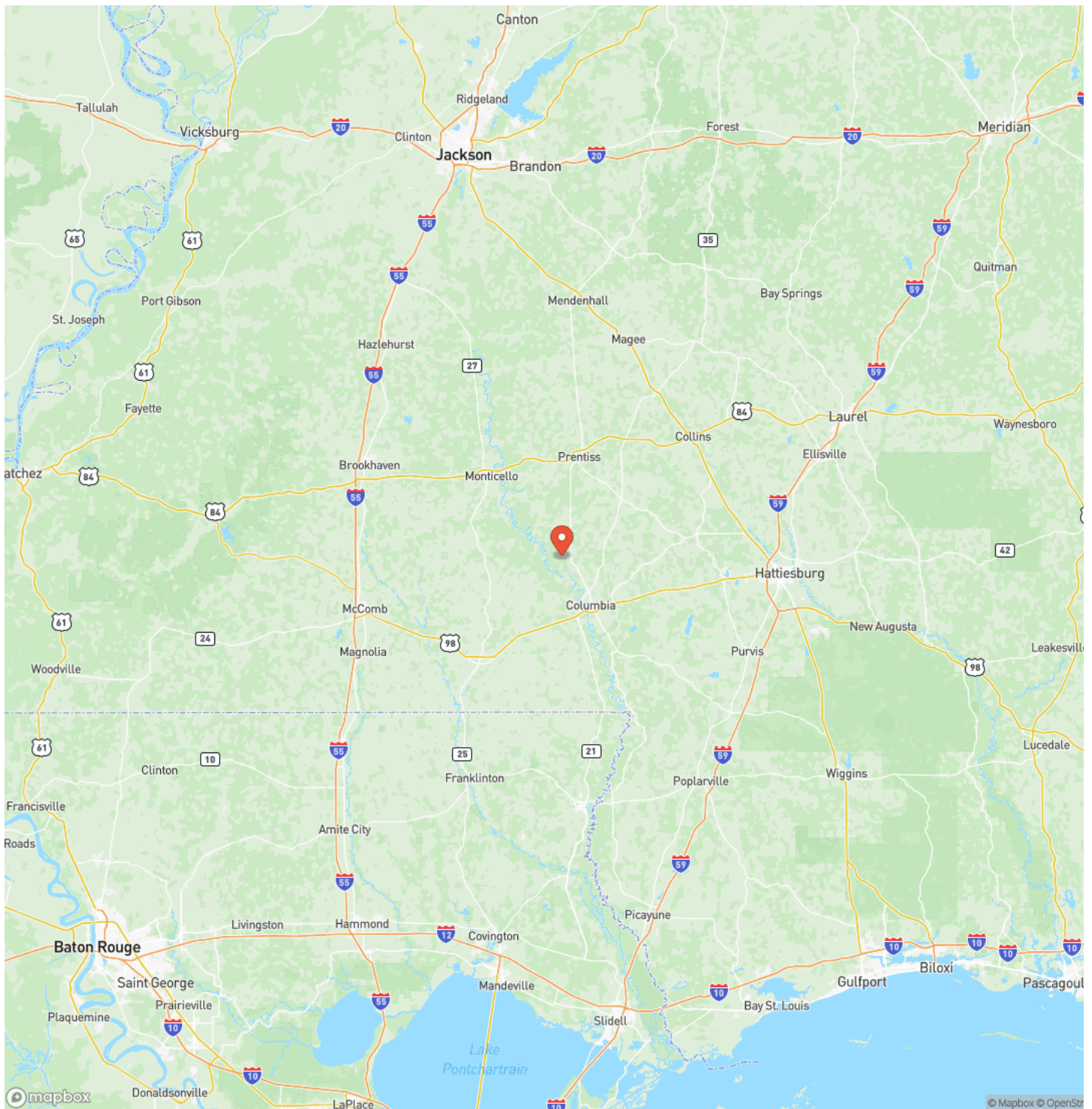

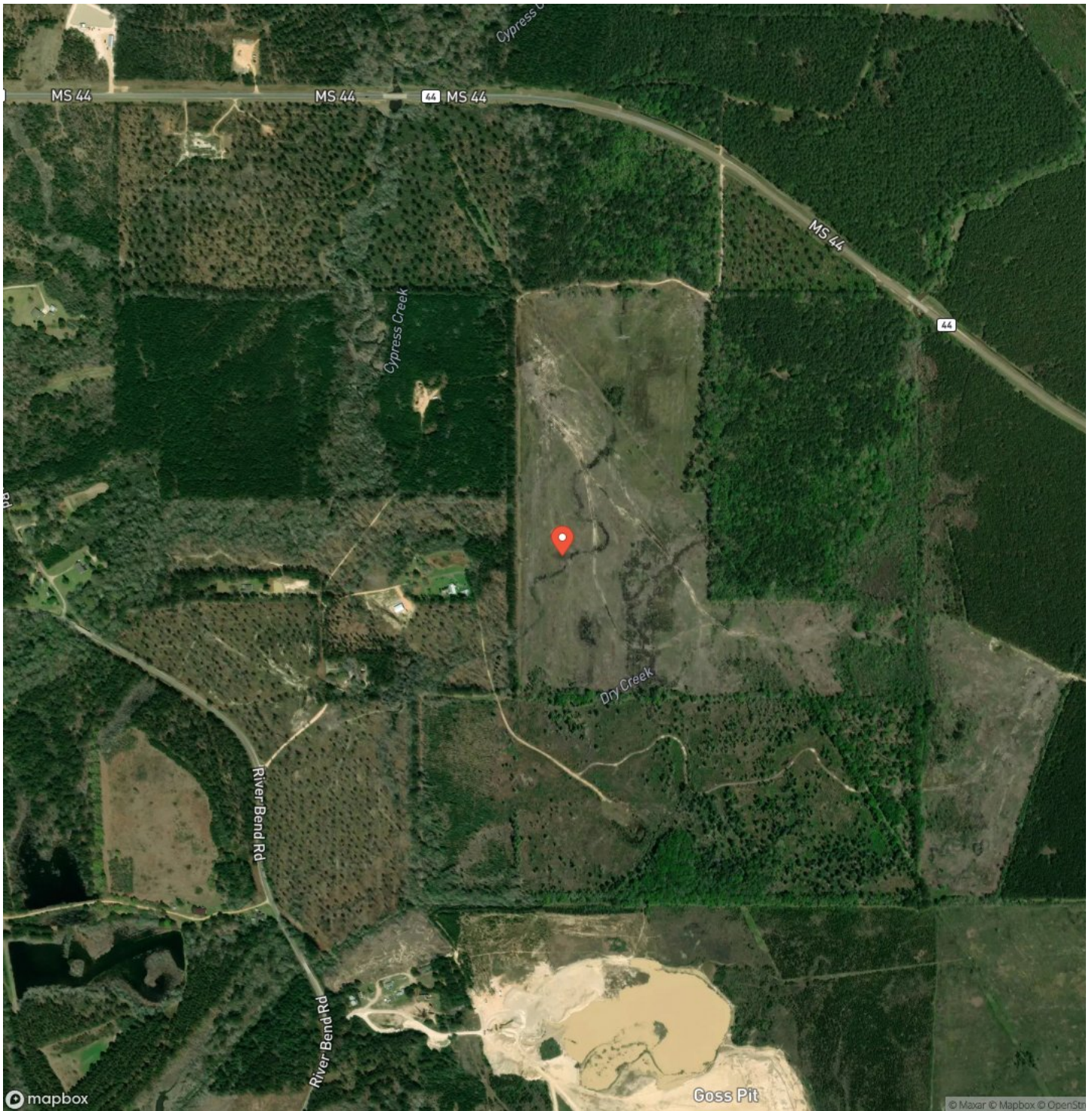
Locator Map
