The current owner has also planted additional pines to further enhance edge habitat in the coming years. Beyond deer, the property boasts a strong and well-established turkey population. The surrounding river bottom is known for its thundering gobbles at sunrise, providing an exhilarating experience for spring turkey hunts.















