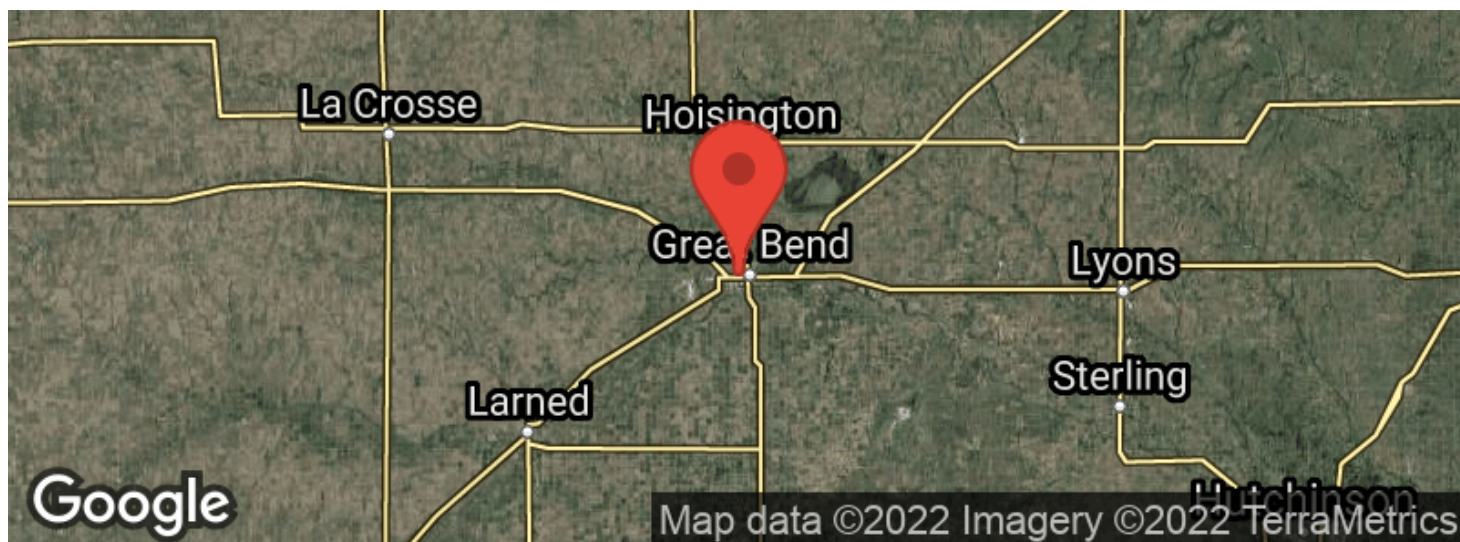


## Locator Maps
