140± Acres - 0.8± Acre Pond - Creek - Nearly 2 Miles of Trails - Timber - Recreation and Hunting - 48x24 Metal Building with 4 Roll-Up Bay Doors on a Concrete Slab in Arvonias, Buckingham County VA!

Located on 140± acres in Buckingham County, this property offers space, natural resources, and versatility to create a true legacy property for generations to come. With approximately 1,520 feet of gravel road frontage along Sunnyside Road, nearly two miles of established trails, and power available at the road, the property provides plenty of flexibility for recreation, hunting, timber and wildlife management, a future homesite, or simply enjoying the privacy and freedom that comes with owning a larger tract of land.

The trail system provides easy access throughout the property and opens the door to a wide range of recreational opportunities, from hiking and exploring the woods to ATV and UTV riding, hunting, wildlife watching, and simply enjoying the outdoors.

The rolling terrain is a mix of pine timber with approximately 13 years of growth and mature hardwoods, with hardwoods following the creek and creating natural corridors throughout the property. A creek and a 0.8+/- acre pond add to the property's natural beauty and recreational appeal, while providing additional wildlife habitat and places to relax, fish, explore, and enjoy the outdoors.

For the sportsman, the combination of timber, hardwoods, water, and varied terrain creates excellent wildlife habitat and opportunities for hunting and outdoor recreation, with several cleared openings suitable for food plots. For the landowner looking toward the future, the timber offers an additional investment component while the acreage provides plenty of room to explore a variety of uses.

The property also includes a 48' x 24' metal building with four roll-up bay doors on a concrete slab, along with a smaller shed, providing valuable storage and workspace for equipment, vehicles, tractors, recreational gear, or future property projects.

Whether your vision is a country home surrounded by acreage, a private hunting and recreational retreat, a place to raise a family, or a property you can eventually pass down to the next generation, this tract offers the room and natural features to make that vision possible.

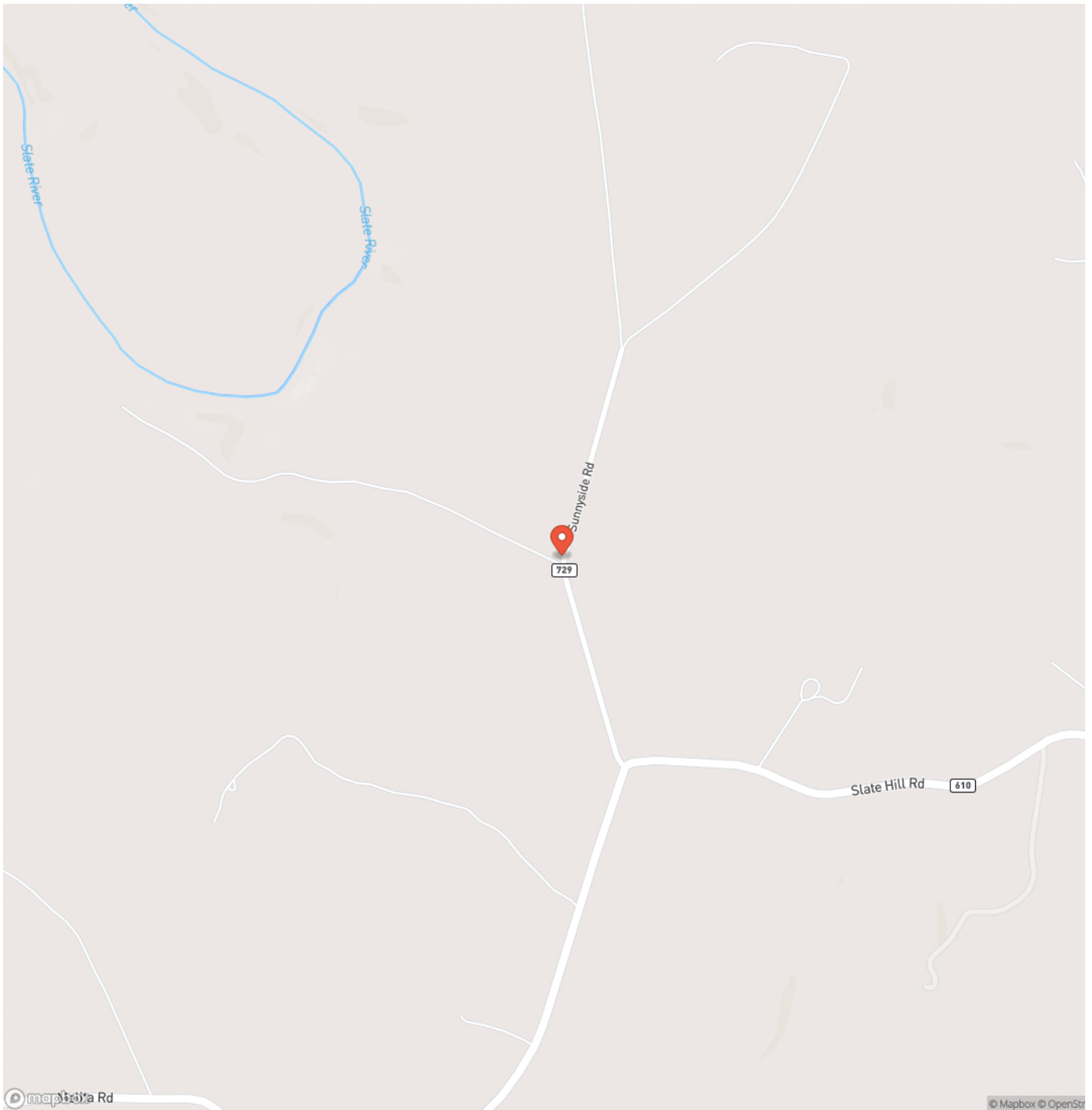

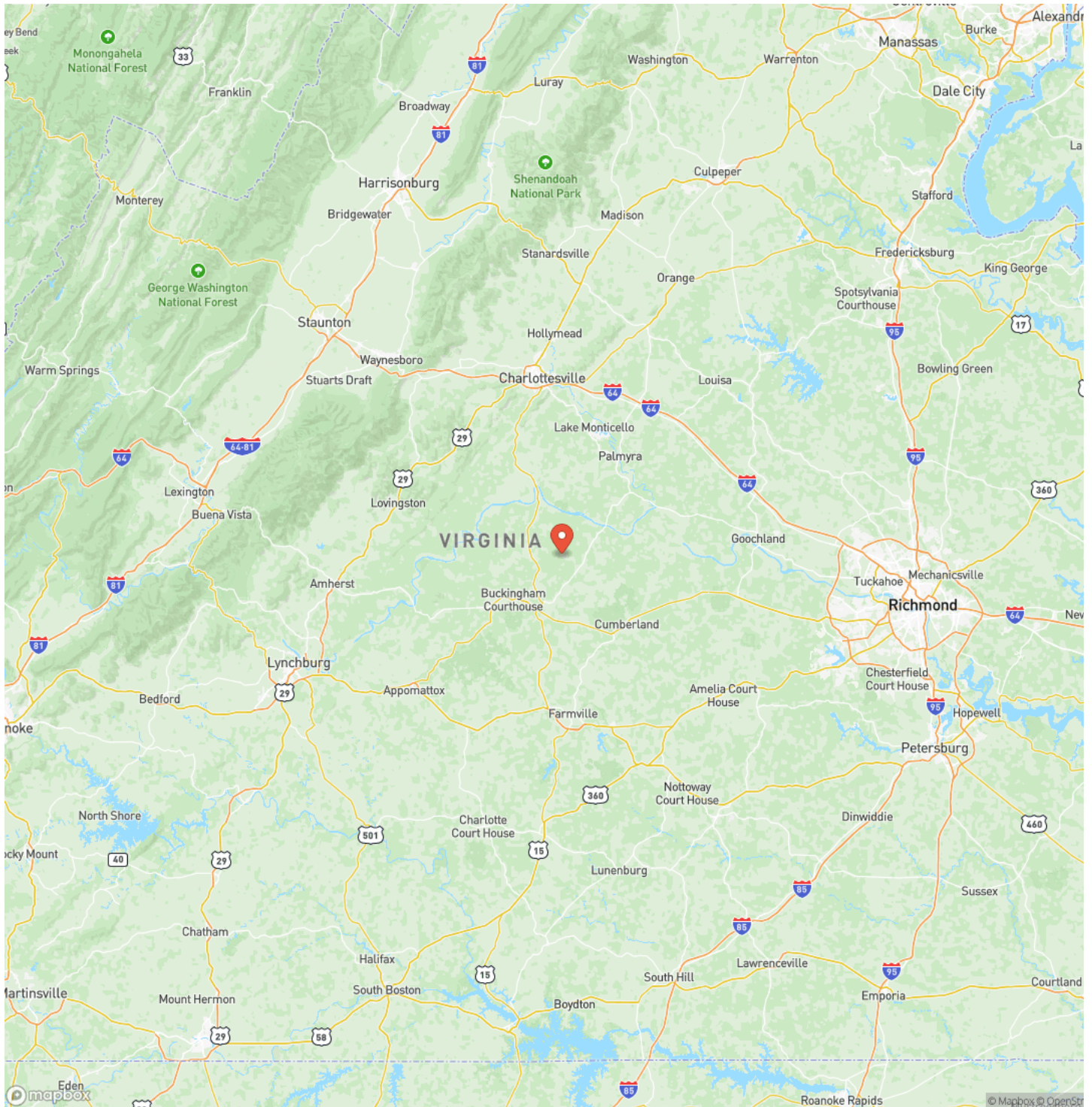


Locator Map



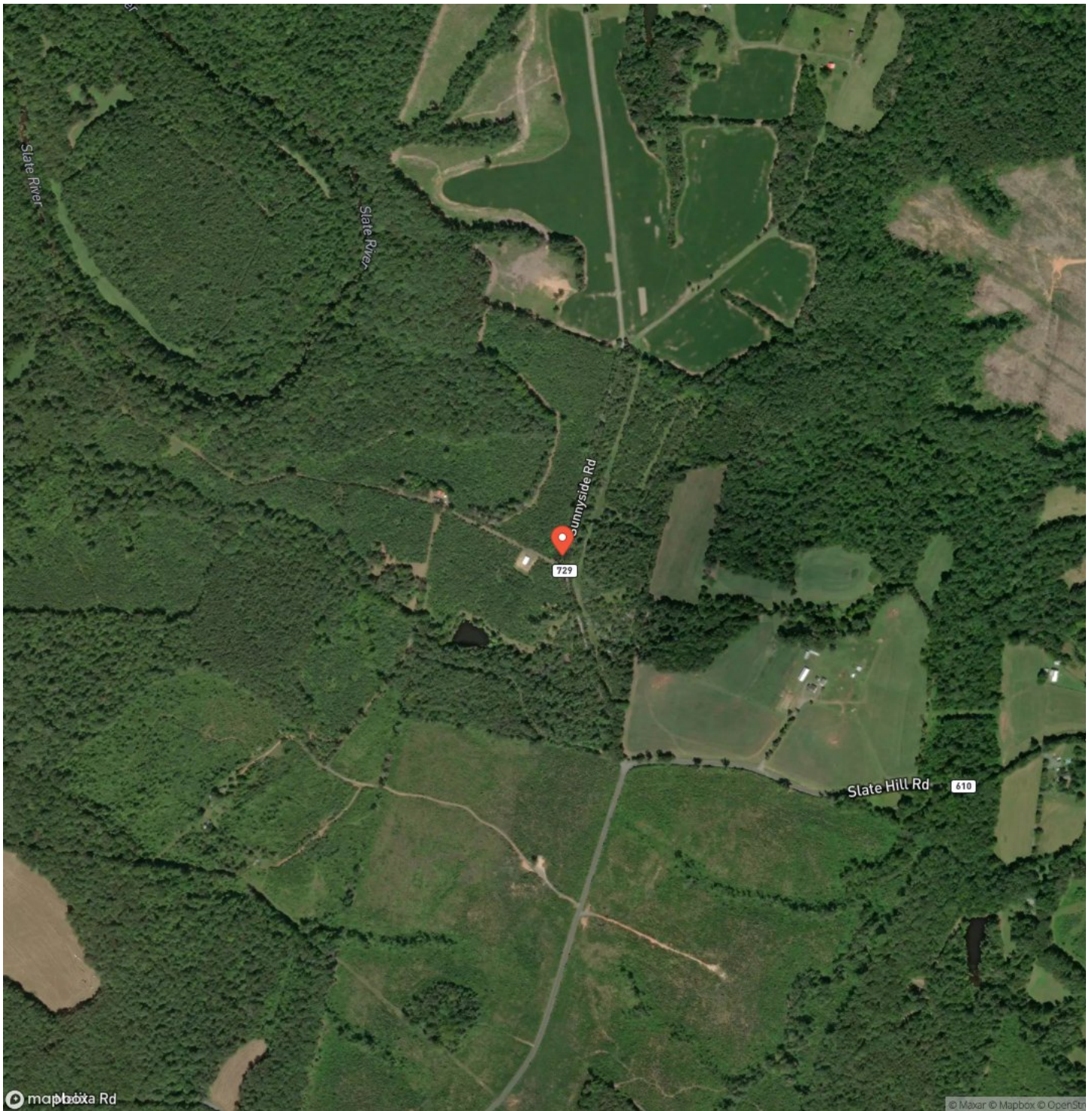
