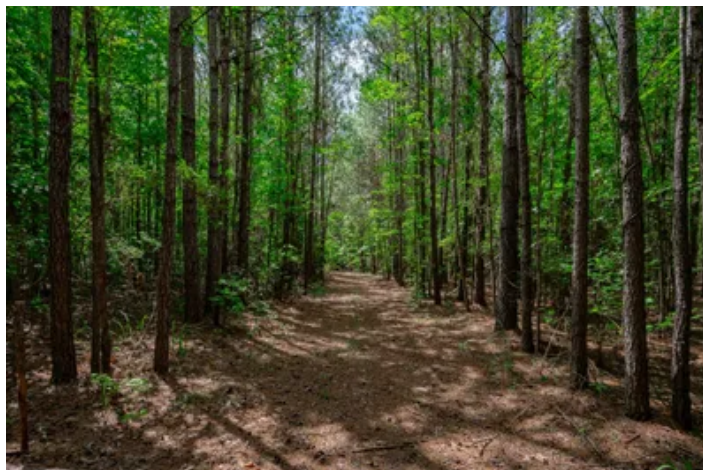

## **PROPERTY DESCRIPTION**

### **Quiet 38-Acre Estate with Two Homes, a Pool, & a Pond**

**Property Address:** 2117 & 2109 Togetherness Way, McBee, SC 29101

Whether you are looking for a family compound, private retreat, homestead, or recreational getaway, this property fits the mold for it all. Imagine sitting on the porch with a cup of coffee watching the ducks and geese take their morning flight. Here, you can enjoy the fresh air and zero noise pollution, while still having convenience to nearby towns. With two full houses, managed timberland, a private pool, a shared pond, and plenty of space, this is a rare find you don't want to miss!

### **Land and Outdoor Features**

The outdoor setup is built for fun, relaxation, and recreation. You can walk out the back door of the brick home to enjoy the shared two-acre pond, which offers excellent fishing and hunting opportunities right on the property. You can also step out the front door to swim in the in-ground pool, which comes with its own pool house.

The property includes transferable USDA contracts that add great value to the land. For storage and projects, there is a separate two-car garage, a large shed that works perfectly for a workshop or home business, a poolhouse and a large lean-to for extra equipment cover.

The acreage is packed with natural beauty and great amenities that make it feel like a private resort:

- **Managed Timberland:** About 31 acres of the property consist of beautiful, well-manicured, and carefully managed timber. The timber was last cut in 2008, making it an excellent established investment.
- **Expert Forest Care:** The woods have been safely prescribed burned (controlled fires used to clear out brush and keep the forest healthy) and feature cleared firebreaks throughout for safety and easy access.
- **Wood Duck Boxes:** This property has multiple wood duck boxes on site, allowing the local wood ducks to safely hatch their ducklings and avoid predators.
- **USDA Contract:** This farm currently holds active contracts with the USDA (United States Department of Agriculture). This contract provides benefits for the land and **can be transferred to the new owner!** (*Please reach out directly for more details*).
- **Inground Pool:** Cool off in your private pool, which comes complete with its own dedicated pool house.
- **Shared Pond:** Relax by the water, watch the local waterfowl, go fishing and enjoy the scenic views. This property sits on about 2 acres of the 7 acre pond.
- **Versatile Shed:** A large, multi-use shed that offers plenty of room for hobbies, storage, or a home business.

### **House #1: The Main Residence (2117 Togetherness Way)**

The primary residence is a beautifully kept modular home. It features four spacious bedrooms and three full bathrooms. Inside, you will find an open layout with a large kitchen island, a big living room, and a huge primary suite. The main bedroom includes two walk-in closets and a private bathroom with a double vanity. There is also a great room equipped with a theater system and surround sound. Outside, the large back deck has electricity, a built-in bar, and a gazebo. It is the perfect spot for grilling and entertaining guests while enjoying the quiet surroundings. This home also includes a separate two-car garage.

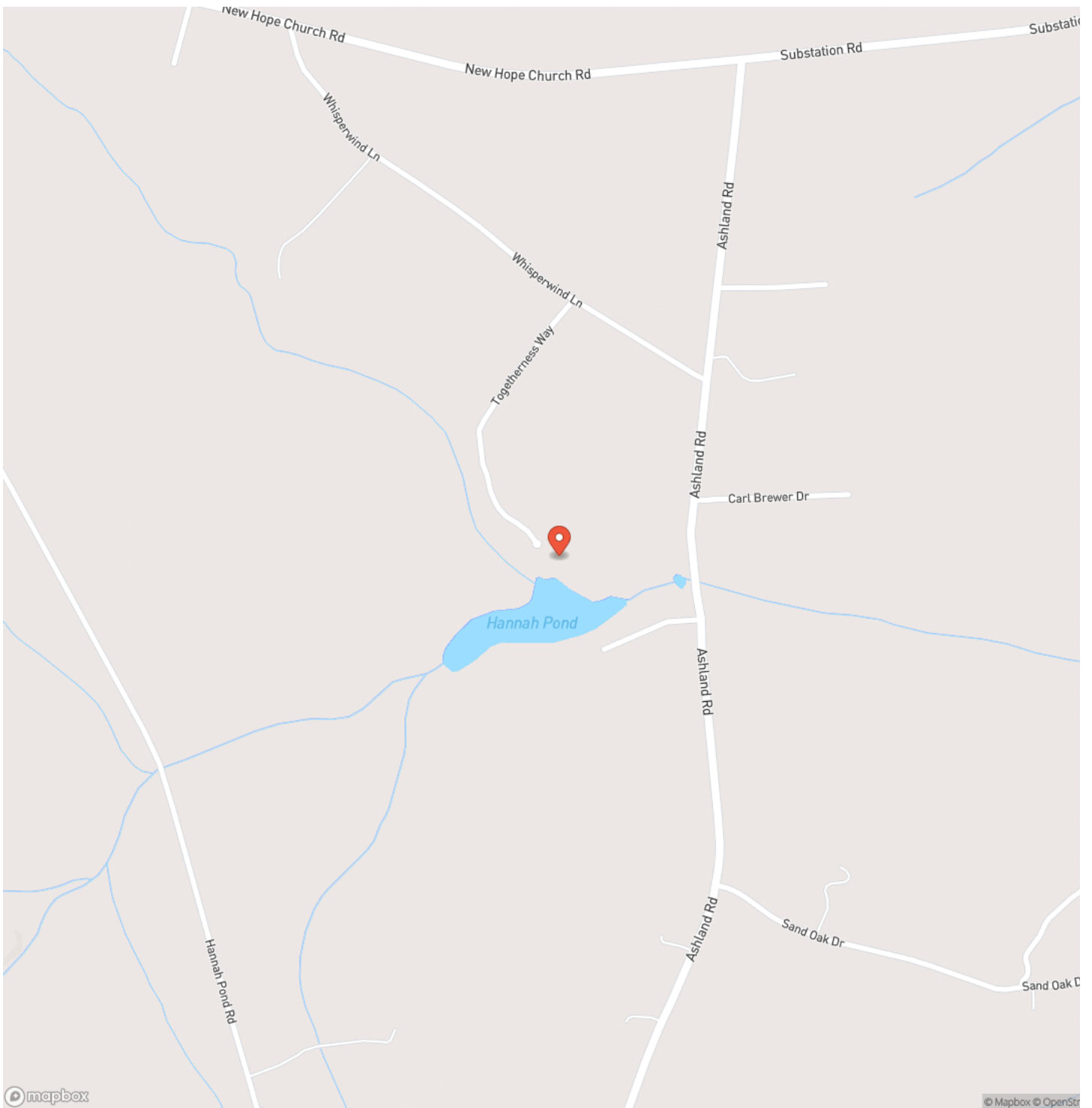

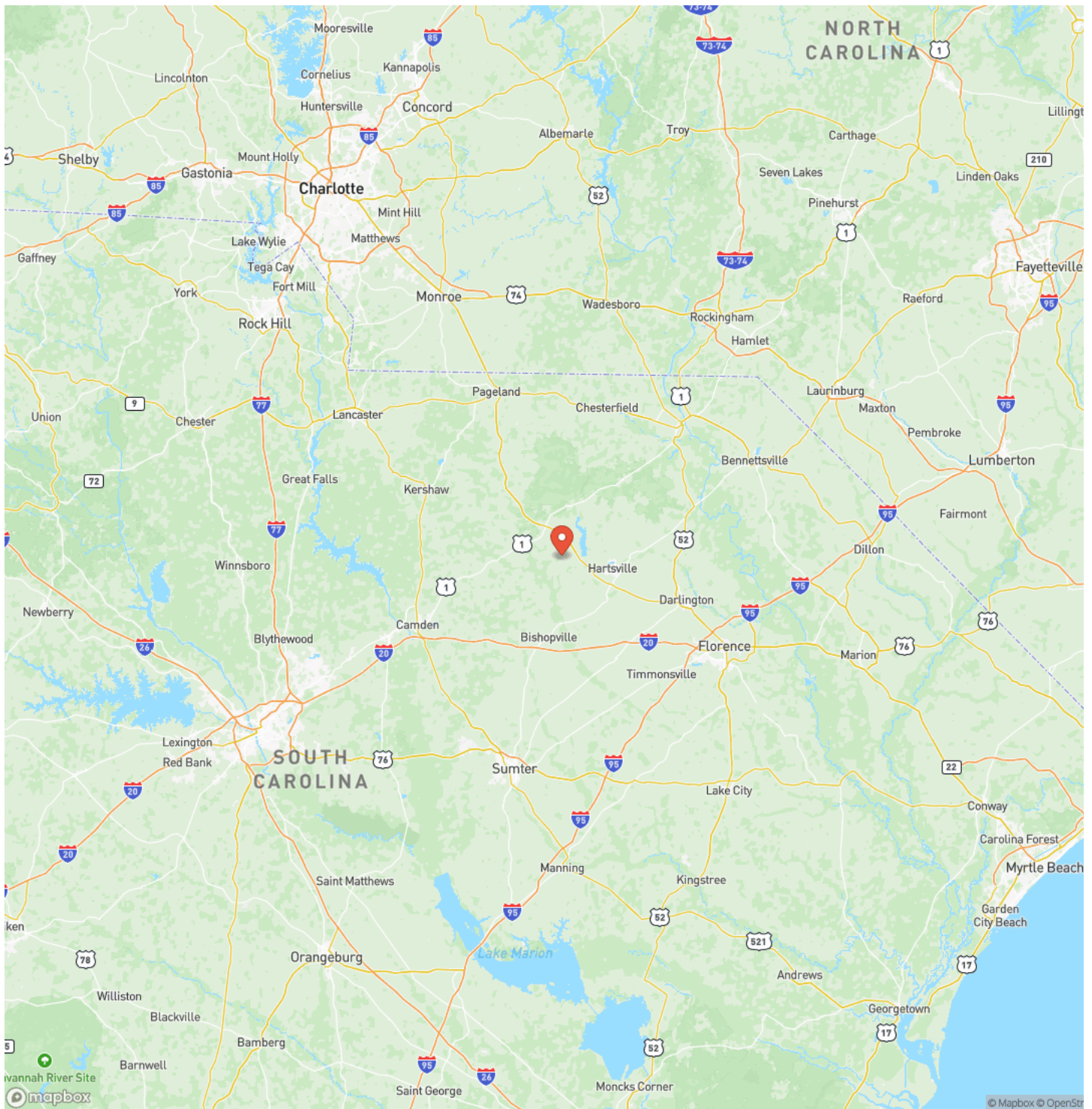
## Locator Map

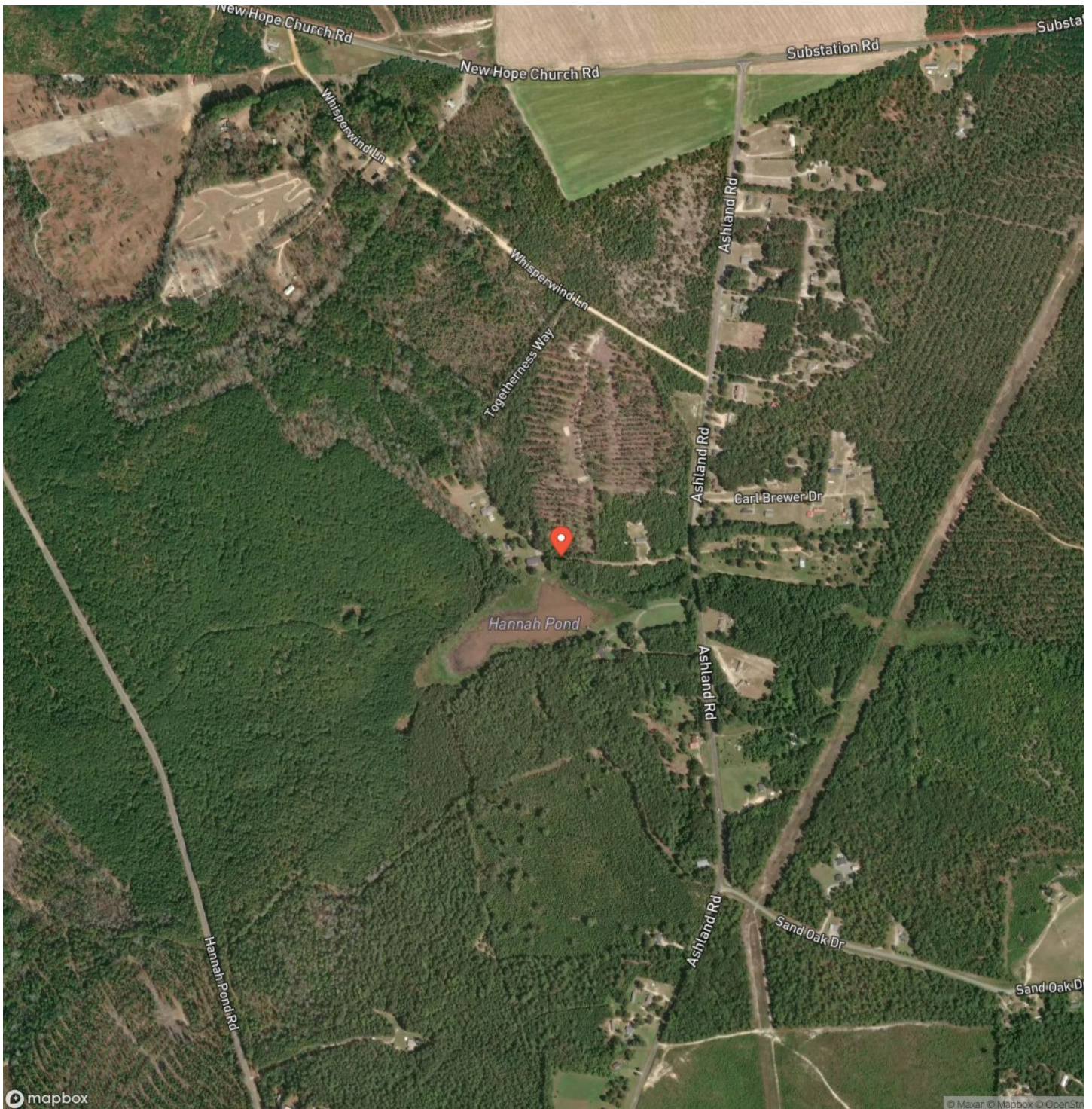
## Locator Map
