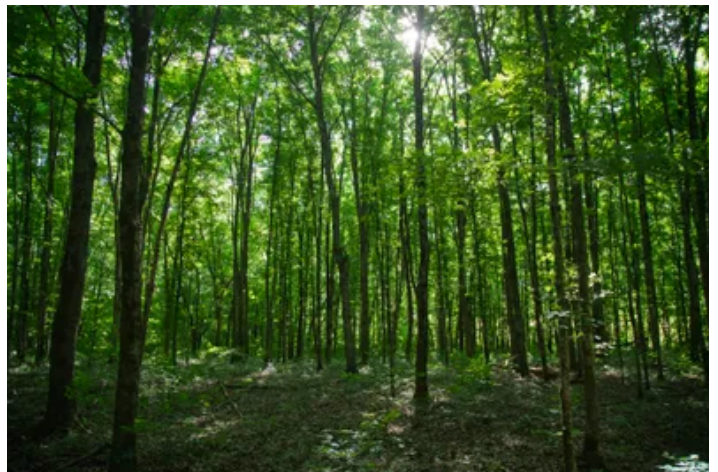

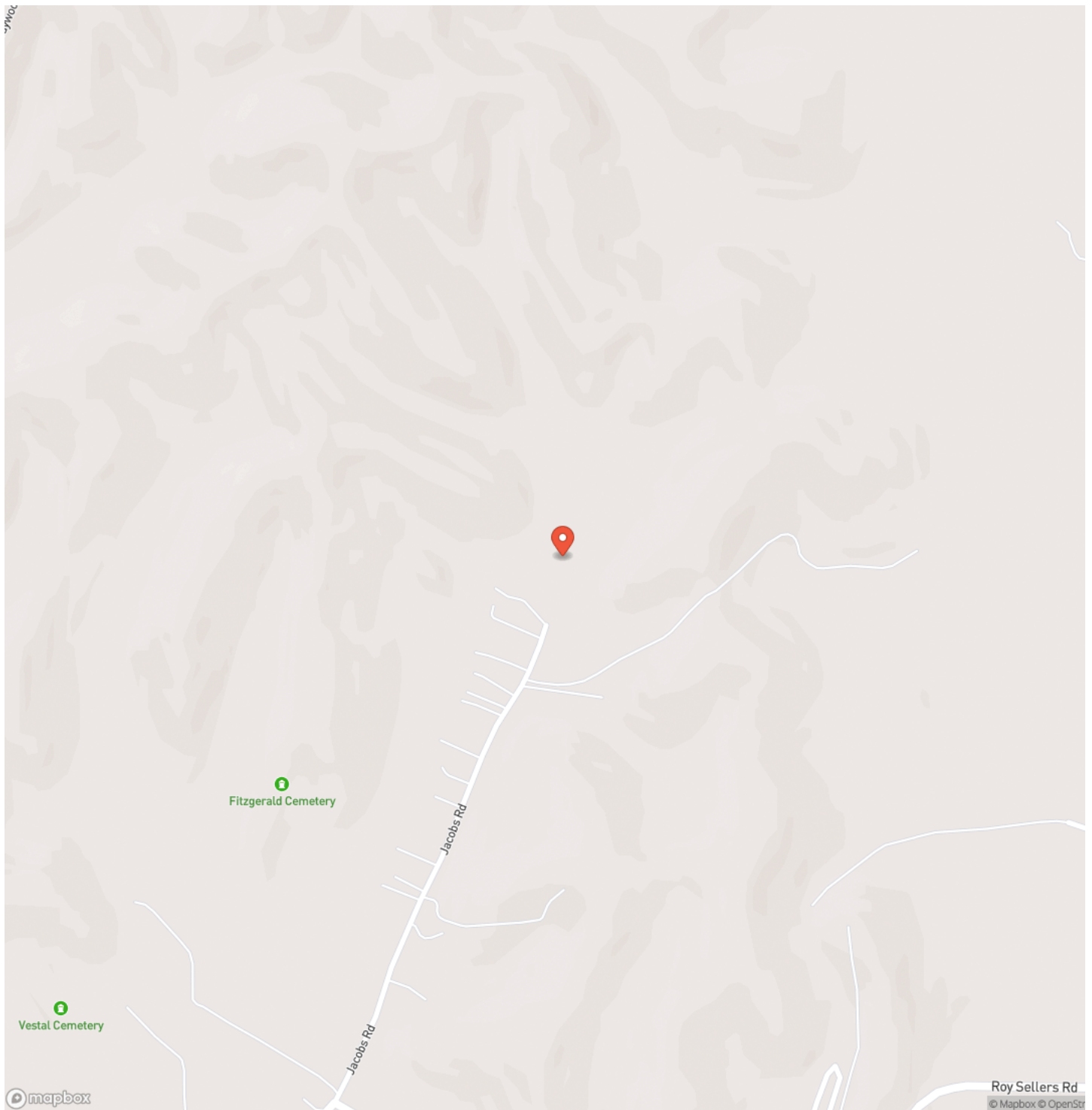
PROPERTY DESCRIPTION

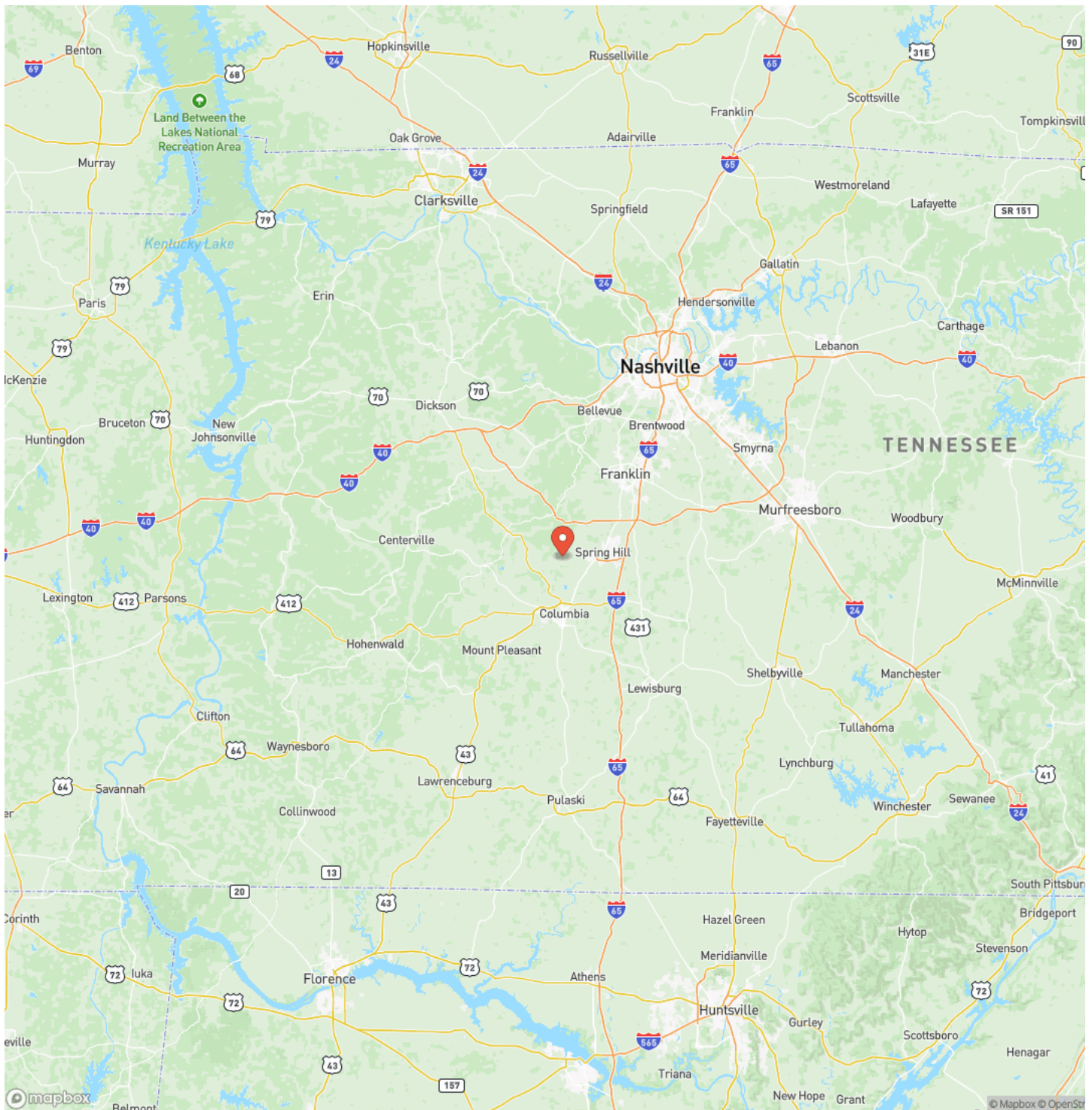
