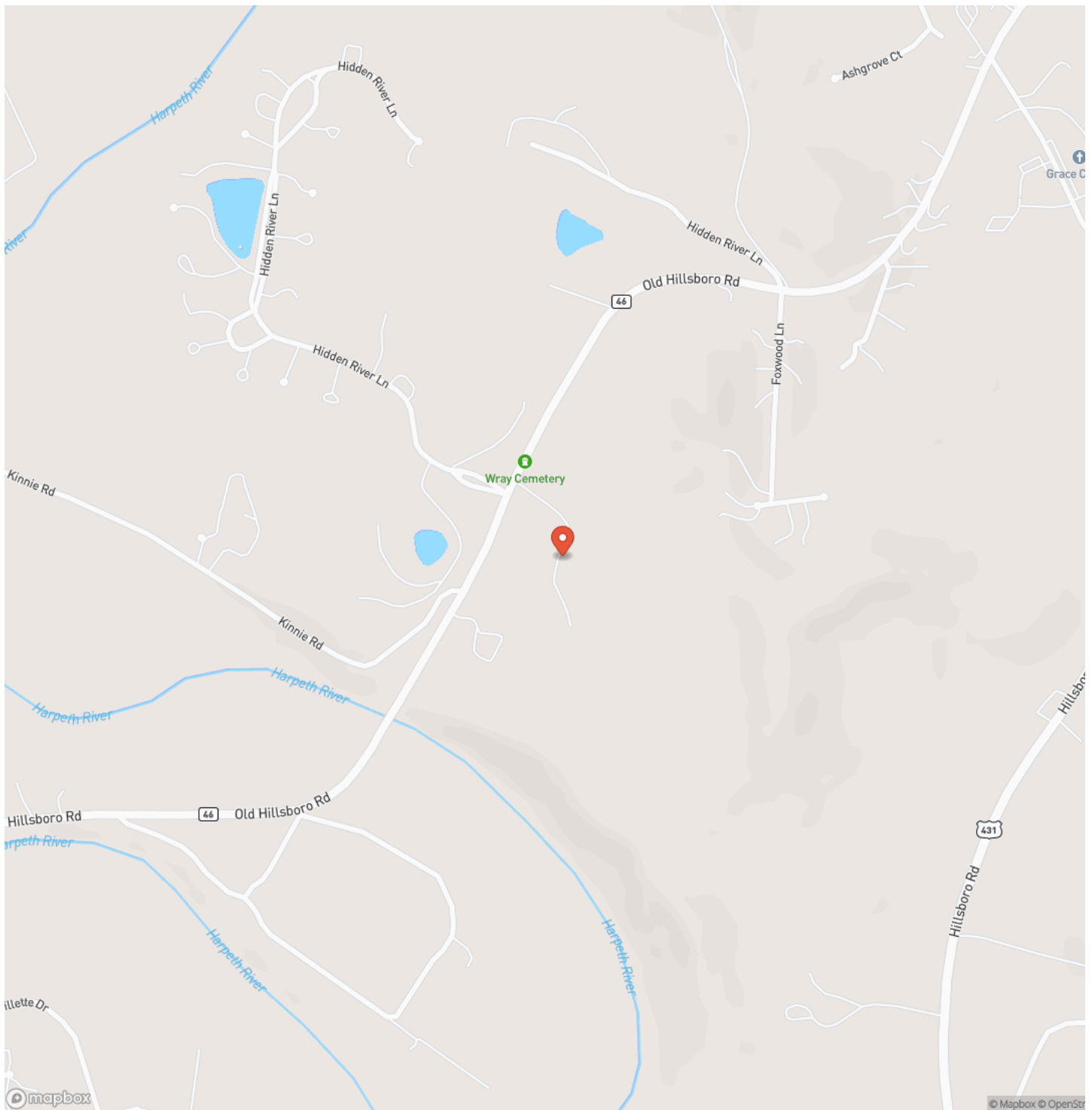

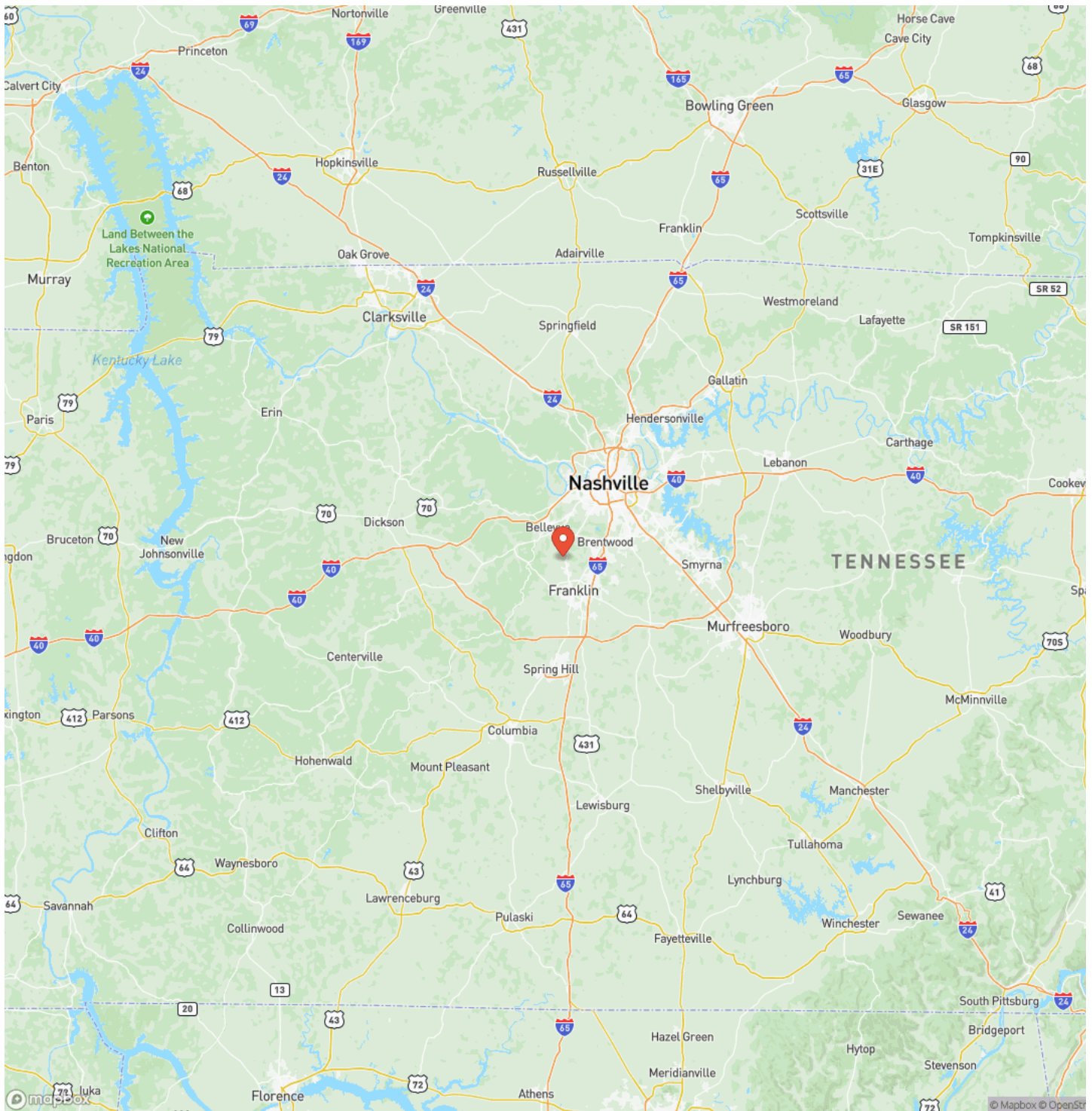

Locator Map



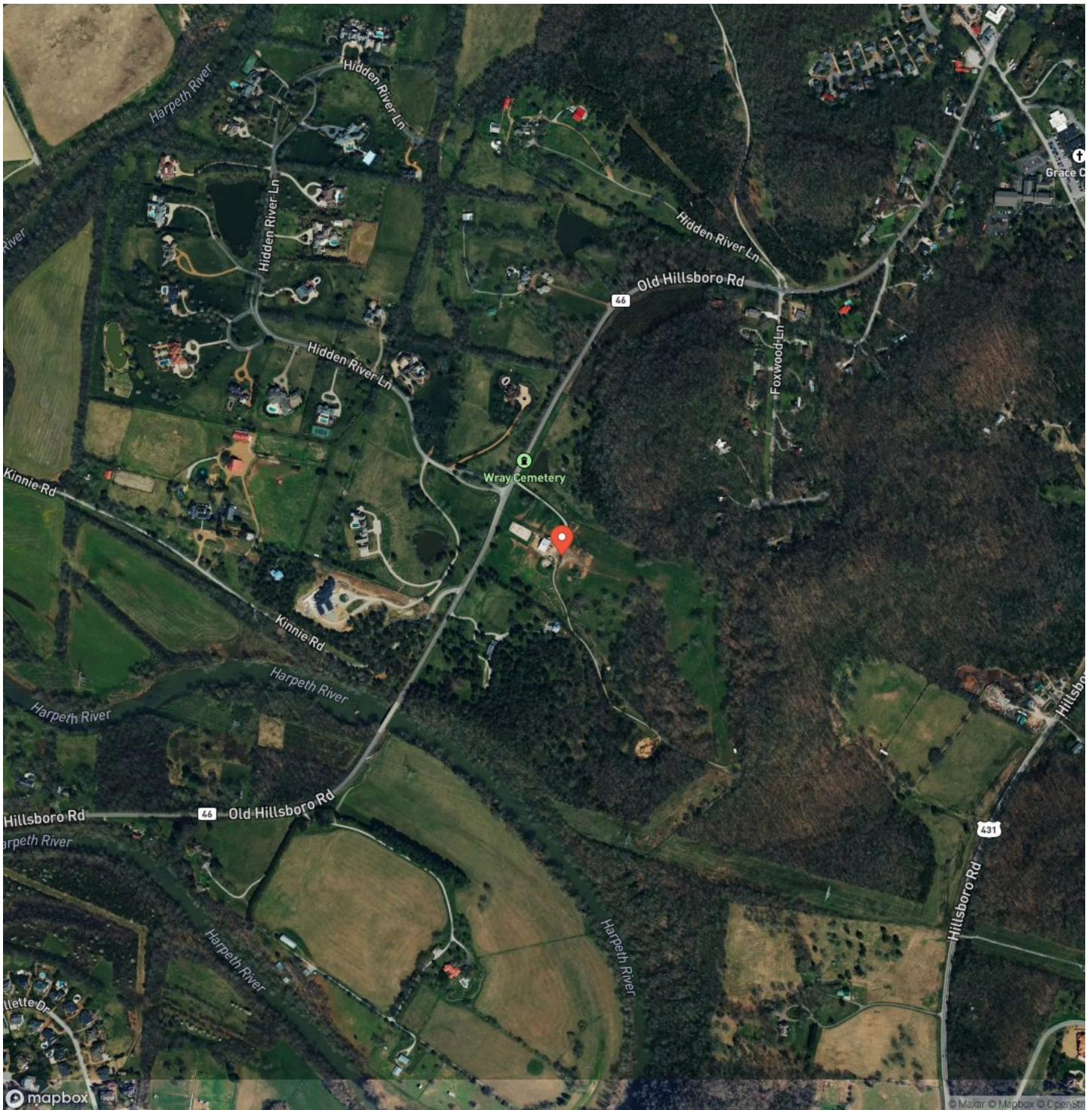
