#### **PROPERTY DESCRIPTION**

The Avalon Road Tract is a 130-acre property located in Lincoln County, Arkansas, just minutes from Star City. Currently used for timber production, this tract offers a versatile mix of hunting land, recreational land, residential potential, timberland, and undeveloped acreage. #### **Location**

The property supports healthy populations of whitetail deer, wild turkey, and feral hogs, making it an ideal destination for hunters throughout the year. The combination of thick pine timber and internal roads provides excellent habitat and movement corridors for wildlife, giving hunters multiple opportunities to set up stands or blinds across the acreage.

#### **Current and Potential Use**

Currently operating as timberland, the Avalon Road Tract is well-positioned to serve a broader range of purposes going forward. 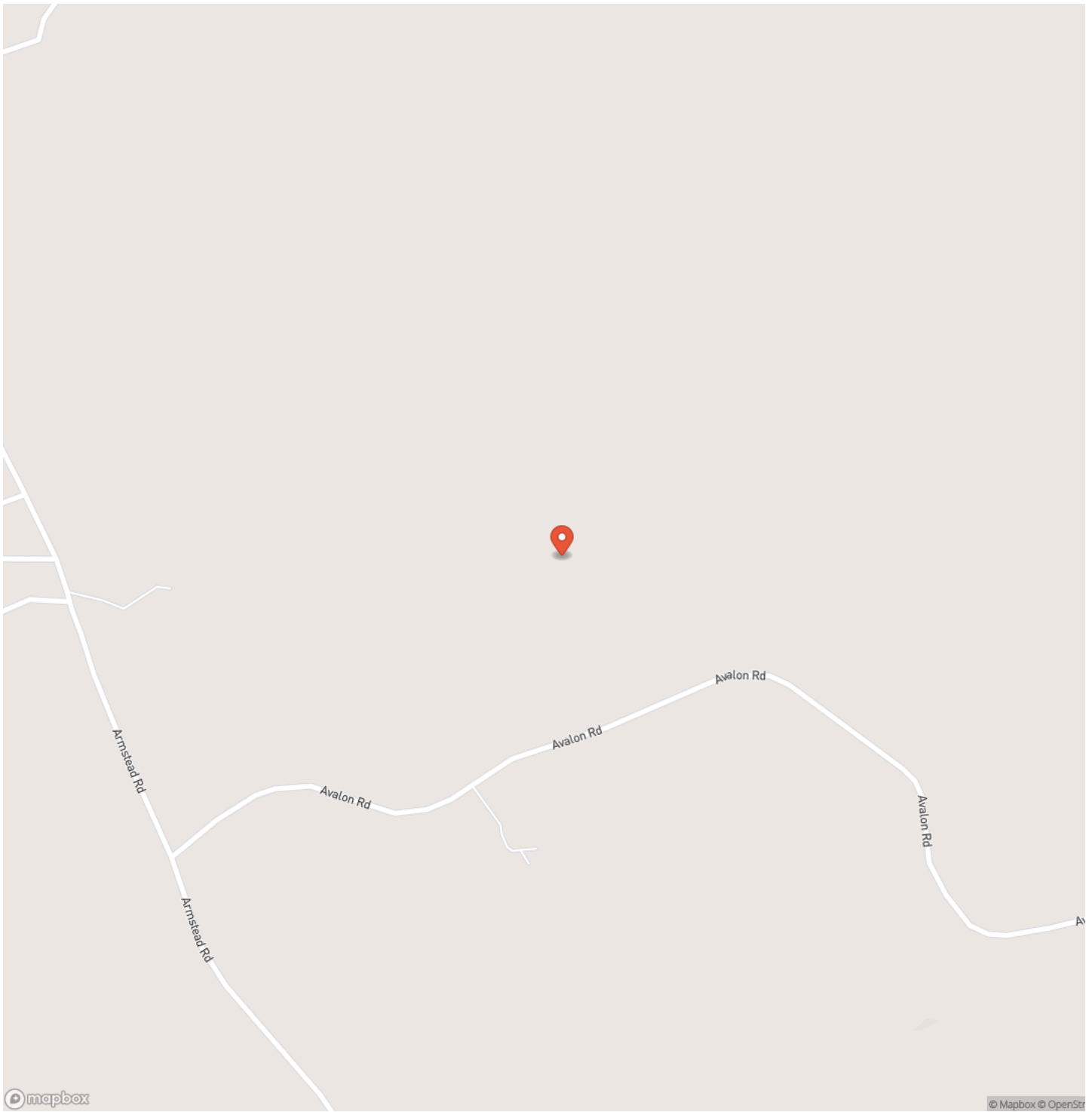

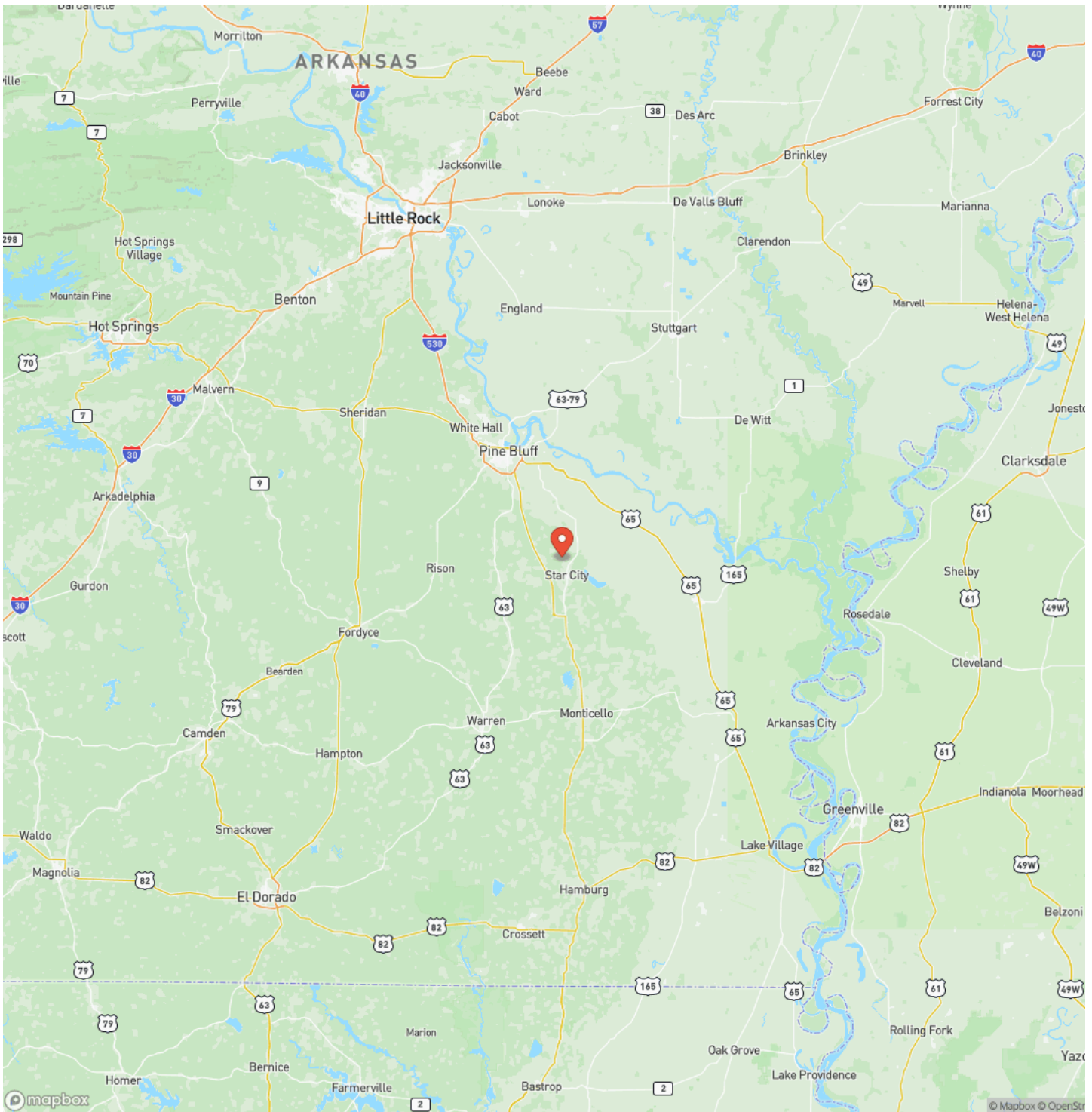
