BORDERS PUBLIC LAND - this exceptional +/-7.52 acre parcel off of Quaking Aspen Ct, Rexford, MT offers direct access to hundreds of thousands of acres of Kootenai National Forest and the Salish Mountains stretching all the way to Lake Koocanusa. Located in the rural subdivision of Tamarack Estates, this property features great road access via a well-maintained Forest Service road and recorded easement, and sits just 0.7 miles from blacktop.

The land is very buildable with a peaceful, private setting at approximately 3,720' elevation. Power borders the property, and reliable Verizon cell service is available. With livestock permitted at one animal per acre, this is an ideal location for a cabin, full-time residence, farmstead, or homestead. Enjoy immediate access to prime general deer and elk hunting, with over-the-counter bear tags available.

Just a short 15-minute drive brings you into the charming town of Eureka, Montana, where you'll find dining, groceries, and small-town amenities. Lake Koocanusa is also nearby, offering some of the best fishing in the region-especially for trophy rainbow trout and kokanee salmon.

Outdoor recreation here is unmatched, with endless opportunities for hiking, boating, snowmobiling, and exploring vast wilderness. The area is rich with wildlife, including elk, moose, deer, black bear, mountain lions, grouse, and wild turkeys, making it a dream setting for nature lovers and sportsmen alike.

For travel, Glacier Park International Airport in Kalispell is approximately 1 hour and 30 minutes away, providing convenient access while still preserving the property's quiet, remote feel.

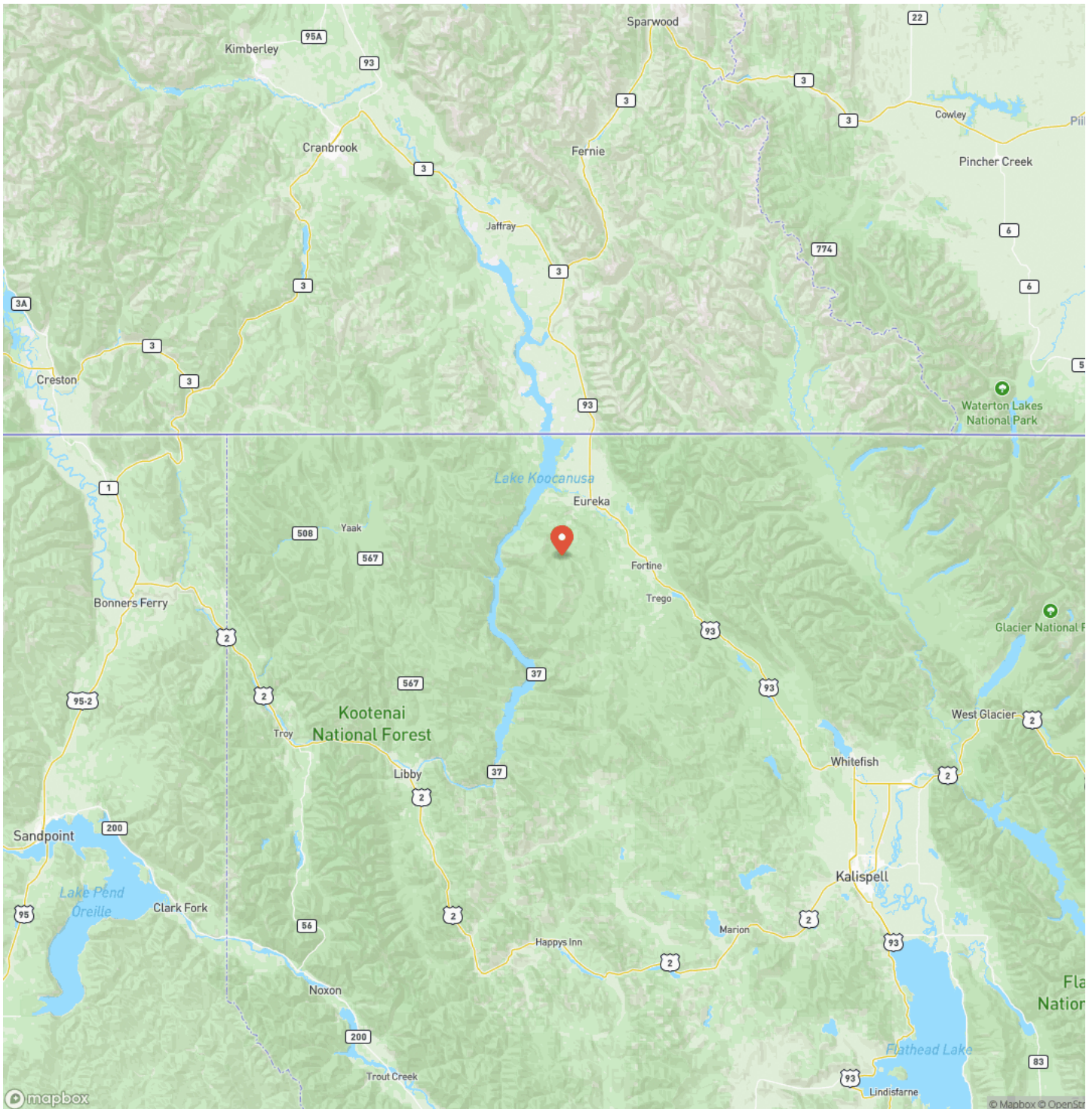
