BEGINNING at a ¾' pipe found in County Road 175 for the southwest corner of the Abner Woolsey Survey #444, the southwest corner of the tract described in Instrument #2021-08824 and being the southwest corner of this tract;

THENCE N 01°15'13" E with the west line of the survey and the county road a distance of 763.25' to a ½" iron pin set for the western most northwest corner of this tract and being the southwest corner of a 11.29 acre tract;

THENCE S 89°04'34" E a distance of 428.08' to a ½" iron pin set for the southeast corner of the 11.29 acre tract and being an interior corner of this tract;

THENCE N 01°15'13" E with the east line of the 11.29 acre tract a distance of 659.38' to a  $\frac{1}{2}$ " iron pin set for the southwest corner of a 14.15 acre tract and being the northern most northwest corner of this tract;

THENCE S 89°04'34" E a distance of 1329.79' to a ½" iron pin set for the southwest corner of a 15.92 acre tract and being the northeast corner of this tract;

THENCE S 01°32'02" W a distance of 1422.69' to a ½" iron pin set in the south line of the Woolsey Survey and the south line of the tract described in Instrument #2021-08824 for the southeast corner of this tract;

THENCE N 89°04'34" W with the south line of the survey and the south line of the tract described in Instrument #2021-08824 a distance of 1750.91' to the place of beginning and containing 50.82 acres of land. (See accompanying plat TA-134 L, bearings based on G.P.S. NAD 198 coordinates).
