


**PROPERTY DESCRIPTION**

Years ago, Lefever Road continued north and connected to Old Jackson Chapel Road near where the Pinhoti Trail now crosses it. When I drive down Lefever Road, I feel like I'm entering a cove in an 1800's farming community. The area is so quiet, I only hear the birds singing. There is a spring-fed pond in the middle of the acreage. I understand there are several springs on the acreage. While walking the property, I noticed several ridges with nice views of the valley.




