Field notes of a 0.603 of an acre tract of land situated in Blanco County, Texas out of the west ½ of Subdivision 15 of the F. C. Gray Survey No. 20, being a part of that 5.364 acre tract conveyed to Howard Ray Koch and Beverly Elaine Porter-Koch and recorded in Volume 0281, Page 285 of the Official Public Records of Blanco County, Texas and being more particularly described by metes and bounds as follows: Note: All iron pins are ½" rebar with yellow plastic cap stamped "Baker Surveying".

Beginning at an iron pin set in the west line of the Koch Tracts recorded in Volume 65, Page 31 of the Official Public Records of Blanco County, Texas and being at the intersection of the east line of U. S. 281 and the east line of Old Highway 66 for the south corner of this tract and the 5.364 acre tract.

Thence N 16° 33' 58" E. 658.08 feet with the west line of this tract and the 5.364 acre tract, across Old Highway 66, to an iron pin set in the west line of Old Highway 68 for the northwest corner of this tract.

Thence S 69° 18' 51" E. 76.49 feet across old Highway 66 and the 5.364 acre tract to an iron pin with Sultemier Surveying plastic cap found in the west line of the Koch Tracts, and the east line of Old Highway 66 and the 5.364 acre tract for the northeast comer of this tract.


Thence in a southerly direction with the east line of this tract, the 5.364 acre and Old Highway 66 and the west line of the Koch Tracts as follows:

S 20° 41' 09" W. 85.80 to an iron pin found at the beginning of a curve to the right. Southerly with the arc of said curve to the right having a radius of 2914.90 feet and a central angle of 05° 06' 58", a distance of 260.28 feet to an iron pin set at the end of said curve. Chord Bears: S 23° 14' 04" W. 260.18 feet.

S 25° 47' 36" W. 176.40 feet to an iron pin found at the beginning of a curve to the left. Southerly with the arc of said curve to the left having a radius of 904.61 feet and a central angle of 08° 30' 54", a distance of 134.56 feet to the end of said curve, Chord bears: S 21° 31' 17"W. 134.43 feet to the place of beginning and containing 0.603 of an acre of land according to a survey on the ground in October of 2003 by Baker Surveying.

A DESCRIPTION OF A 72.36 ACRE TRACT OF LAND OUT OF THE F. C. OF THE DEED RECORDS OF SAID COUNTY; SAID 72.36 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING at a 3/8 inch diameter iron rod set on the east R.O.W. (Right-of-way) line of old Highway No. 68 at the southwest corner of the said 144.8 acre tract, being at the northwest corner of that certain 180.2 acre (Deed/called acreage) tract described in Volume 106, Page 490 et seq. of the said Deed Records, for the southwest corner hereof:

THENCE with the said east R.O.W. line of old Highway No. 66 and west line of the said 144.8 acre tract, the following seven (7) courses:

- N 11° 18' 43° E, a distance of 388.60 feet to a concrete R.O.W. monument found at the beginning of a curve to the left,
- A distance of 255.46 feet along the arc of said curve having a central angle of 14° 33' 29", a
 radius of 1005.40 feet and a chord bearing of N 04° 09' 05" E, a distance of 254.77 feet to a
 concrete R.O.W. monument found at the end of said curve,
- N 03° 17' 10" W, a distance of 301.66 feet to a 3/8 Inch diameter iron rod set at the beginning
 of a curve to the right.
- 4. A distance of 456.11 feet along the arc of said curve having a central angle of 28° 51' 49°. a radius of 905.40 feet and a chord bearing of N 11° 06' 37° W, a distance of 451.30 feet to a ½ inch iron rod found at the end of said curve.
- N 25° 45' 23° E. a distance of 176.43 feet to a ½ inch iron rod found at the beginning of a curve to the left.
- 6. A distance of 260.69 feet along the arc of said curve to the left having a central angle of 05° 07° 27°, a radius of 2914.90 feet and a chord bearing of N 23° 16′ 50° E, a distance of 260.60 feet to a 3/8 inch diameter iron rod set at the end of said curve, and
- N 20° 38' 13" E, a distance of 85.80 feet to a 3/8 inch iron rod set for the westerly southwest corner of a 72.16 acre Tract "A" this day surveyed and the northwest corner hereof;
