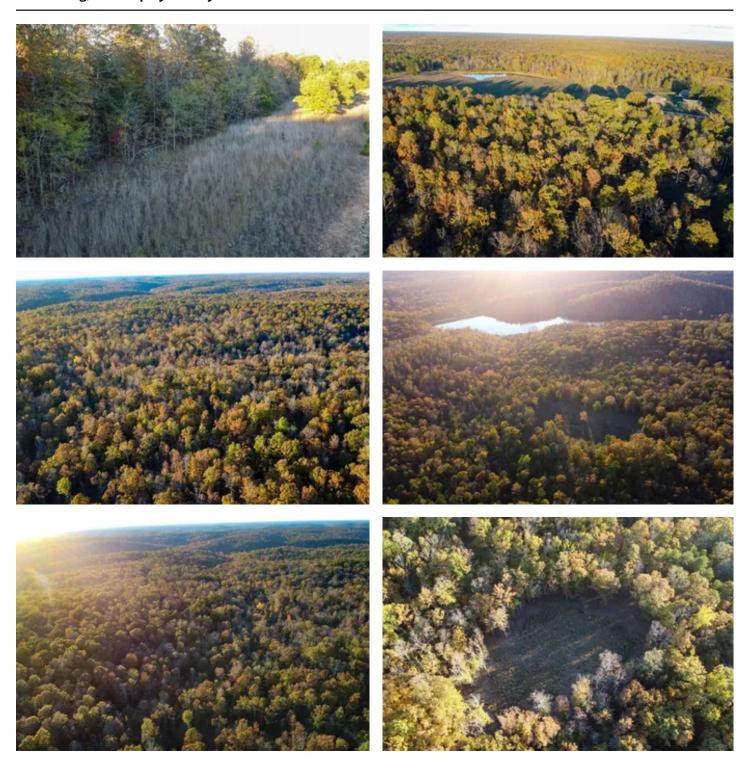

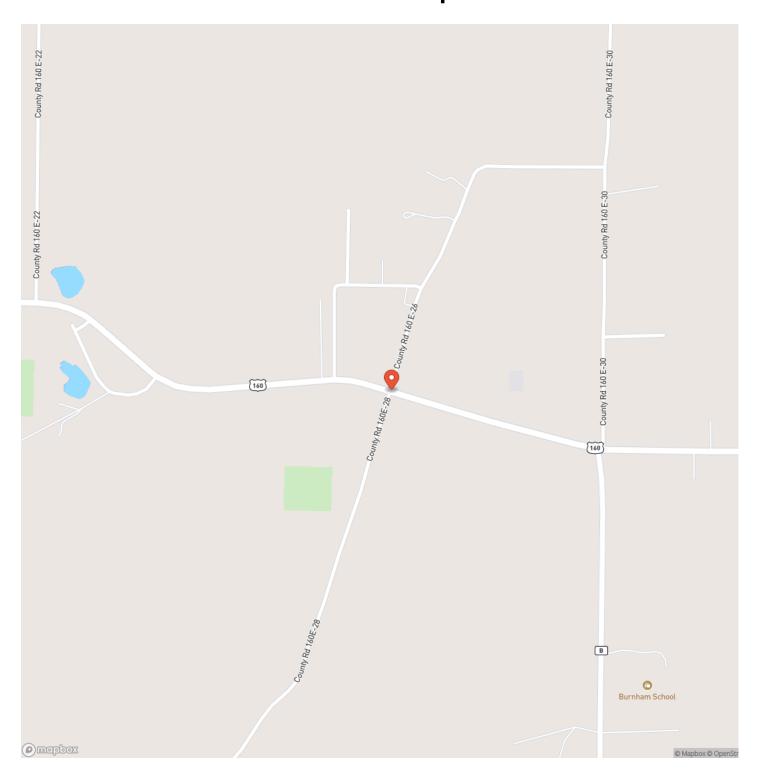

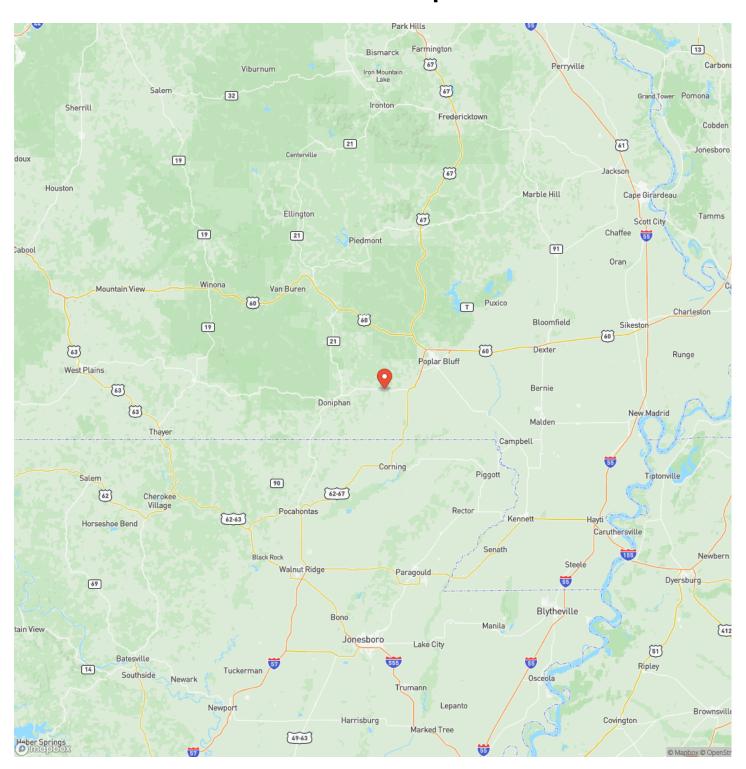


Locator Map



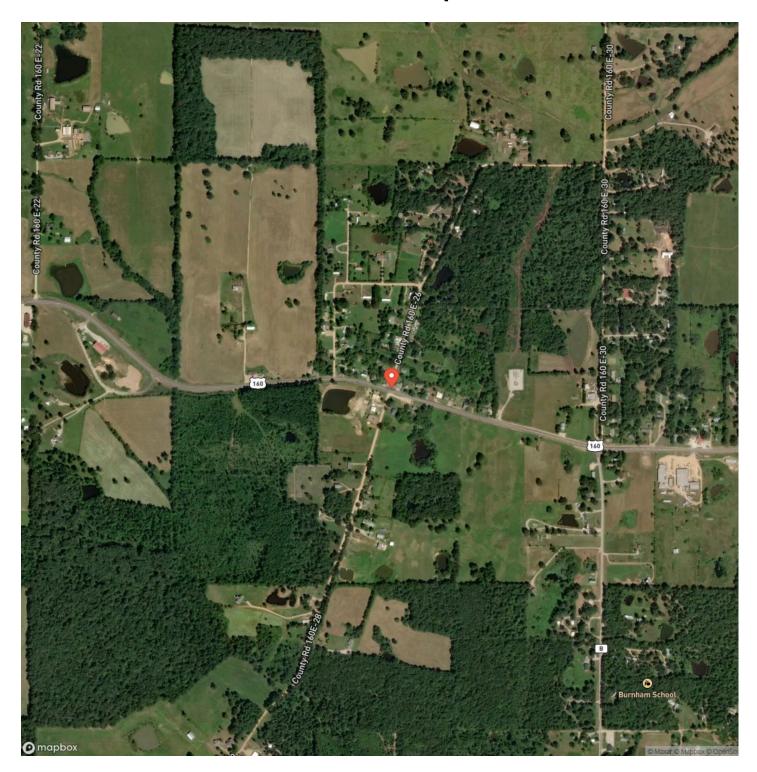
