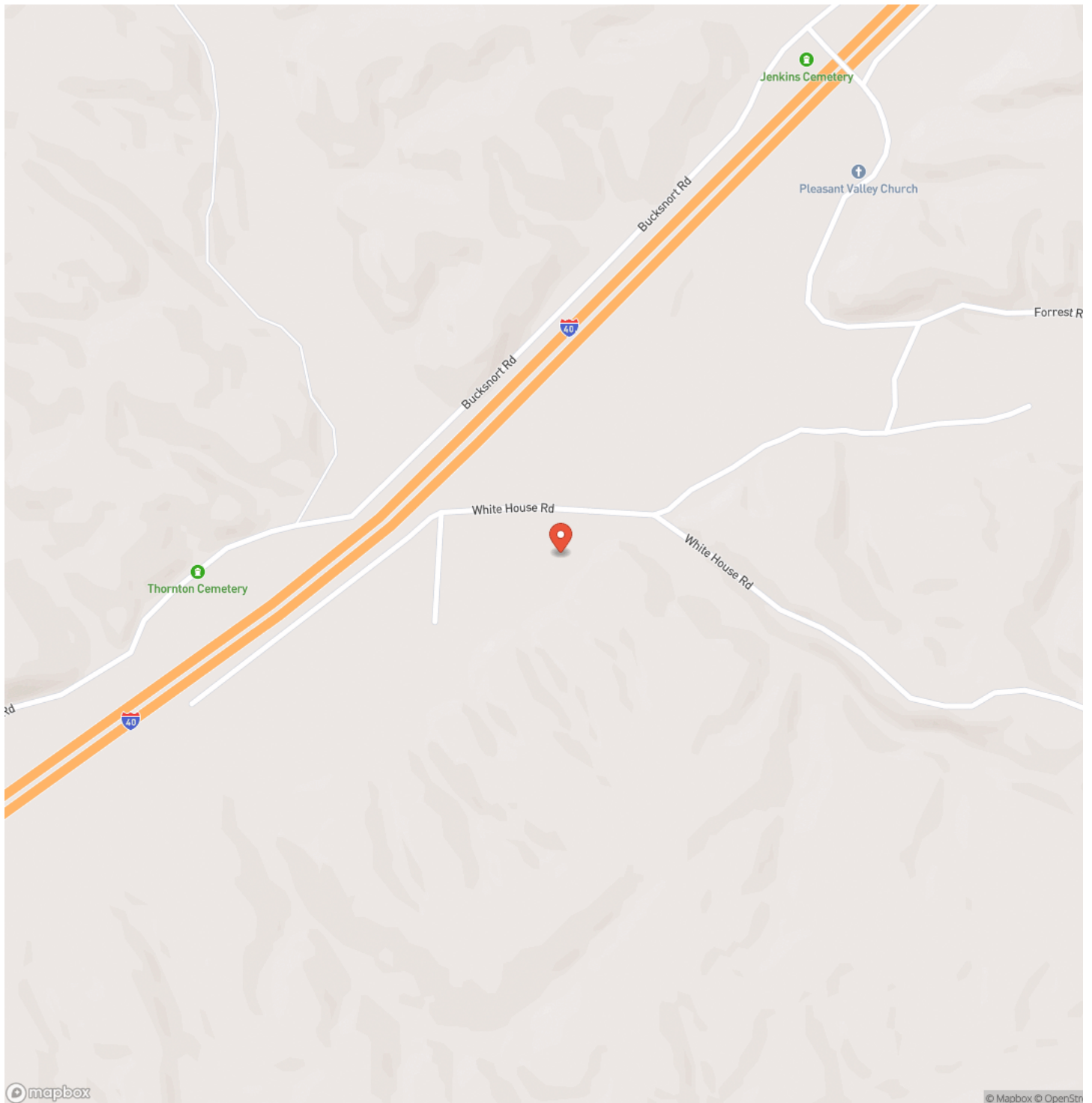

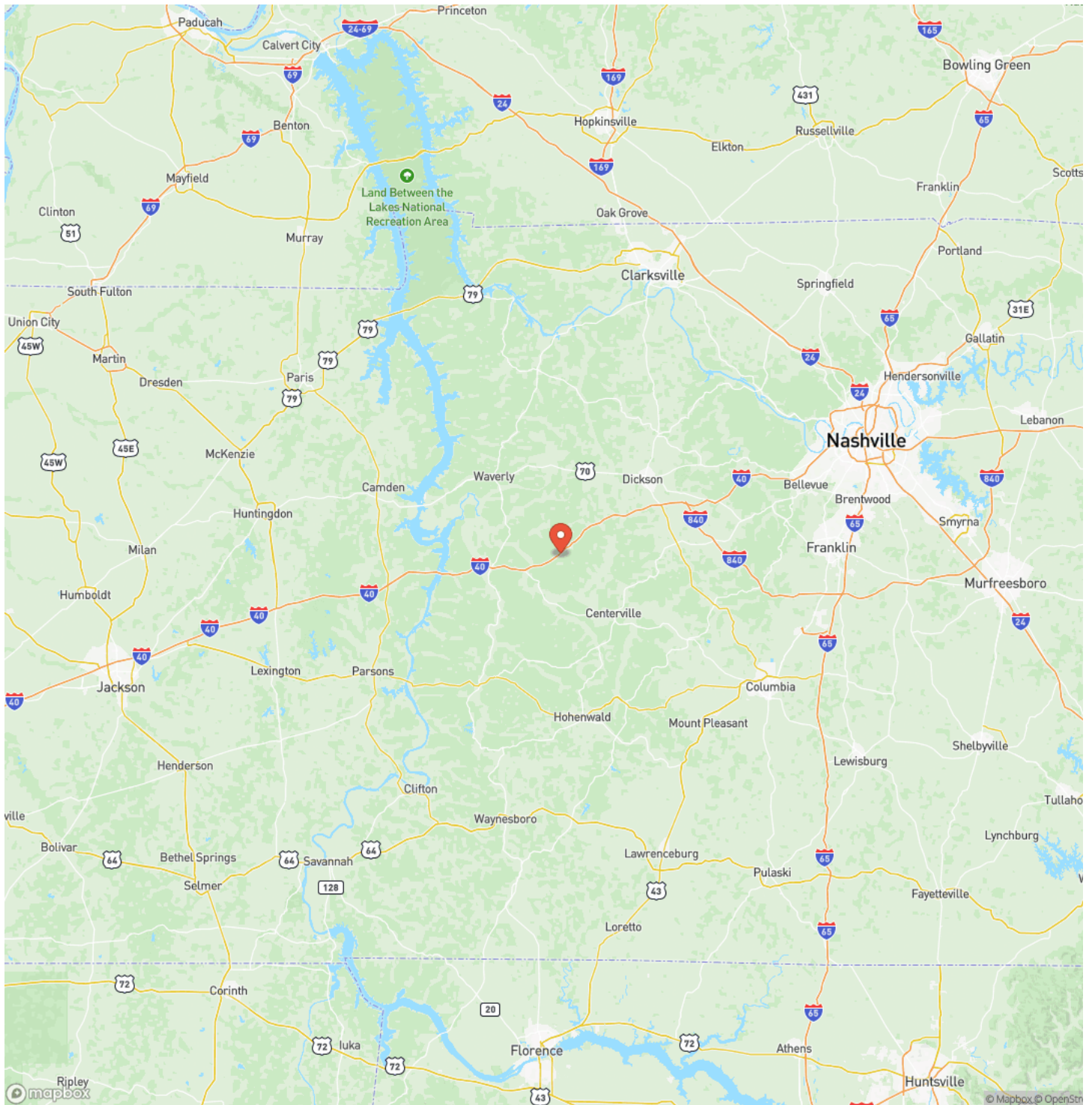




## Locator Map
