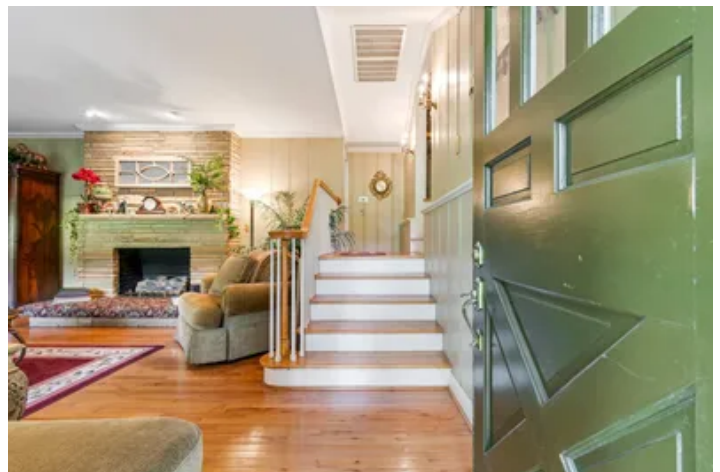

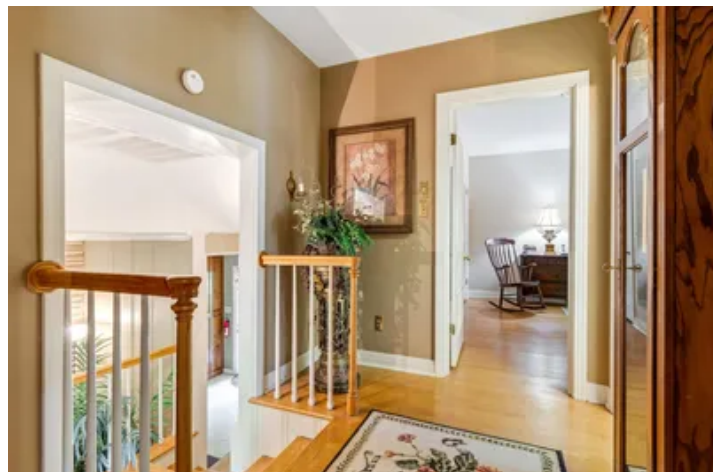

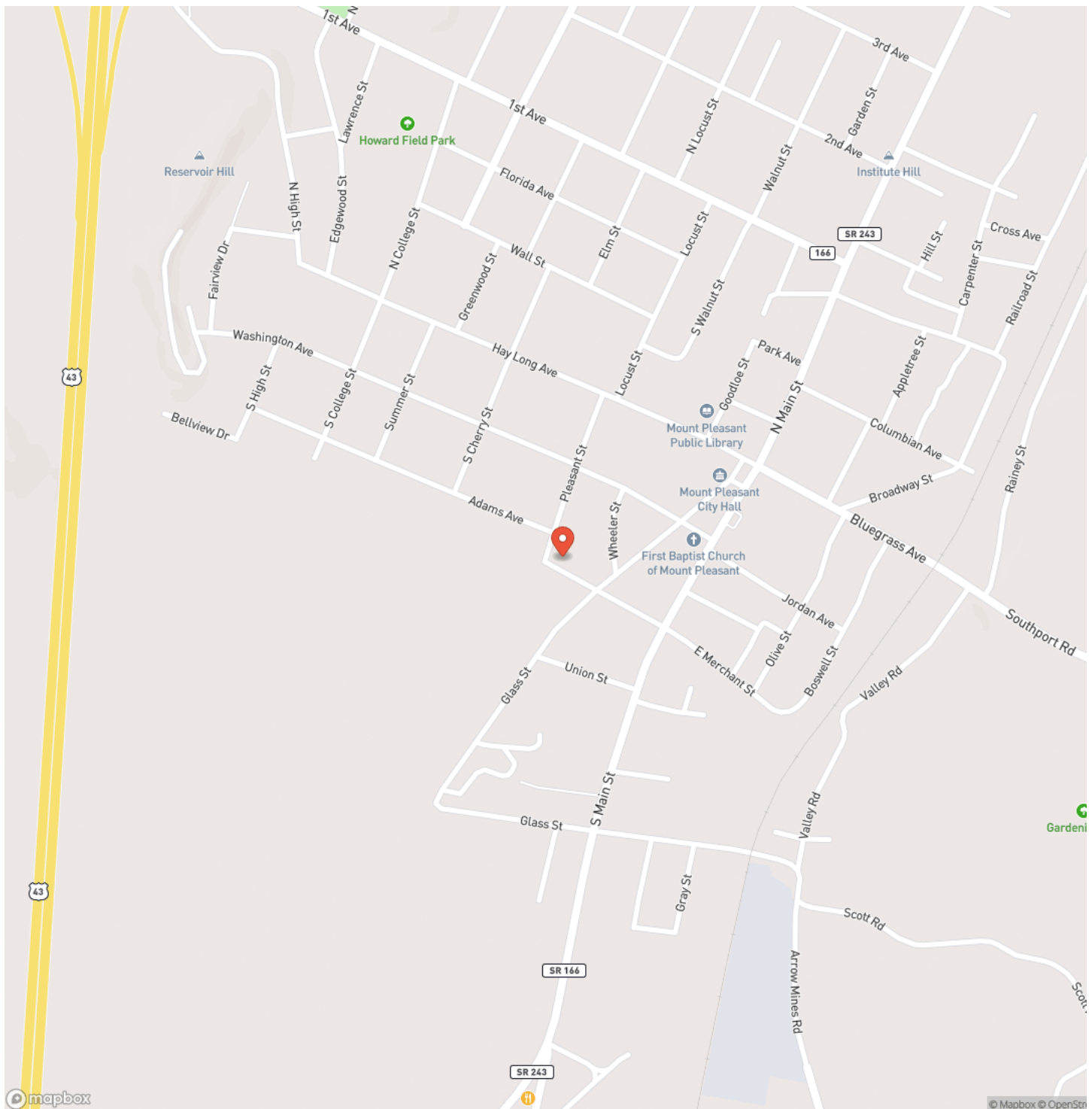
PROPERTY DESCRIPTION

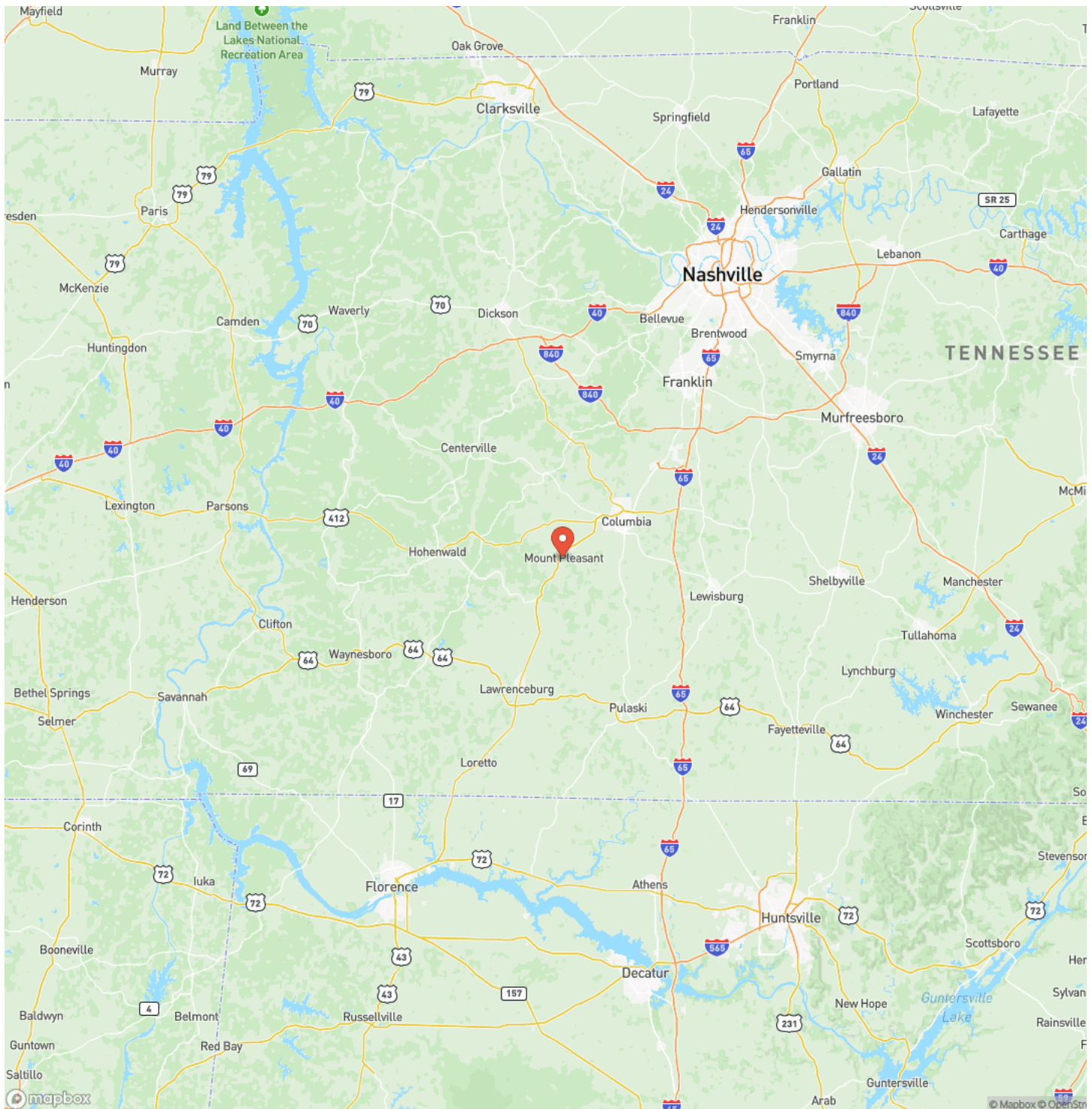

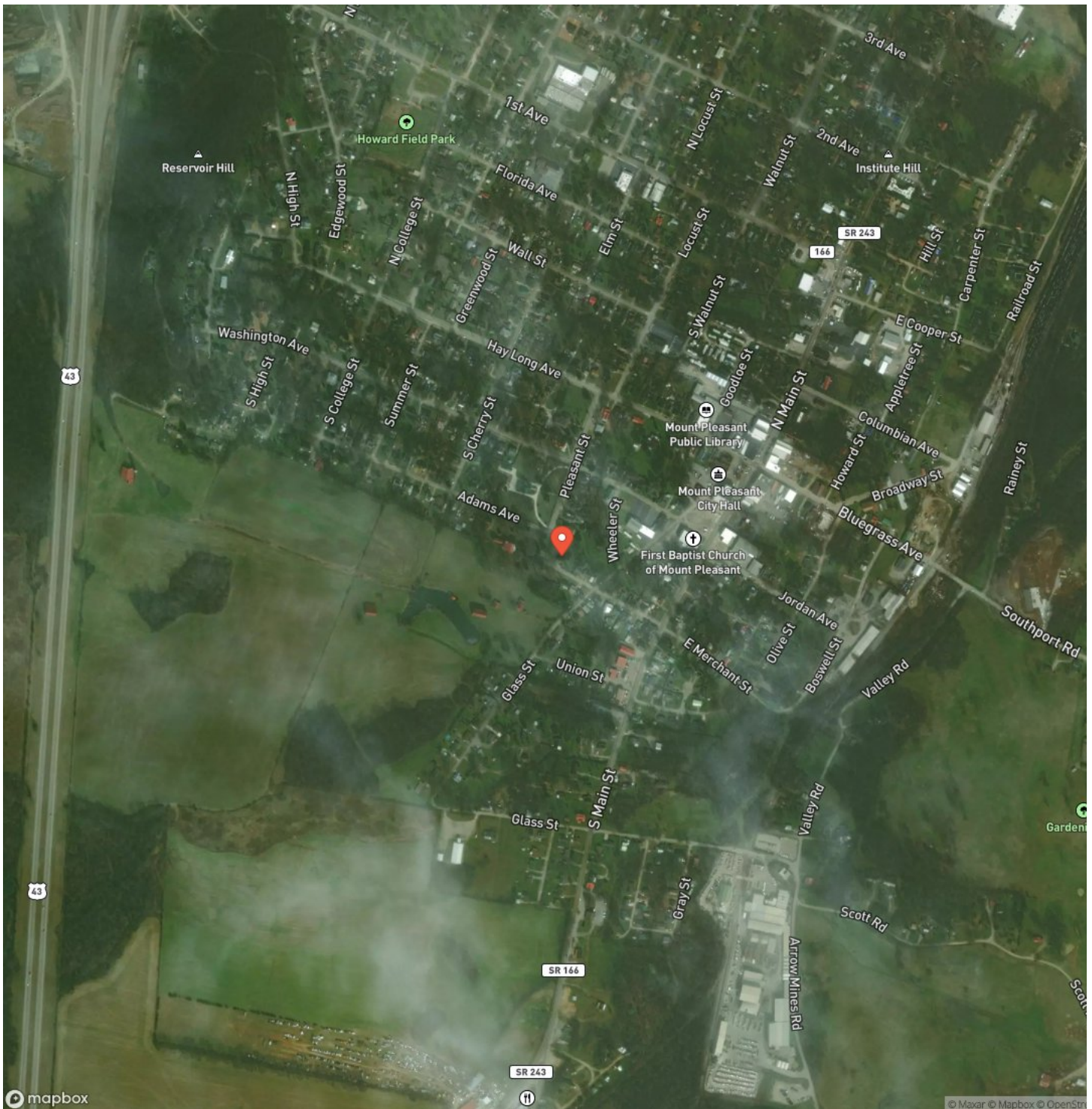
Locator Map
