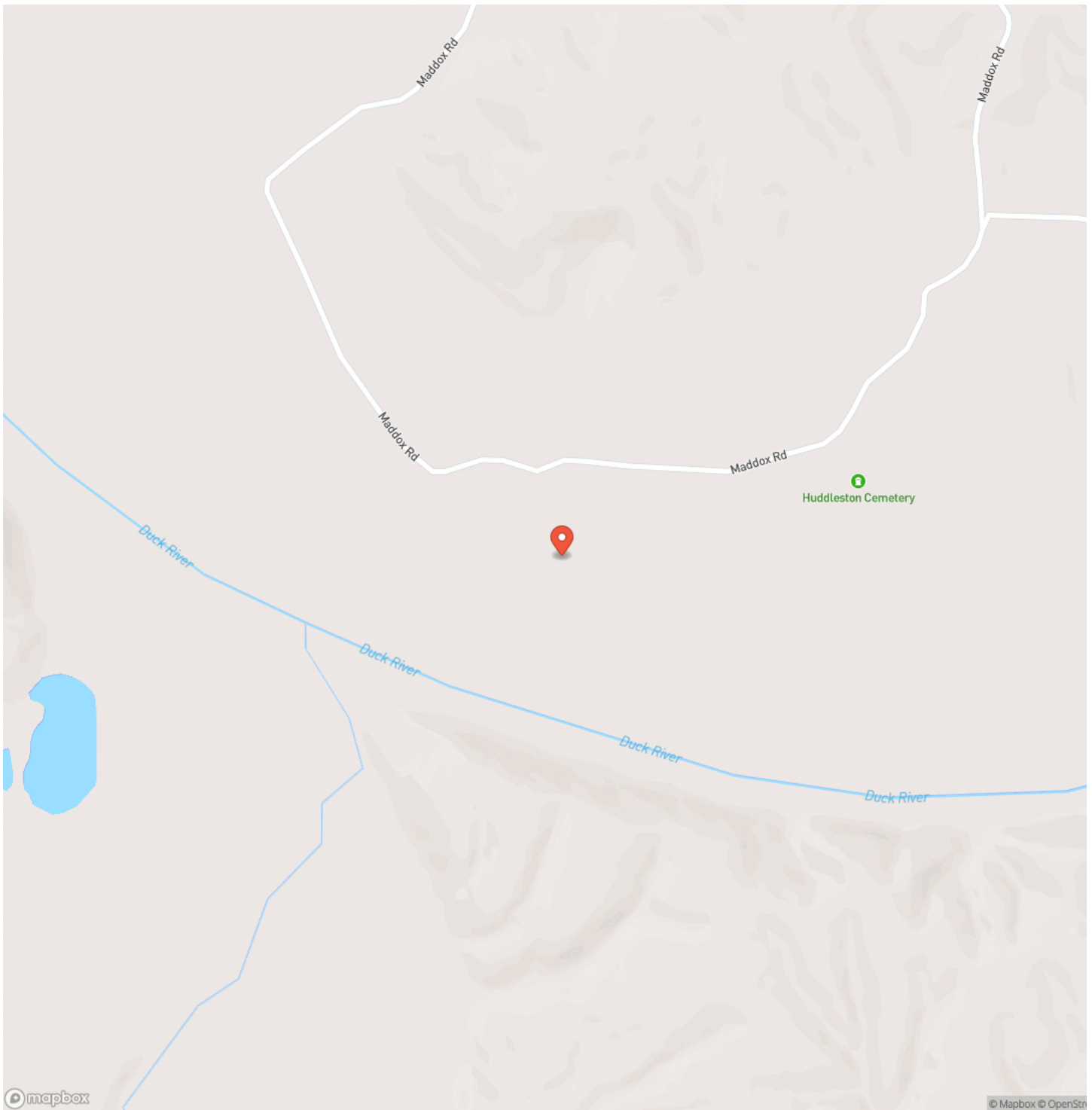

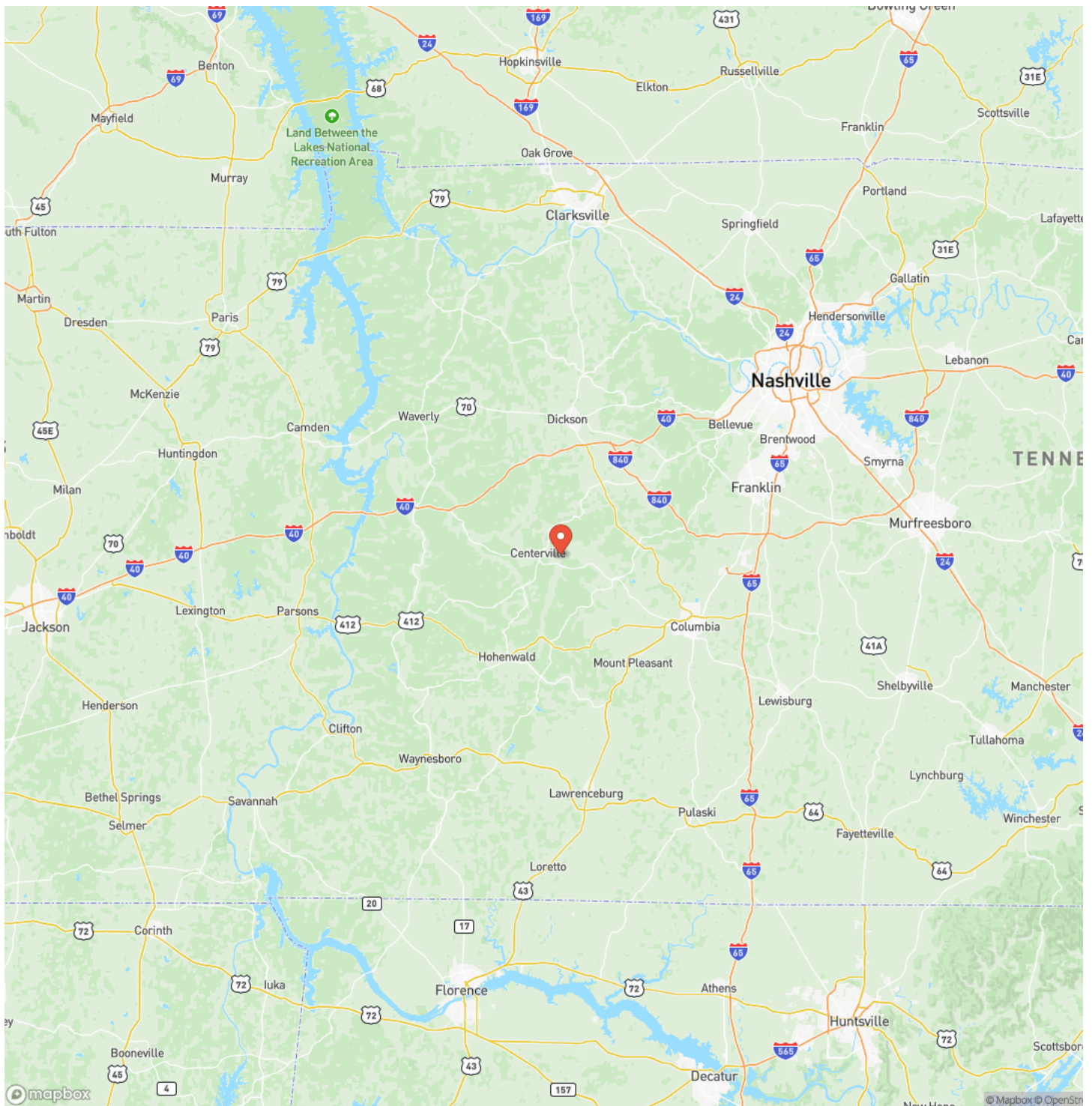


Locator Map

Locator Map



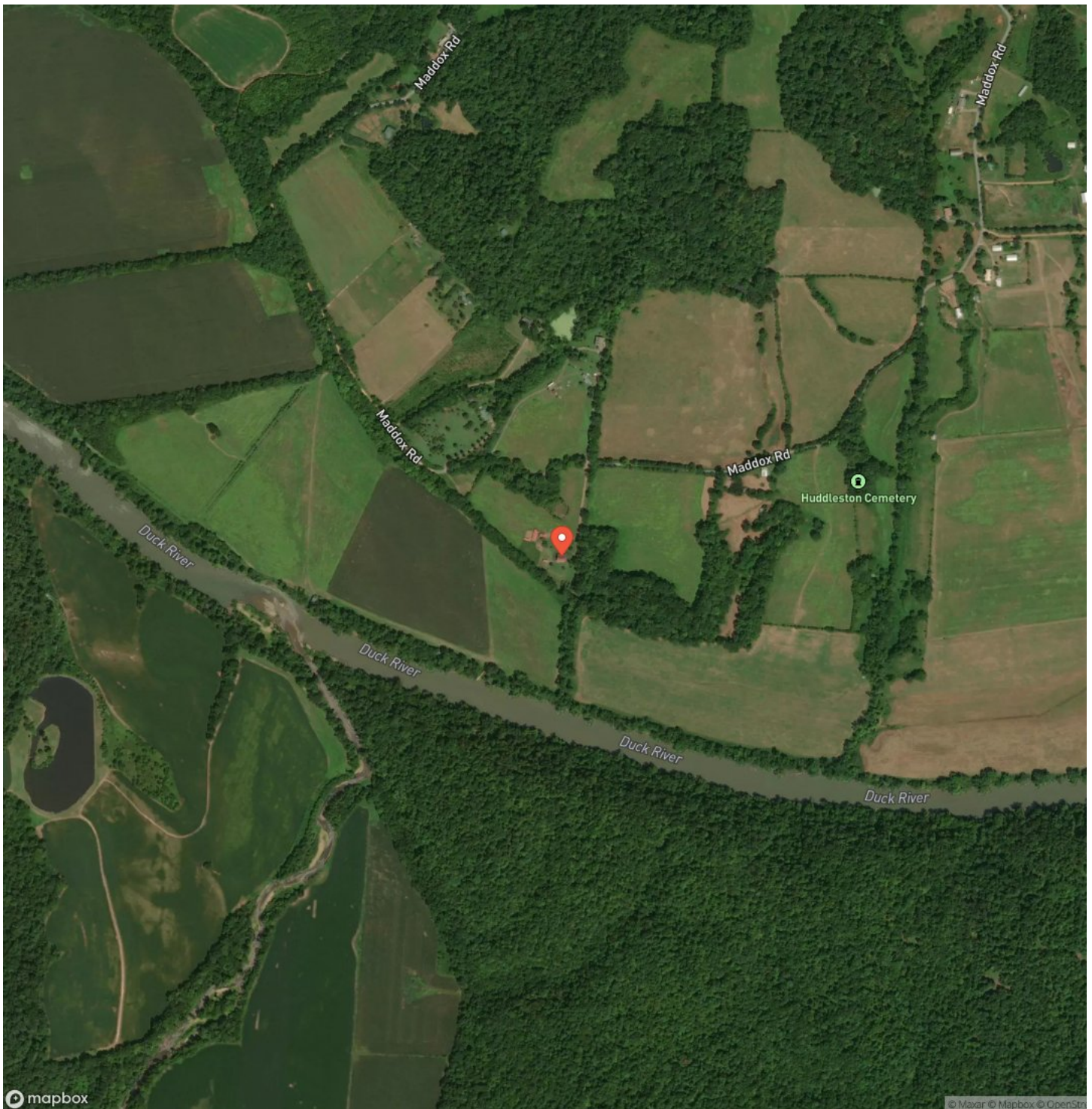
