## Disclosure of Information on Lead-Based Paint and/or Lead-Based Paint Hazards

### Hazards Lead Warning Statement

Lead poisoning in young children may produce permanent neurological damage, including learning disabilities, reduced intelligence quotient, behavioral problems, and impaired memory. A risk assessment or inspection for possible lead-based paint hazards is recommended prior to purchase.
