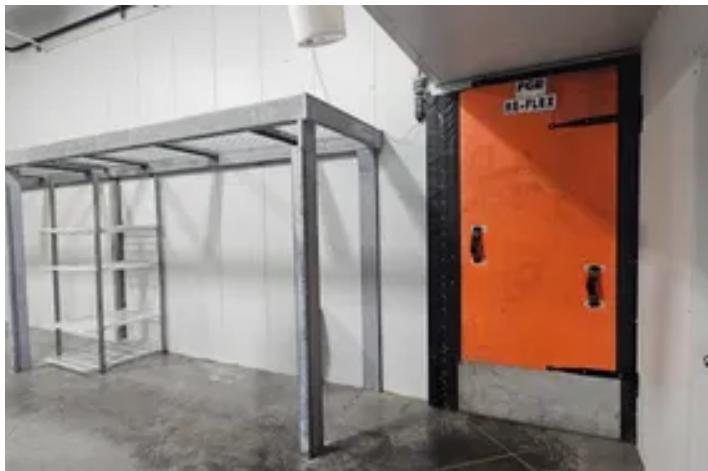

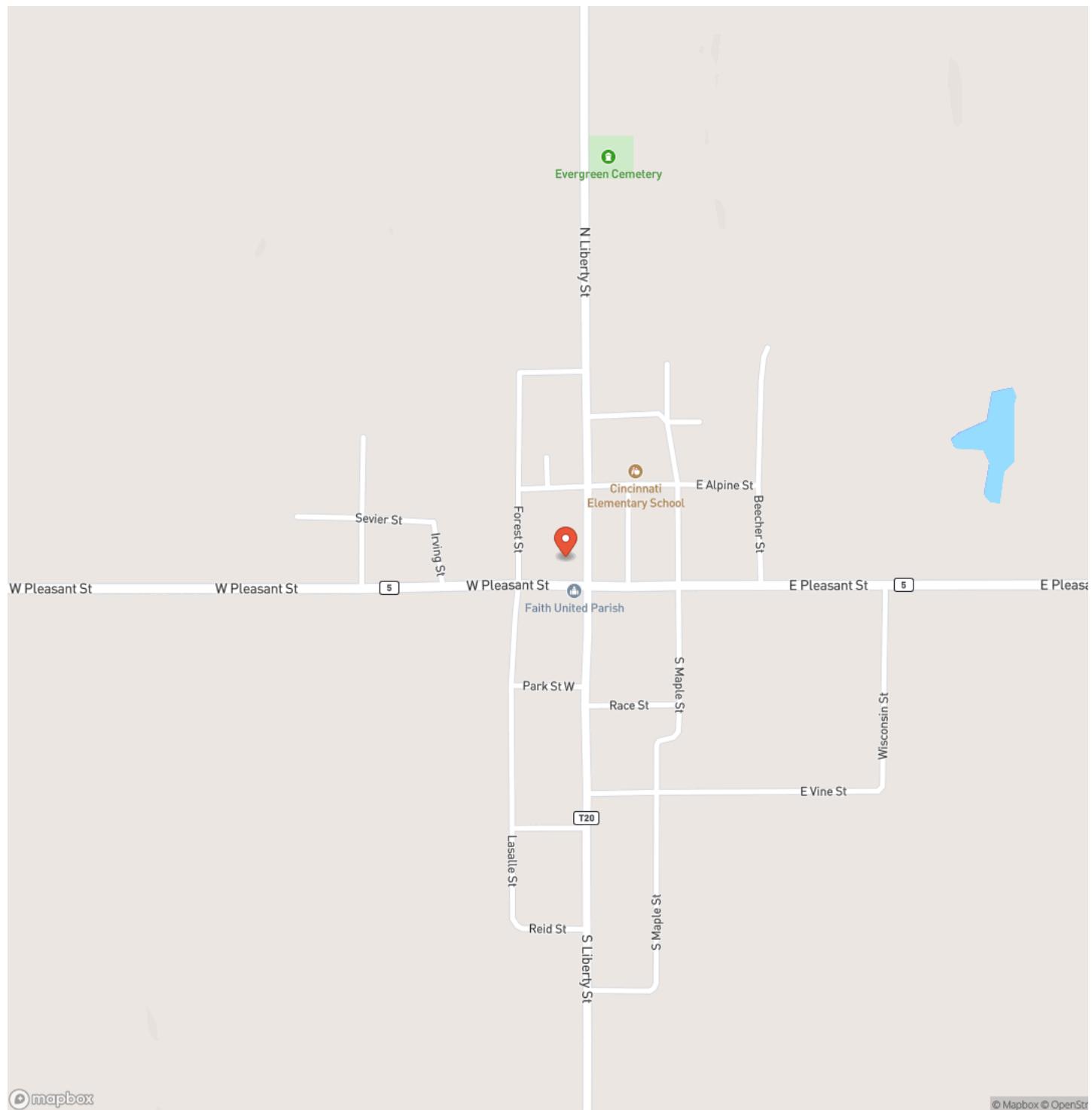

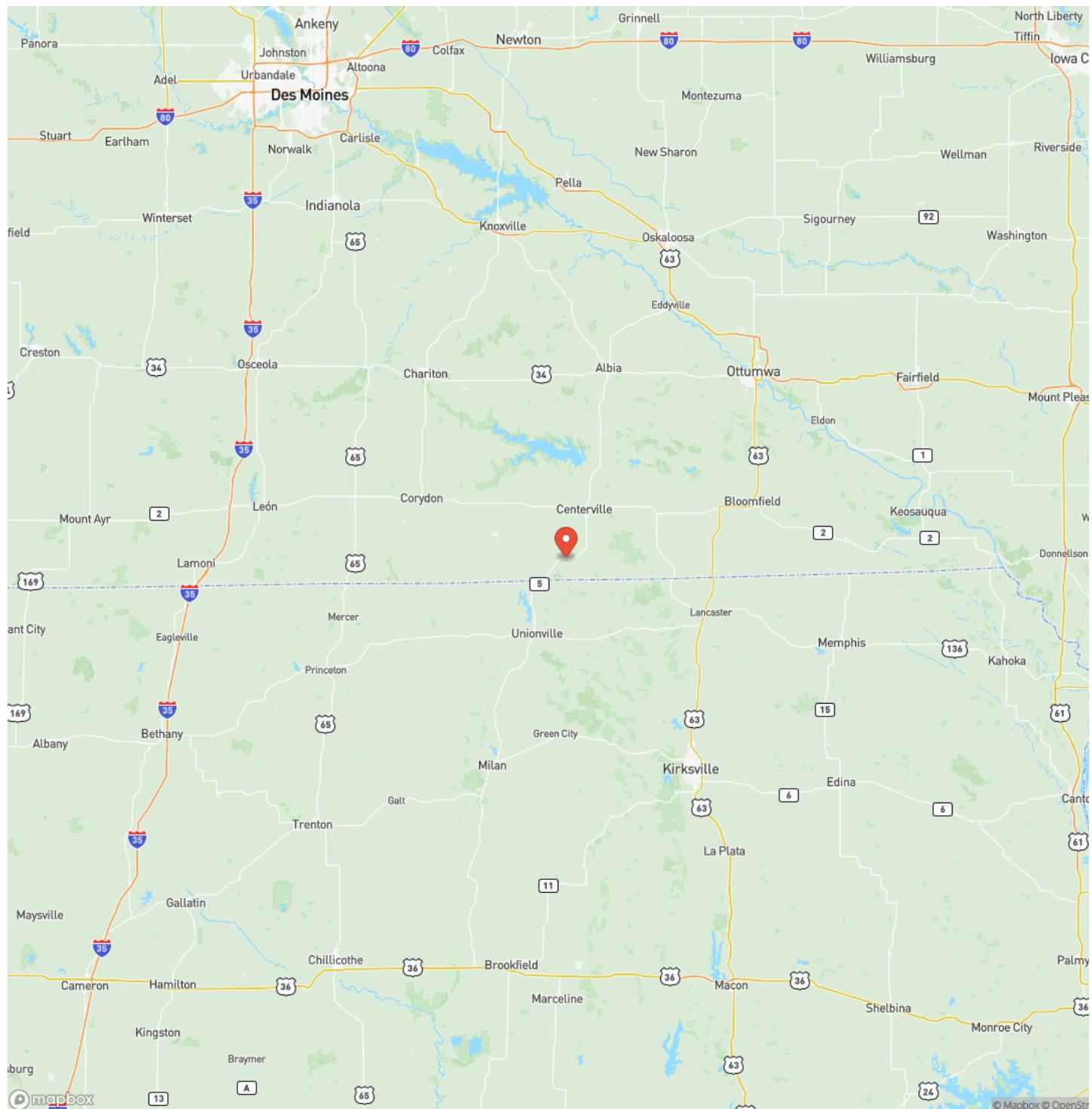


Locator Map



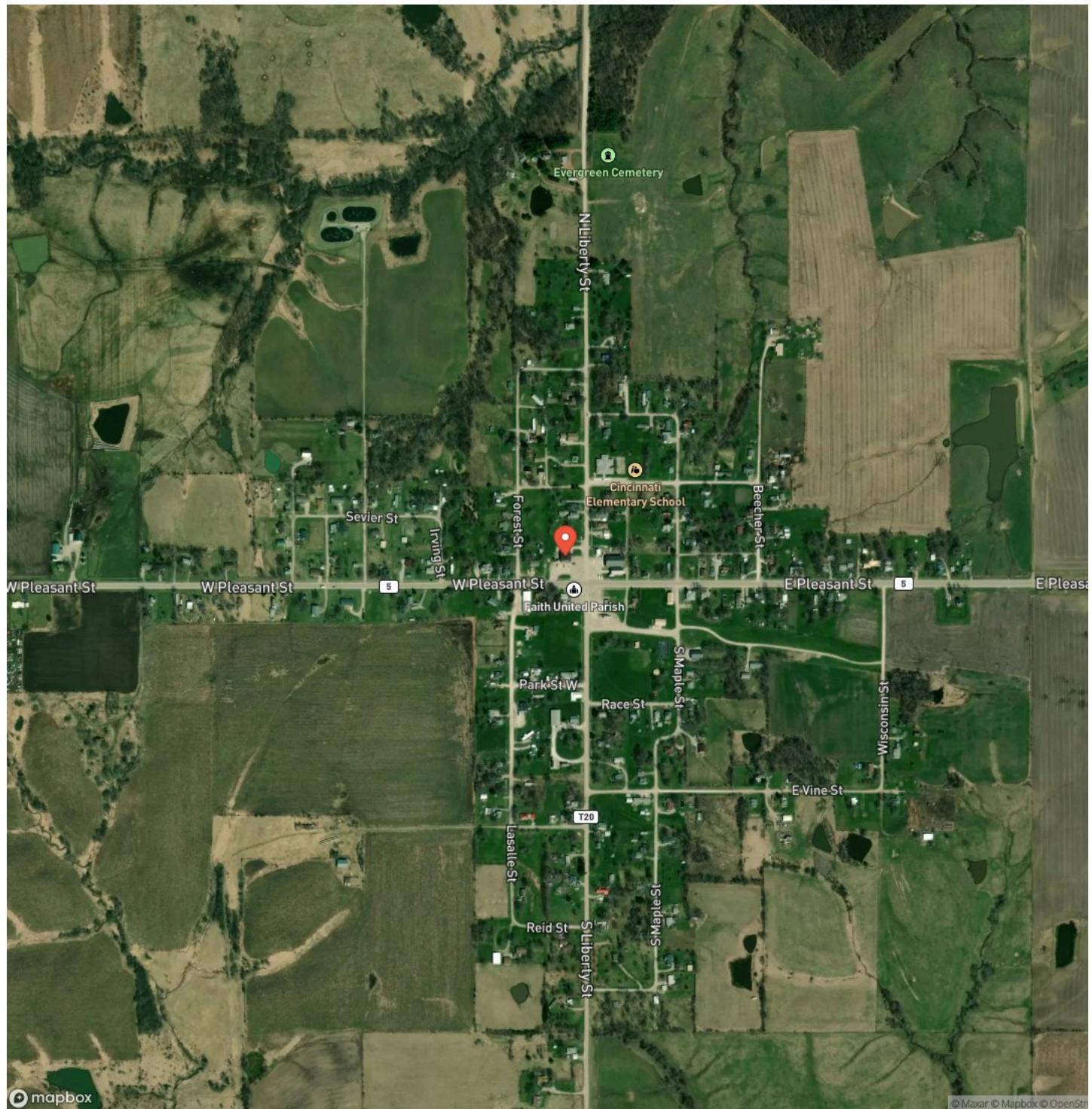
