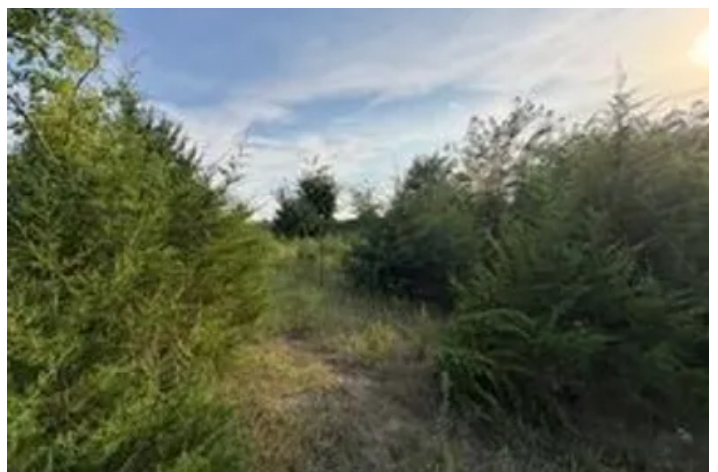

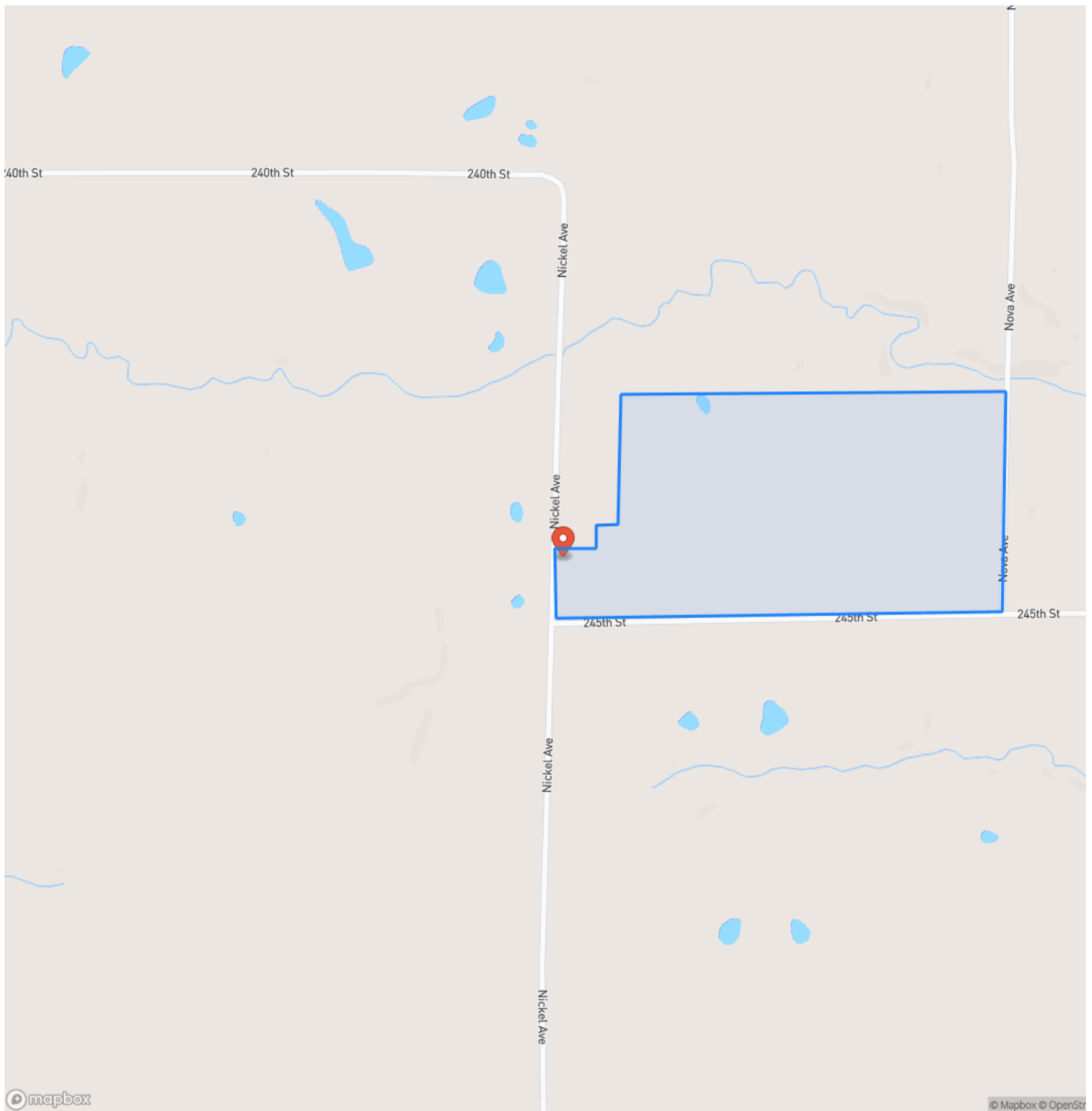
With its combination of productive farmland, quality pasture, recreational appeal, and income-producing potential, this Van Buren County farm is a rare opportunity in a desirable location.

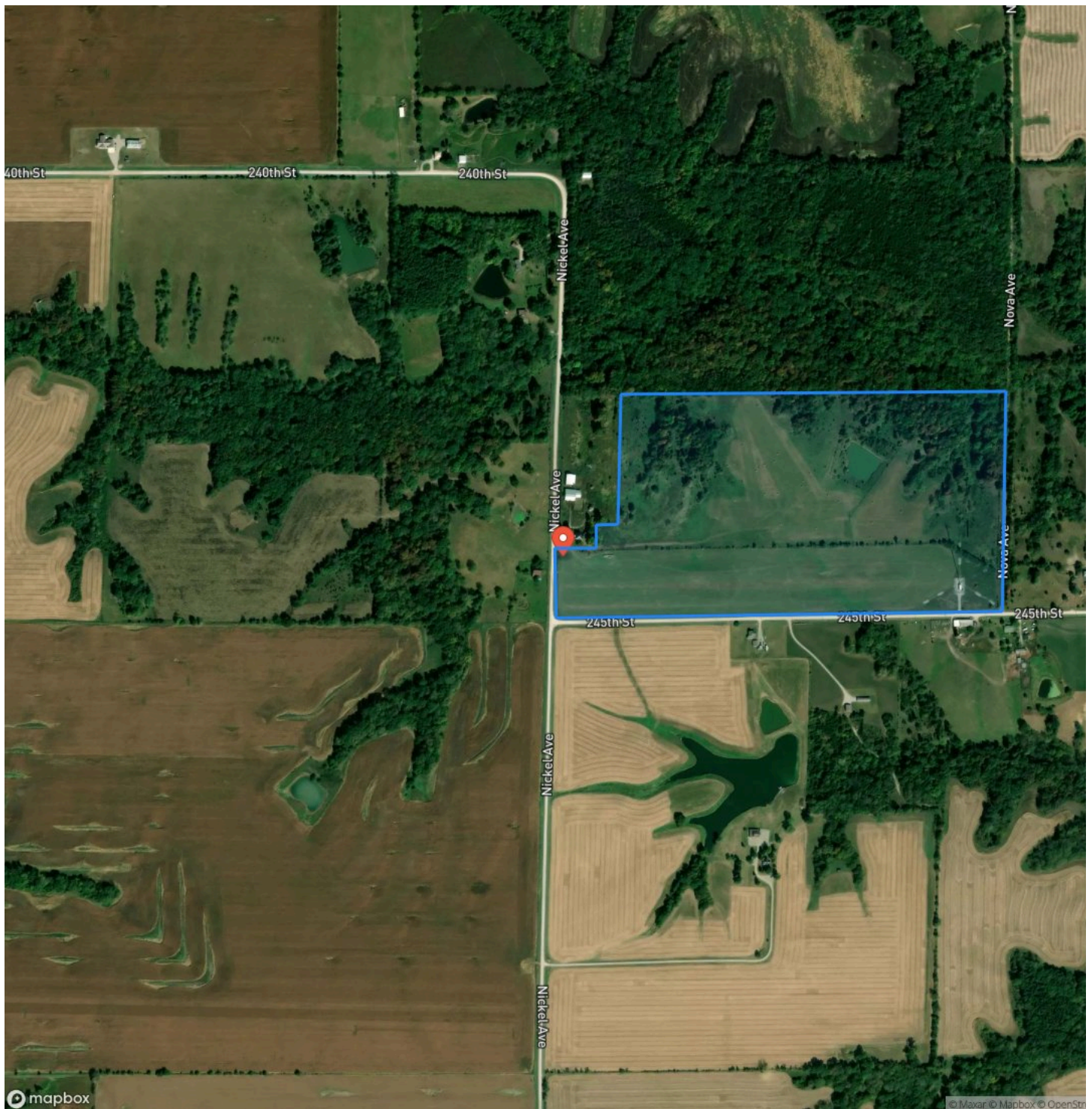
