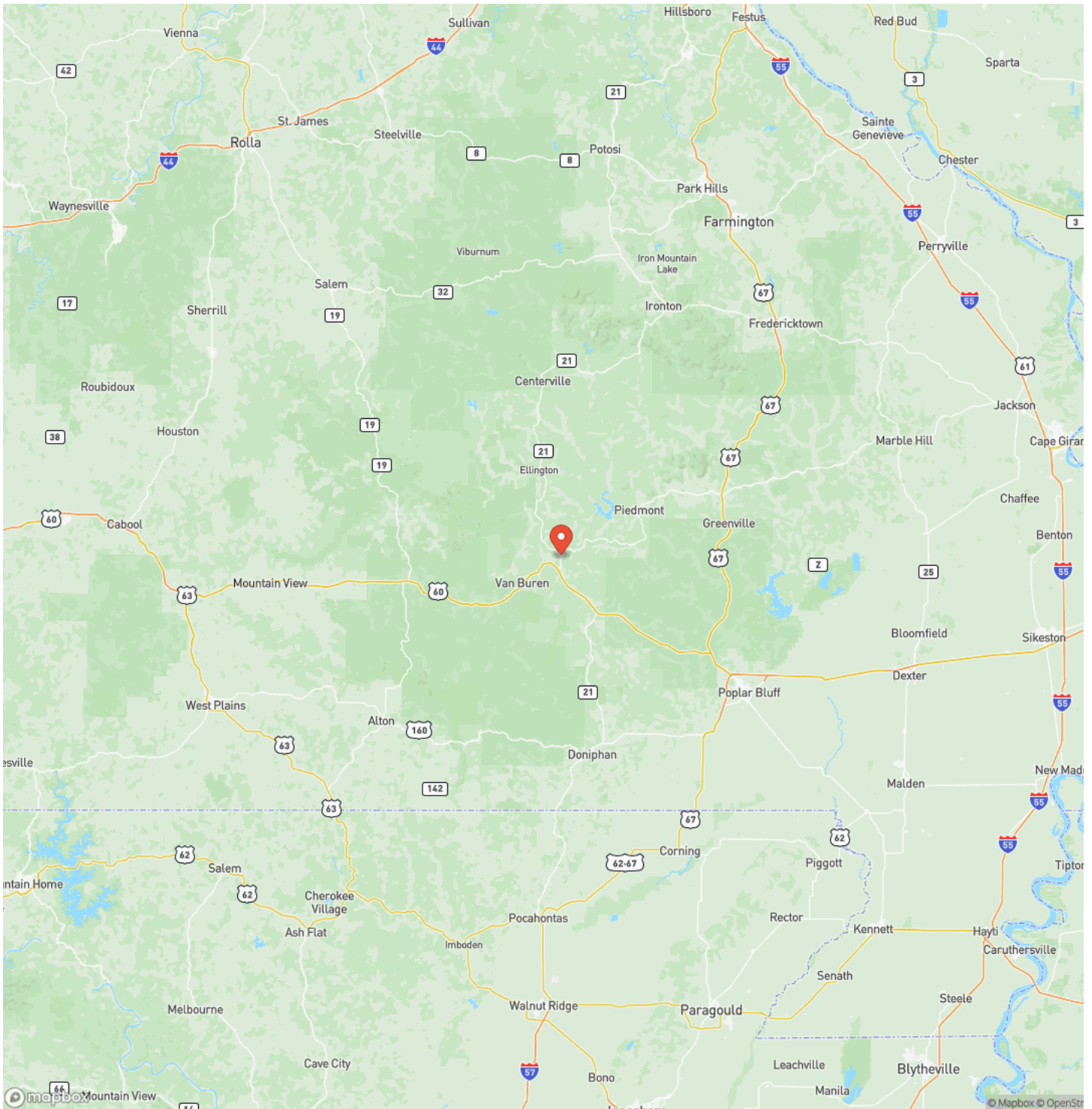


Locator Map

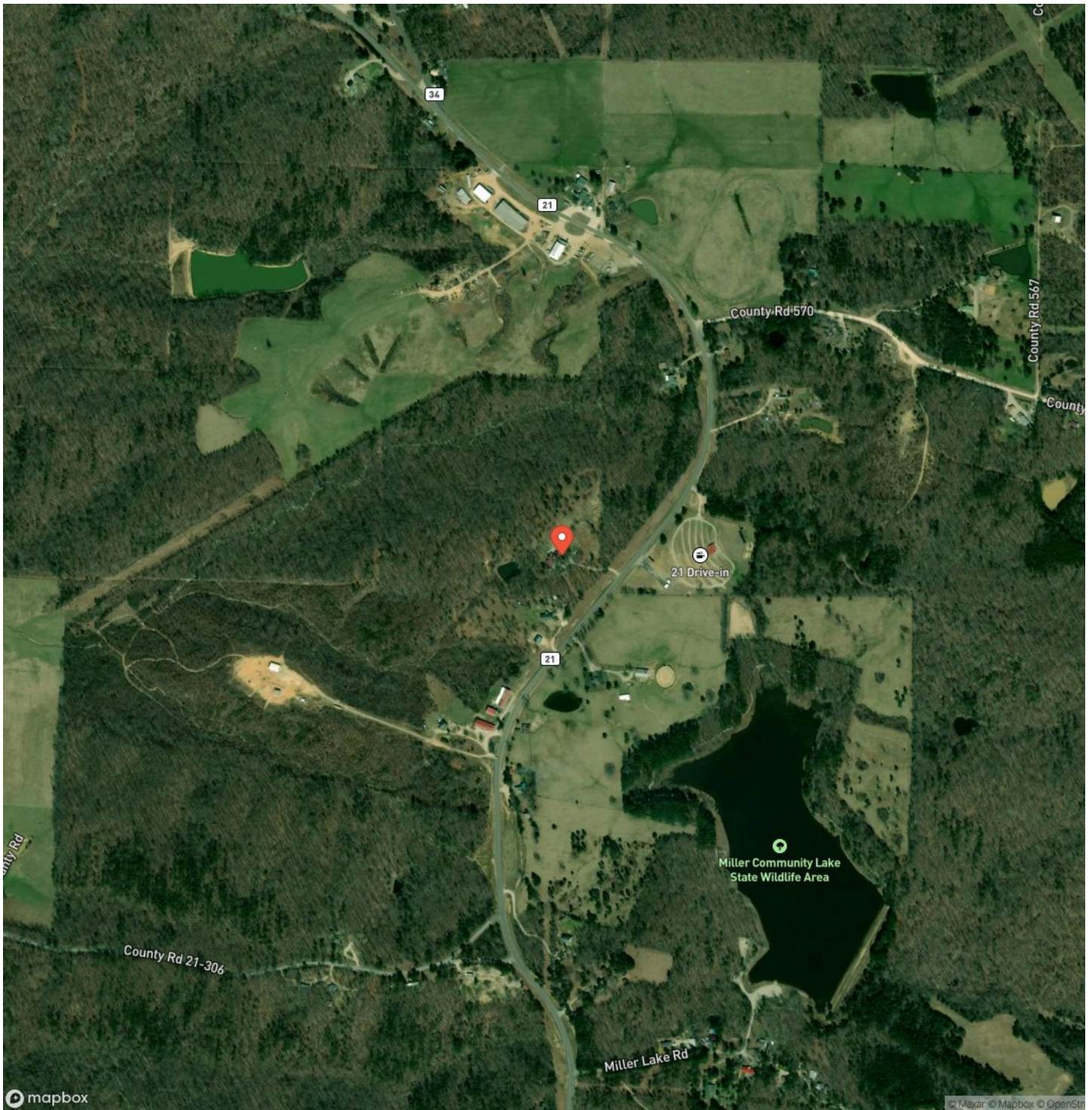
