Property features include:

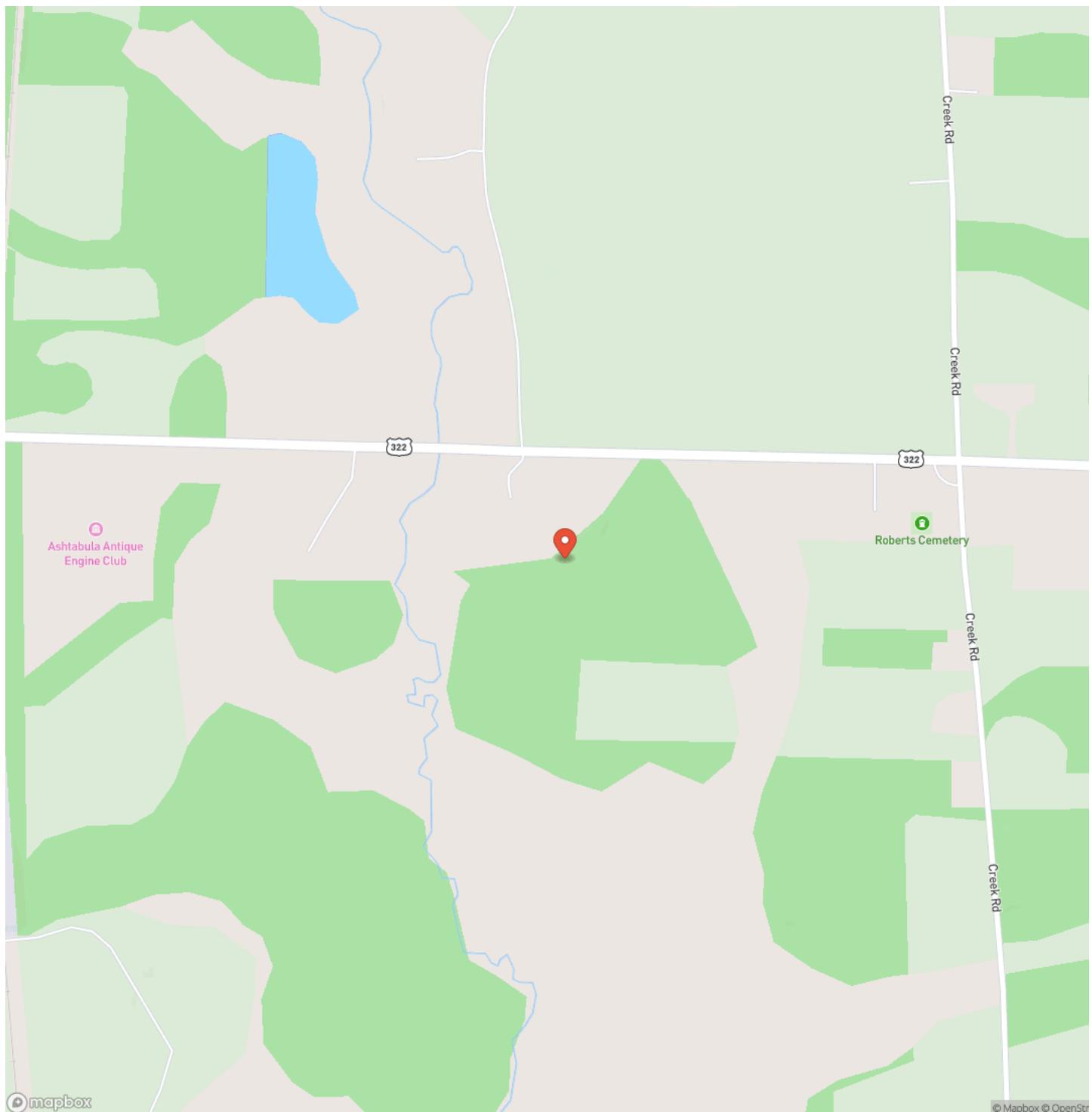
- Woods consist of early successional trees and brush with pole-size timber throughout.

Annual taxes are approximately \$1,216.26. What mineral rights that the sellers own will transfer. Showings by appointment only.

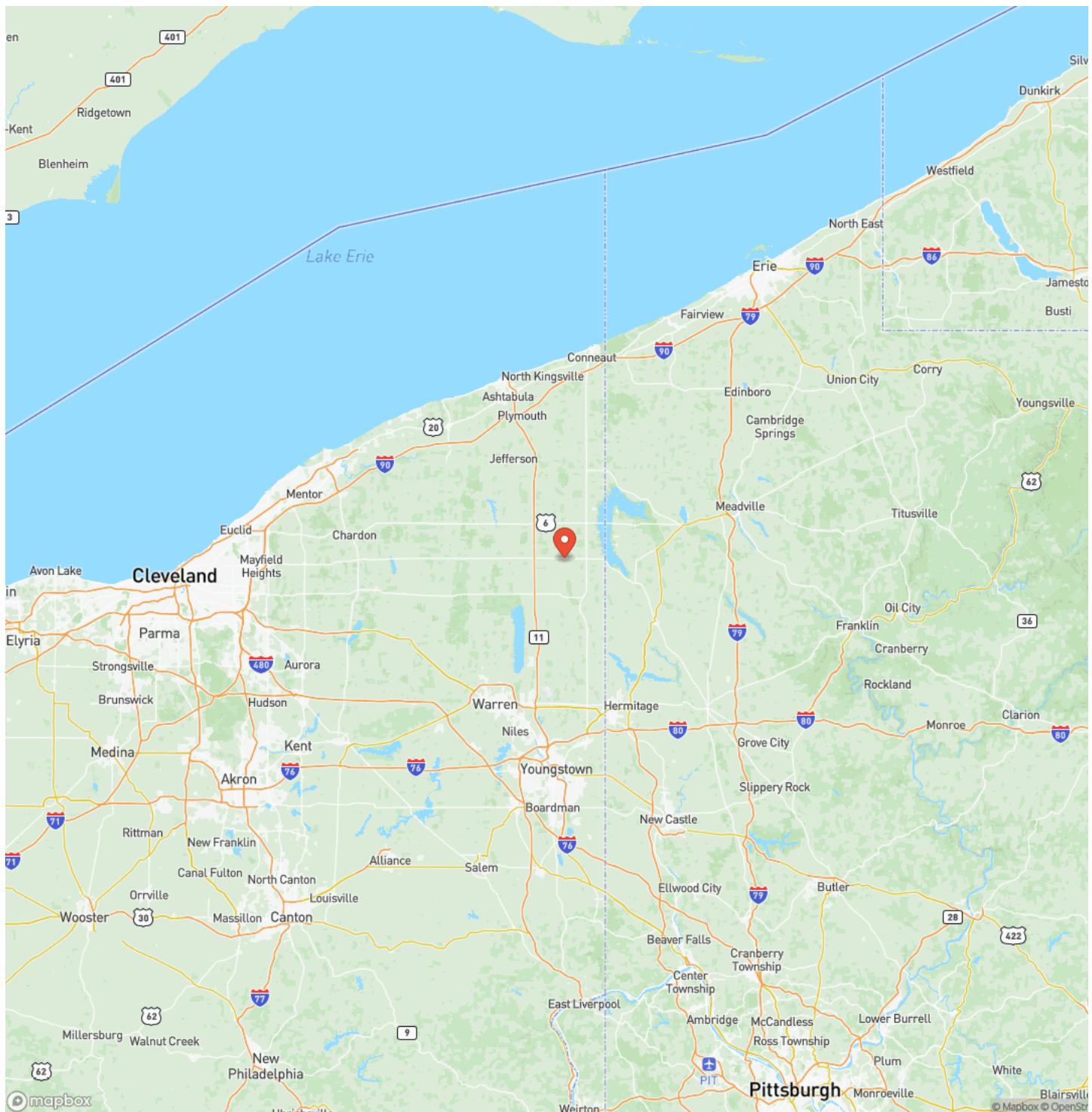

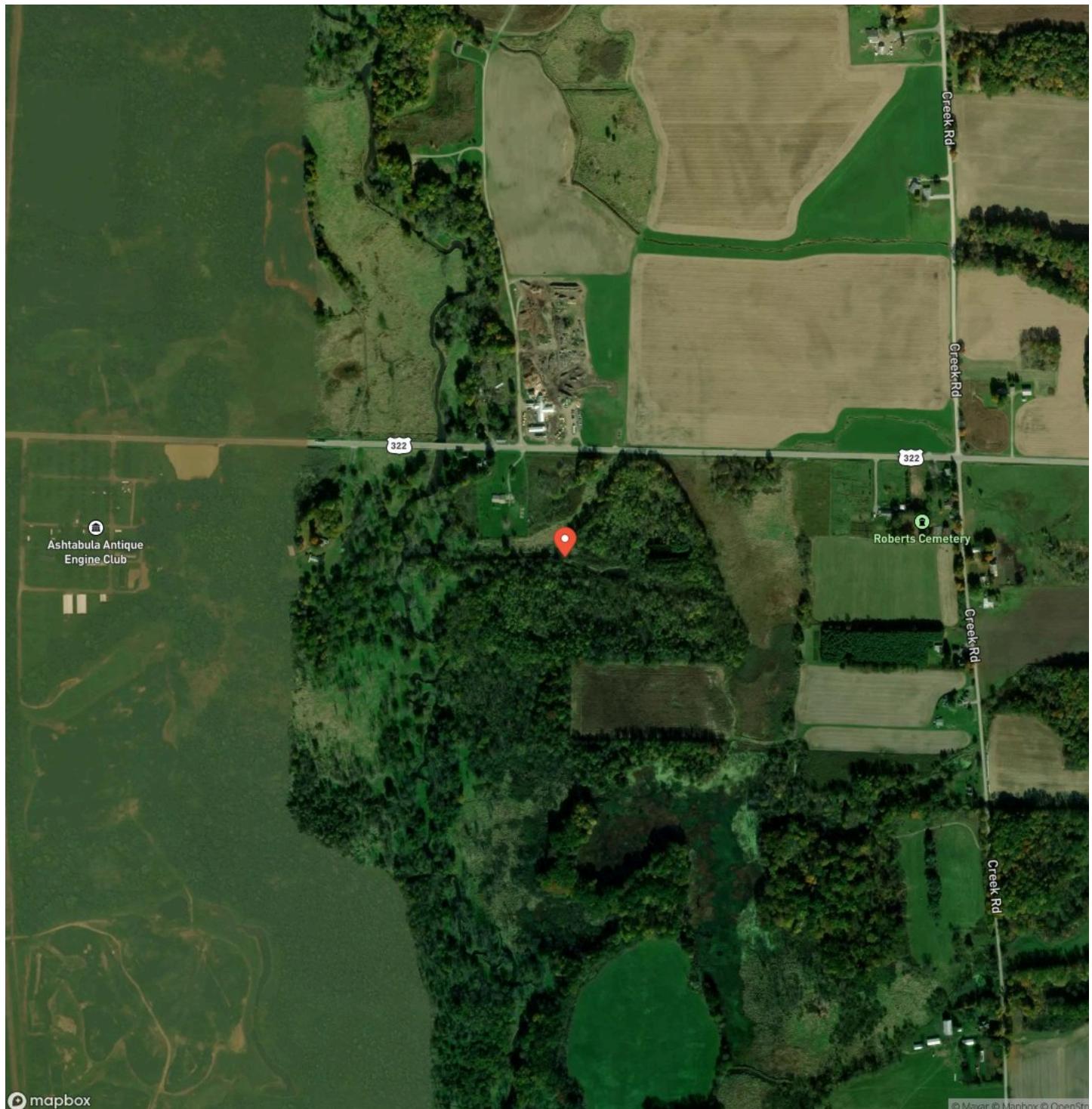
## Locator Map
