A small creek flows through the property, attracting wildlife and making this an excellent opportunity for hunting whitetail deer and turkey. Access is currently provided by a one-year temporary easement, giving the new owner time to install a permanent driveway. Electric and county water are available at the road. Conveniently located just 20 minutes from Hocking Hills, 30 minutes from Athens, and 55 minutes from Columbus. Access to OH-33 is only 2 miles away. Located in Green Township within the Logan-Hocking Local School District. Any mineral rights the seller owns will transfer with the sale.

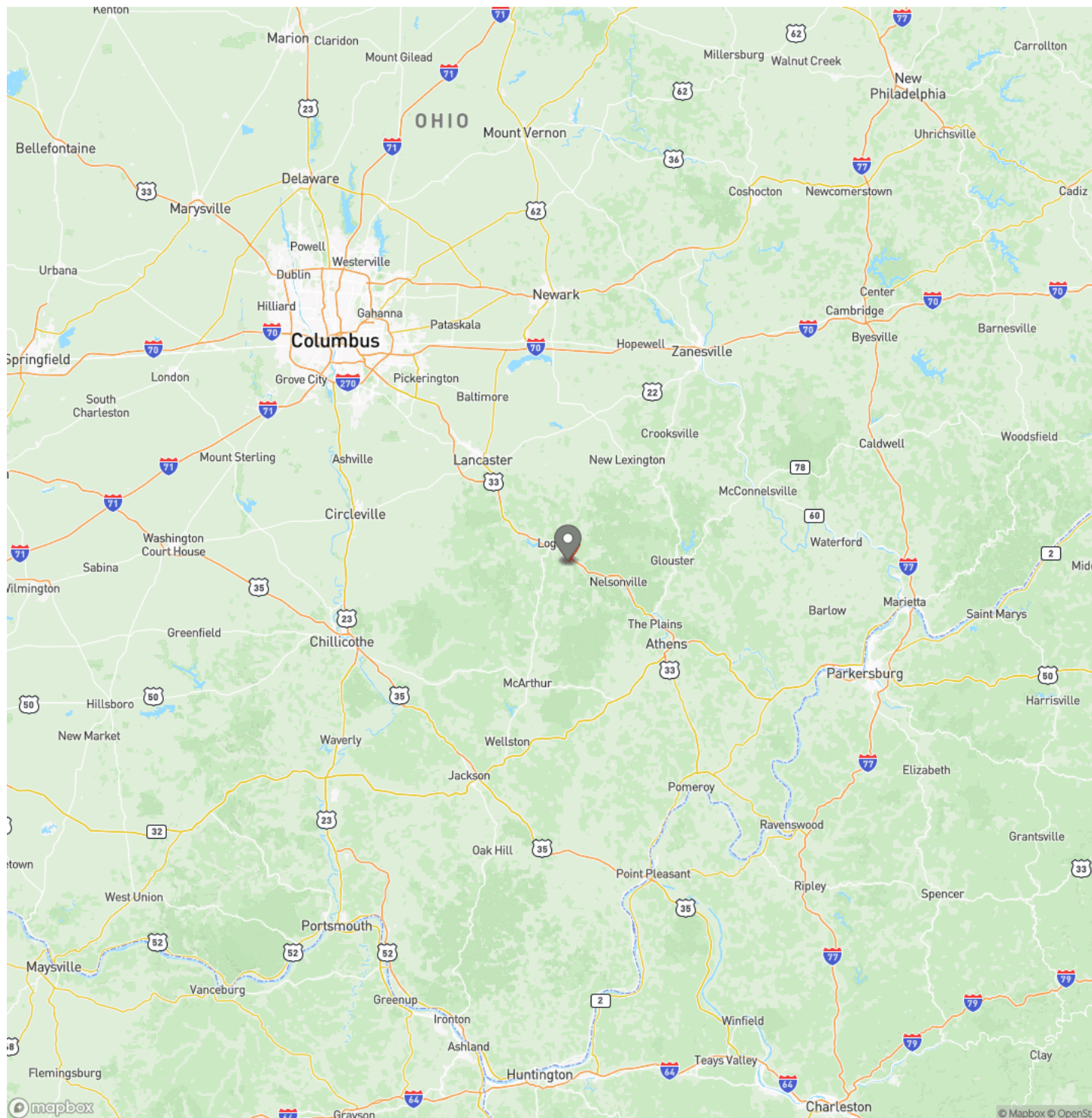


Locator Map
