This beautiful 108-acre property in southern Cherokee County, South Carolina, offers a rare mix of open land, river frontage, and peaceful country living. About 17 acres are open fields, while the rest of the land is covered with mature natural hardwoods and planted pines that create a quiet and scenic setting.

The property features more than 1,000 feet of frontage on the Broad River, giving you easy access to fishing, kayaking, and relaxing by the water. A historic railroad bed from the 1800s runs along the river bottom, adding character and a touch of local history.

A rustic barn and a stunning homesite shaded by large old oak trees are surrounded by 10 acres of well-maintained hay fields, creating a picture-perfect country setting.

Wildlife is everywhere on this land, including deer, turkey, and quail, making it ideal for hunting and outdoor recreation. There are also great spots for hiking, horseback riding, and peaceful walks through the woods. A nearby public boat landing makes it easy to enjoy even more time on the river.

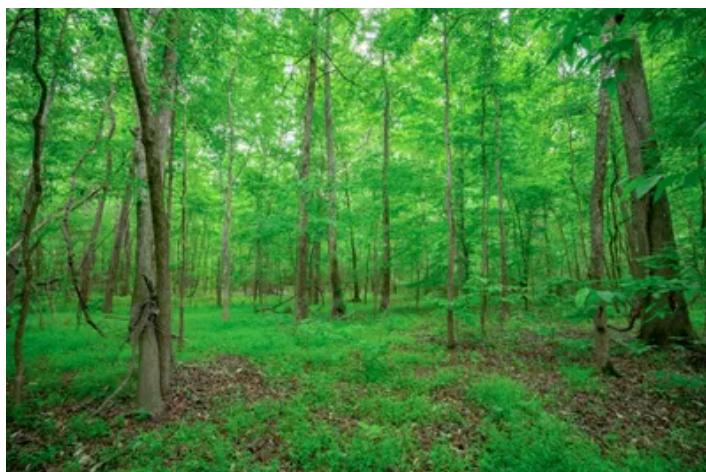

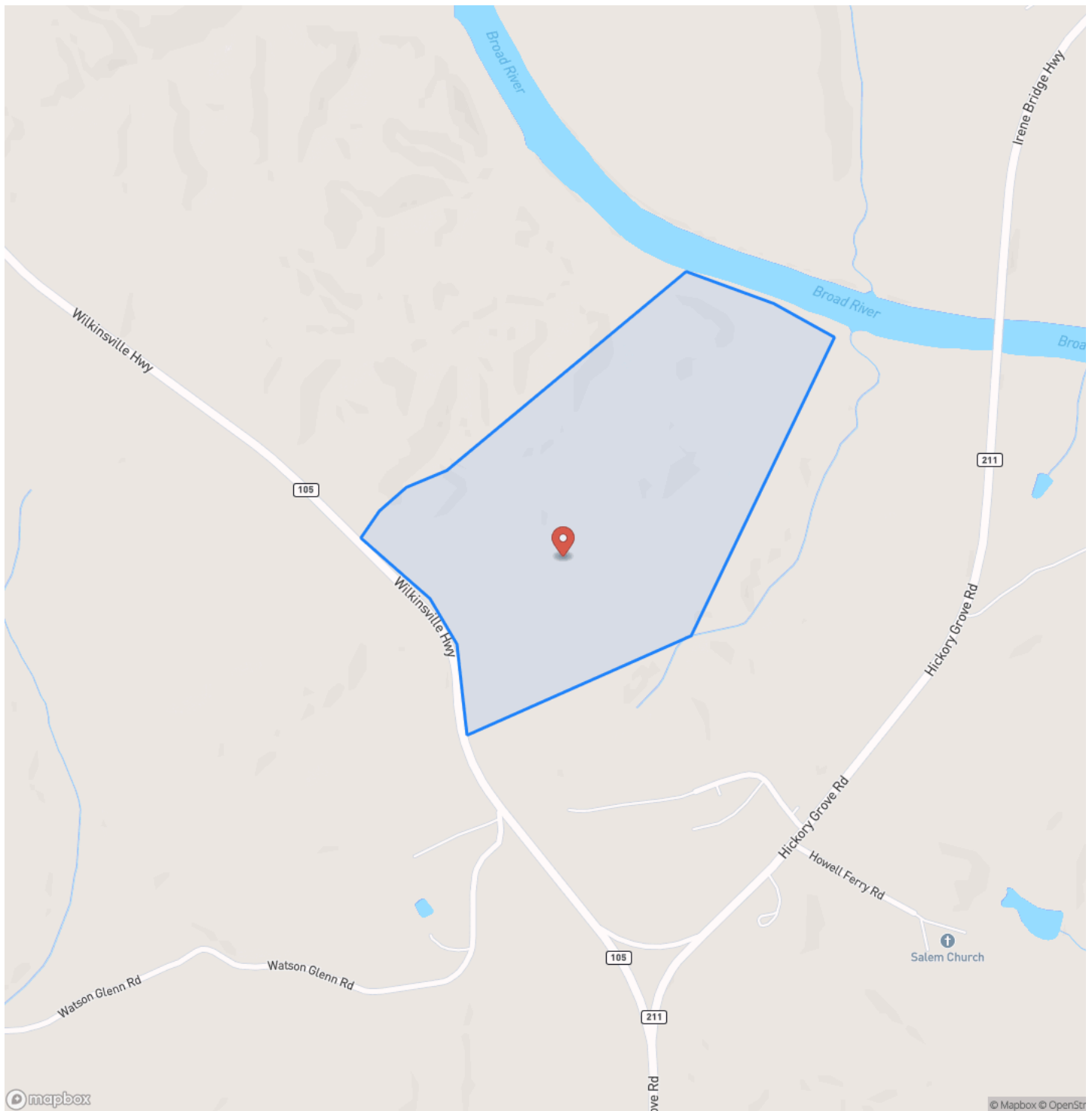
