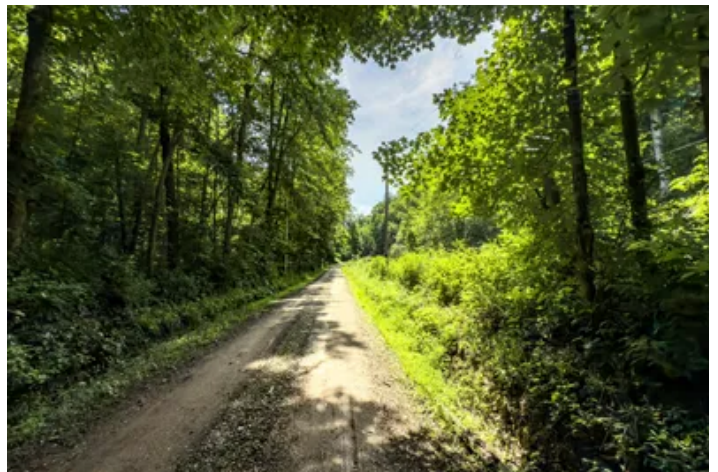

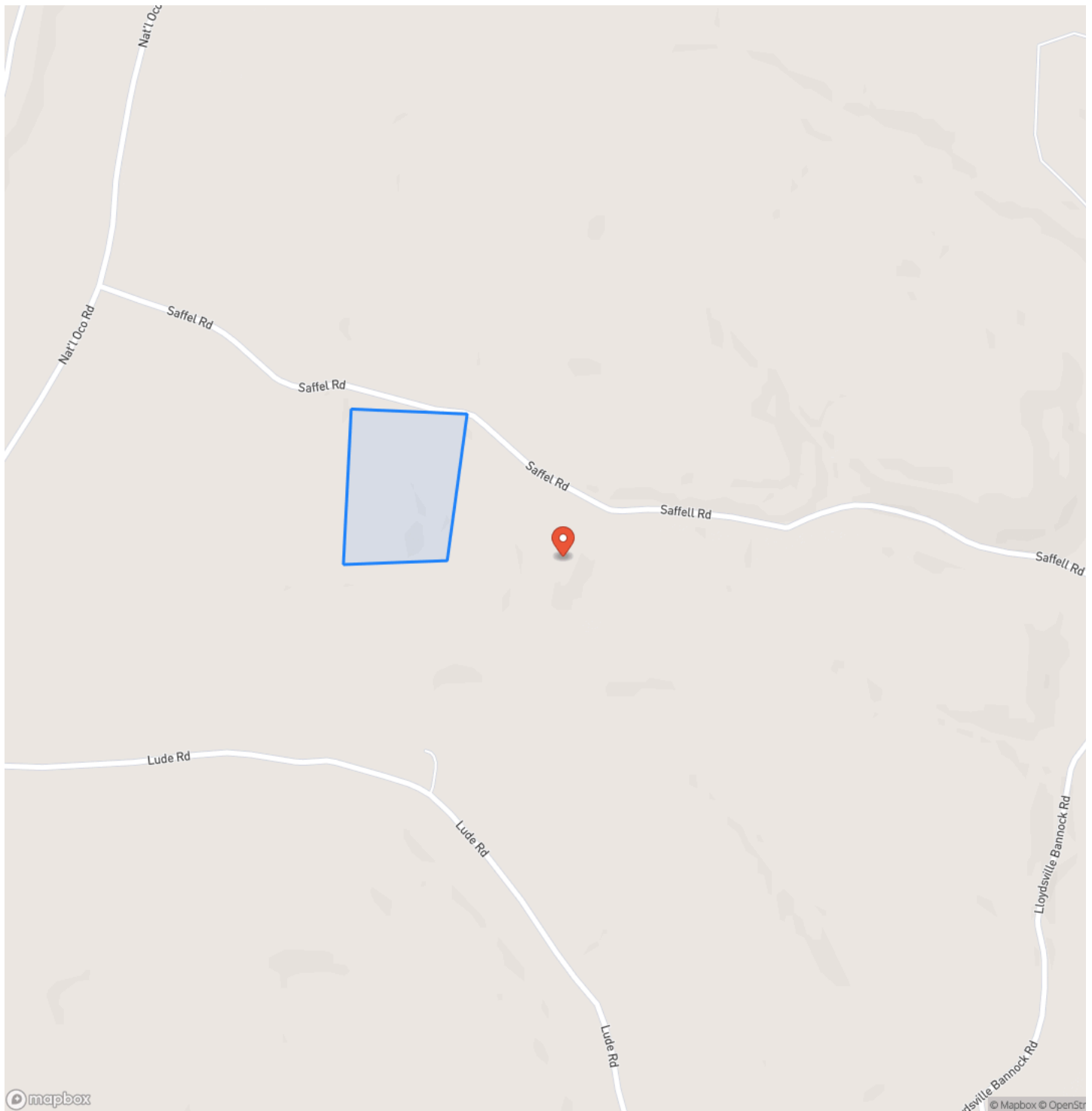

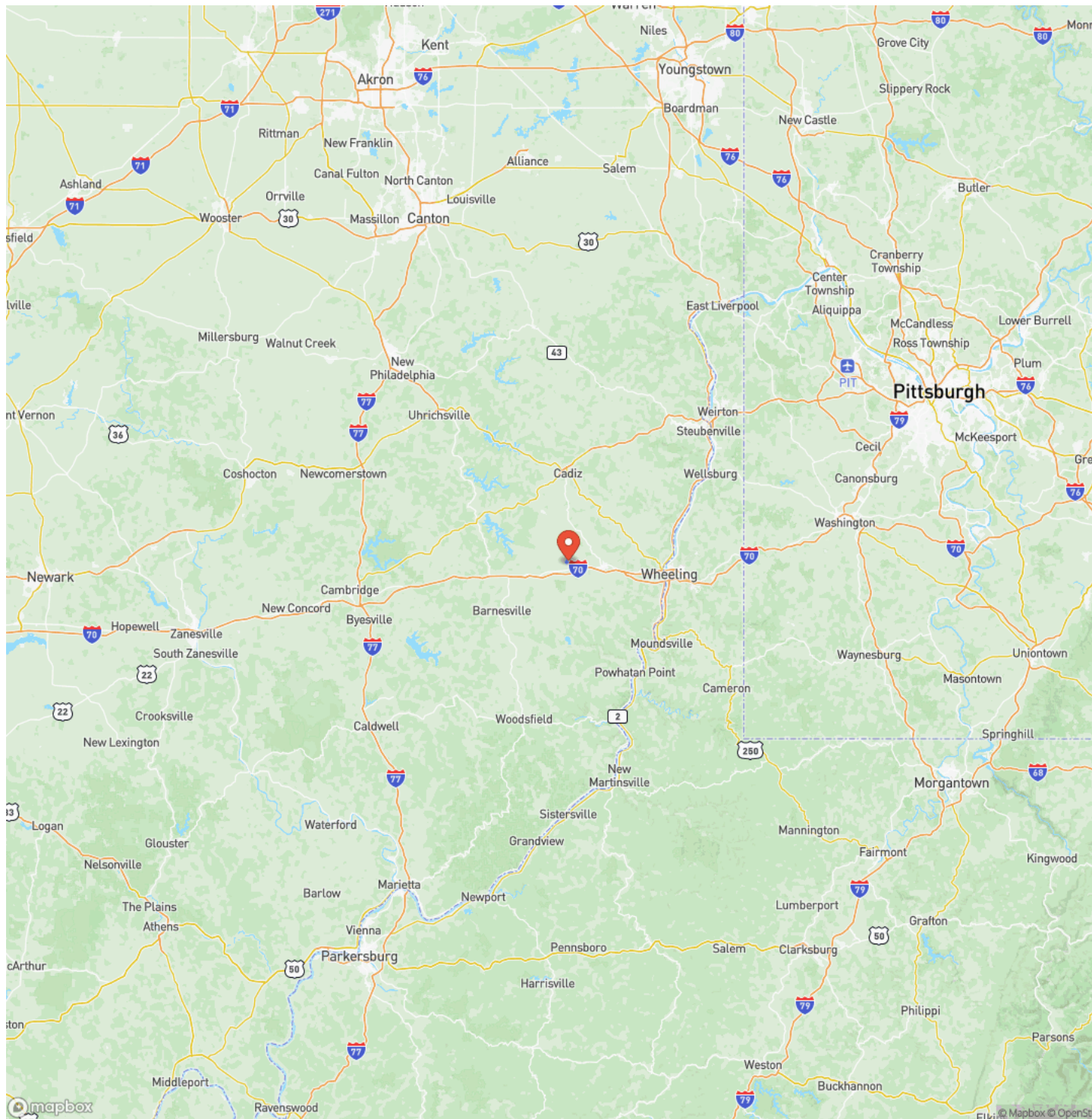


Locator Map
