The terrain is rolling to steep. The property is surrounded by larger wooded tracts and shows strong deer activity throughout. Timber was selectively harvested in 2021, creating additional cover and wildlife habitat.

County water and electric are available near the access point, making the property a potential cabin site or recreational retreat. Access is primarily from Ayers Boulevard off of State Route 7.

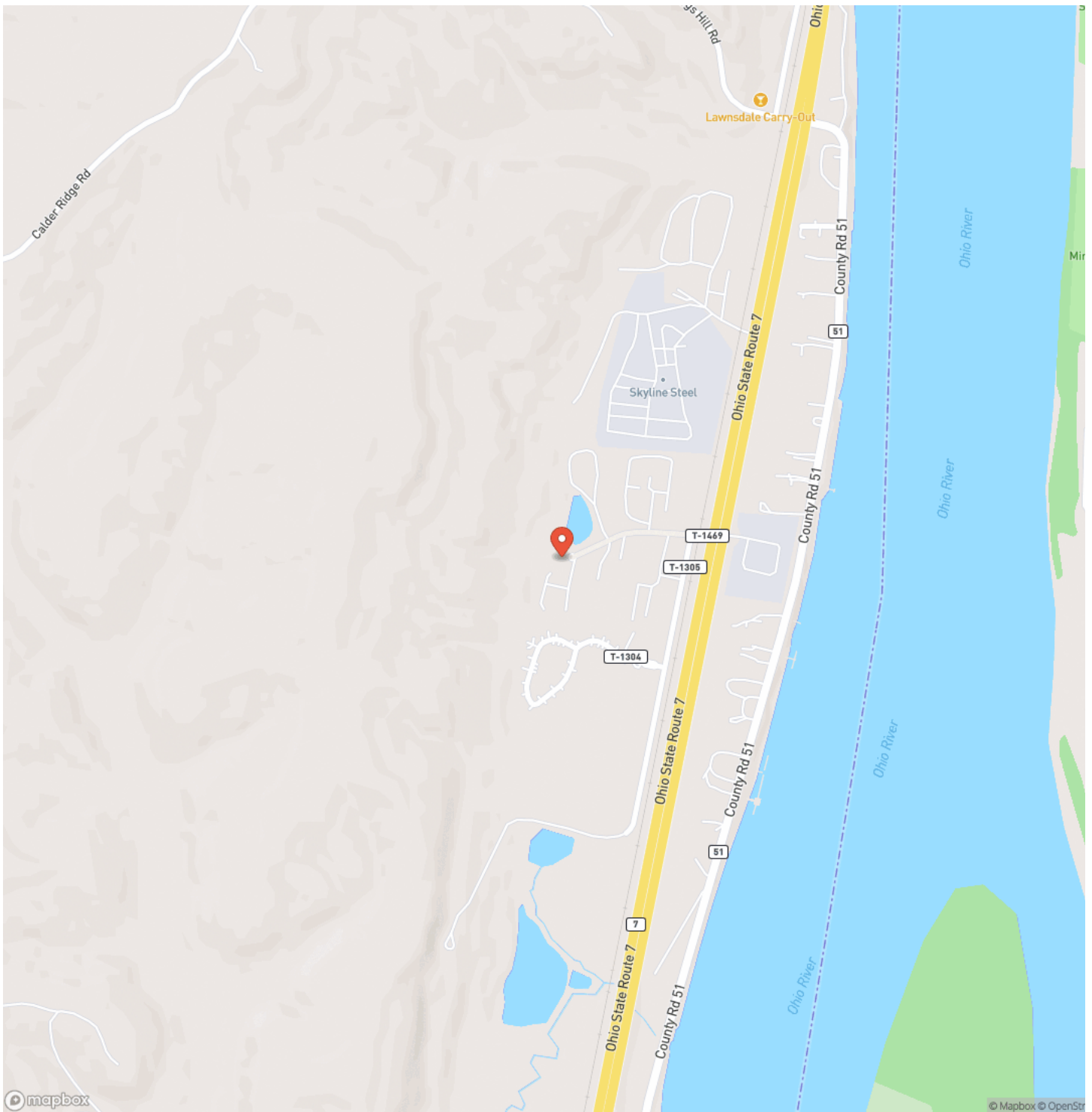

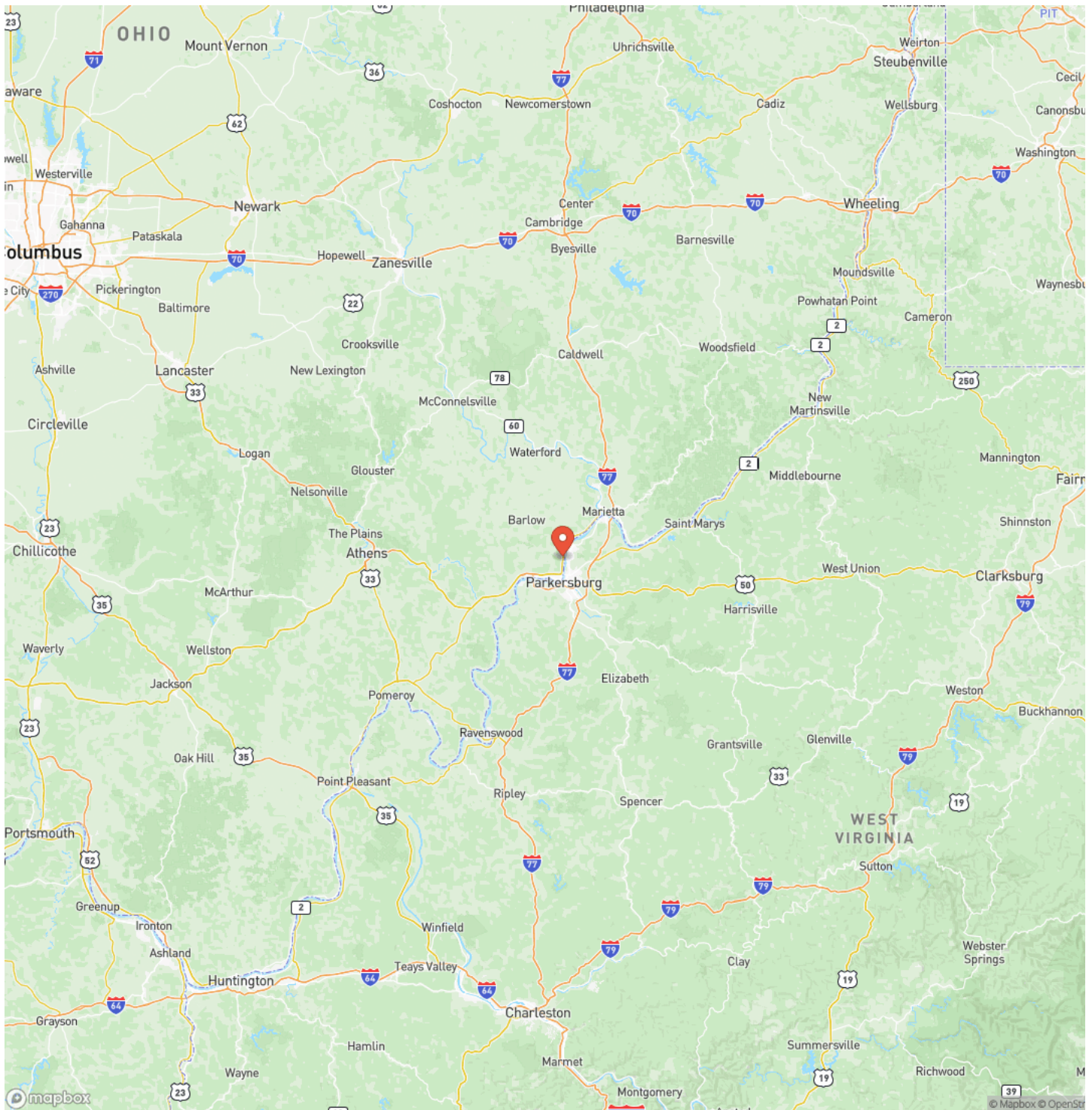

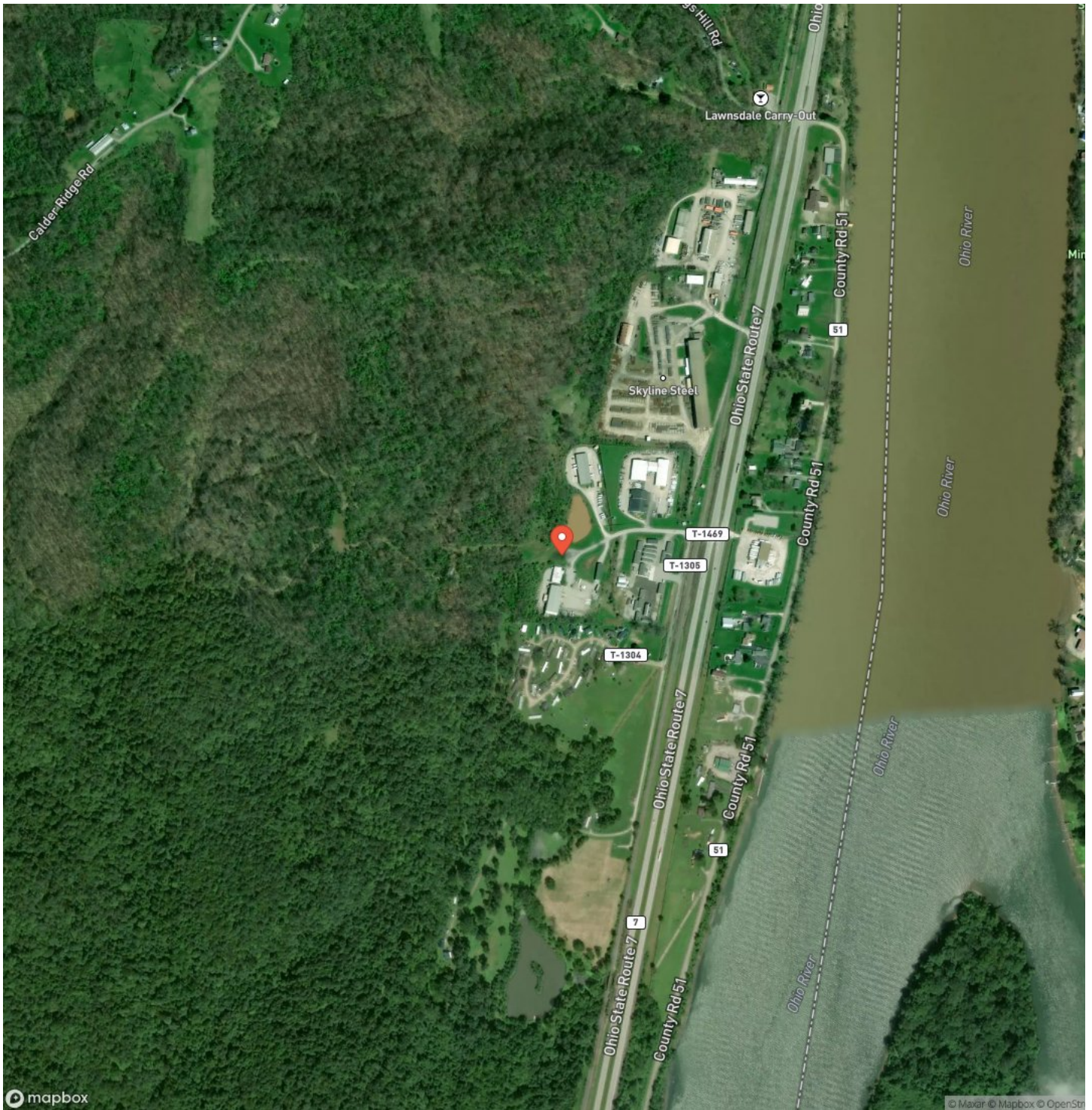
Locator Map
