PROPERTY DESCRIPTION

The Devils Gut encompasses 1,394 acres along US Highway 64, west of Jamesville in Martin County, NC. This sprawling property includes a 10,000-square-foot lodge featuring 16 bedrooms, 9.5 baths, a spacious kitchen with a bar, and a dining area that comfortably seats twenty people, making it ideal for conferences. Additionally, the lodge offers a lounge area on each floor, with the main lounge boasting a large fireplace, a locker room with 22 lockers, and a laundry room. The estate also includes two barns, a river shelter with a dock, a shed equipped with commercial sinks, and a walk-in cooler. The tract offers approximately 3 miles of frontage along the Roanoke River and 2.7 miles along Gardner Creek. The Devils Gut is perfectly situated for a timber investment with a rich wildlife habitat.

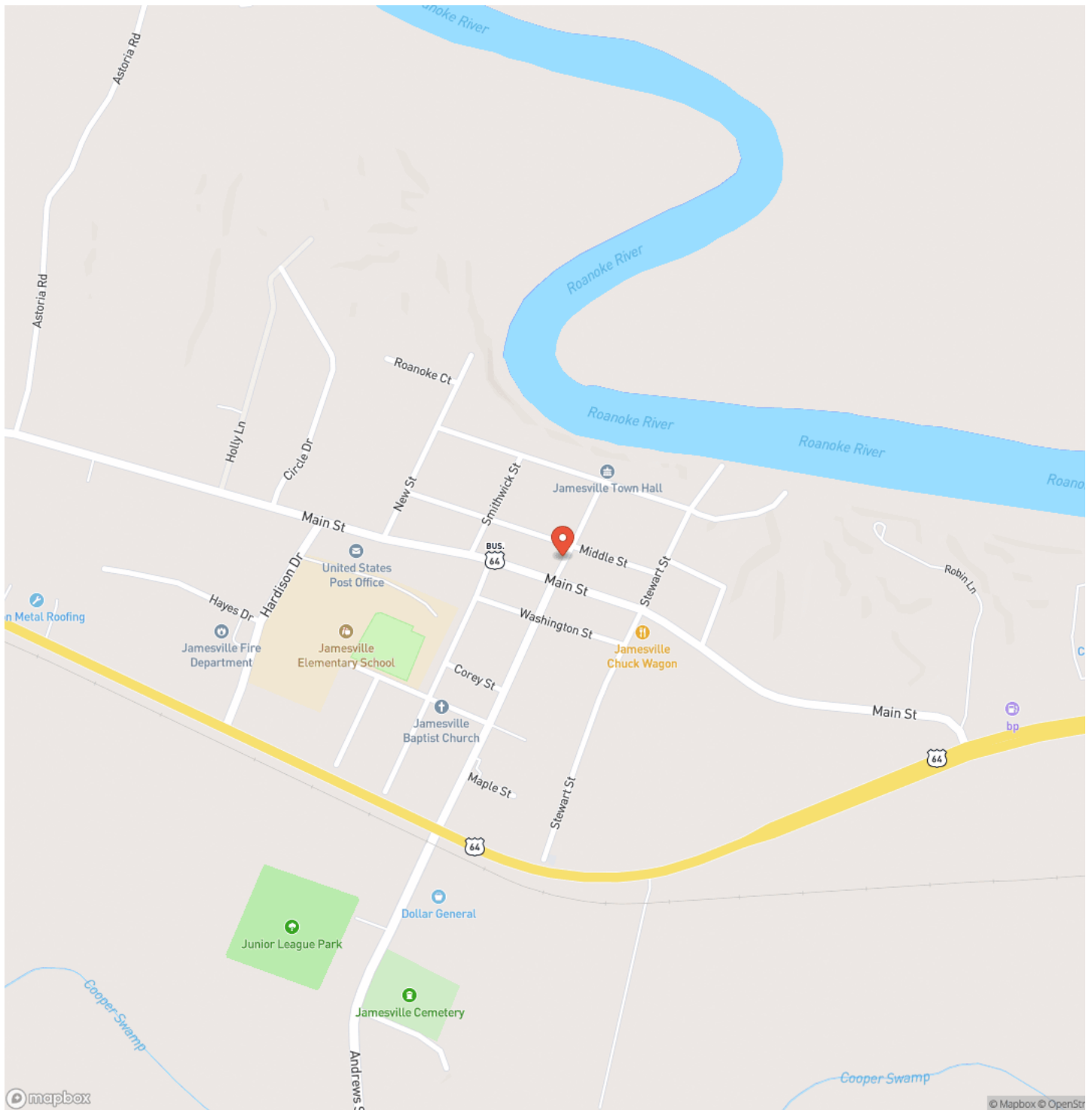
The timber on the property consists of:

- 31 acres of 1995 planted Loblolly pine

- 42 acres of mature pine/cypress
- 15 acres of 2003 planted long leaf pine
- 125 acres of mixed pine and hardwoods in a conservation easement

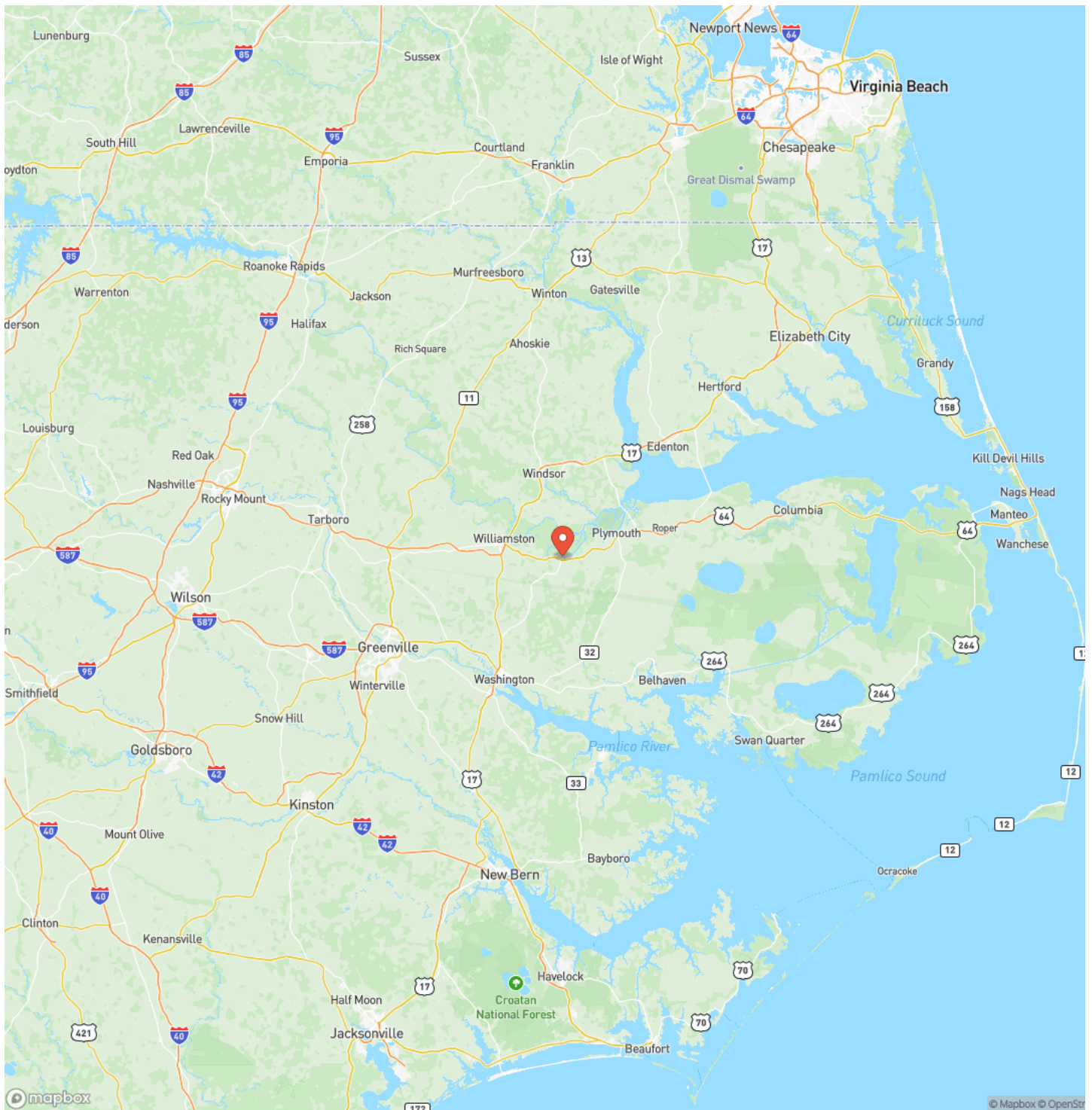
