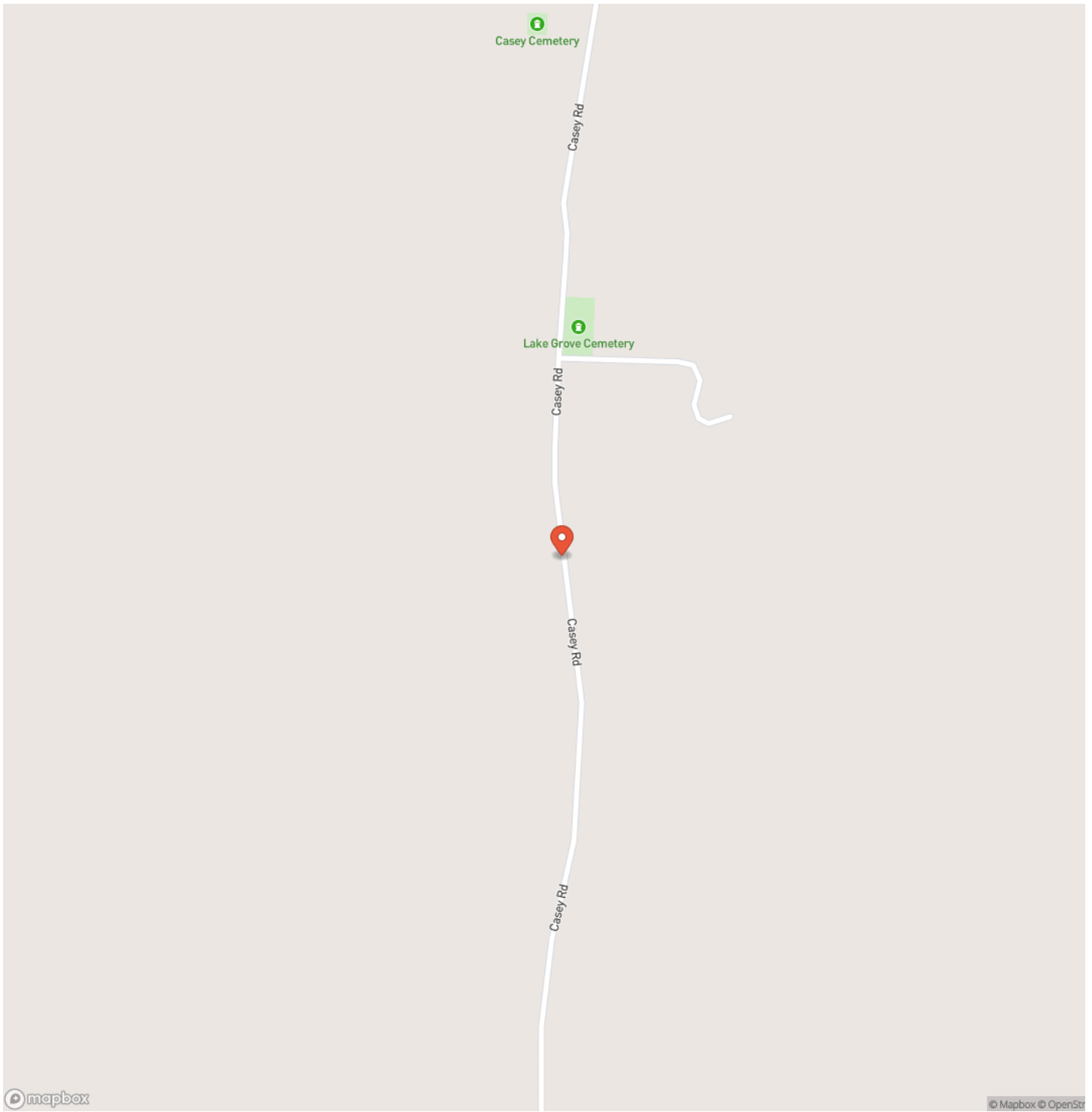

Located in a great waterfowl flyway in Woodruff County, AR, this property has Buzzard Lake and Bayou Deview going thru it.

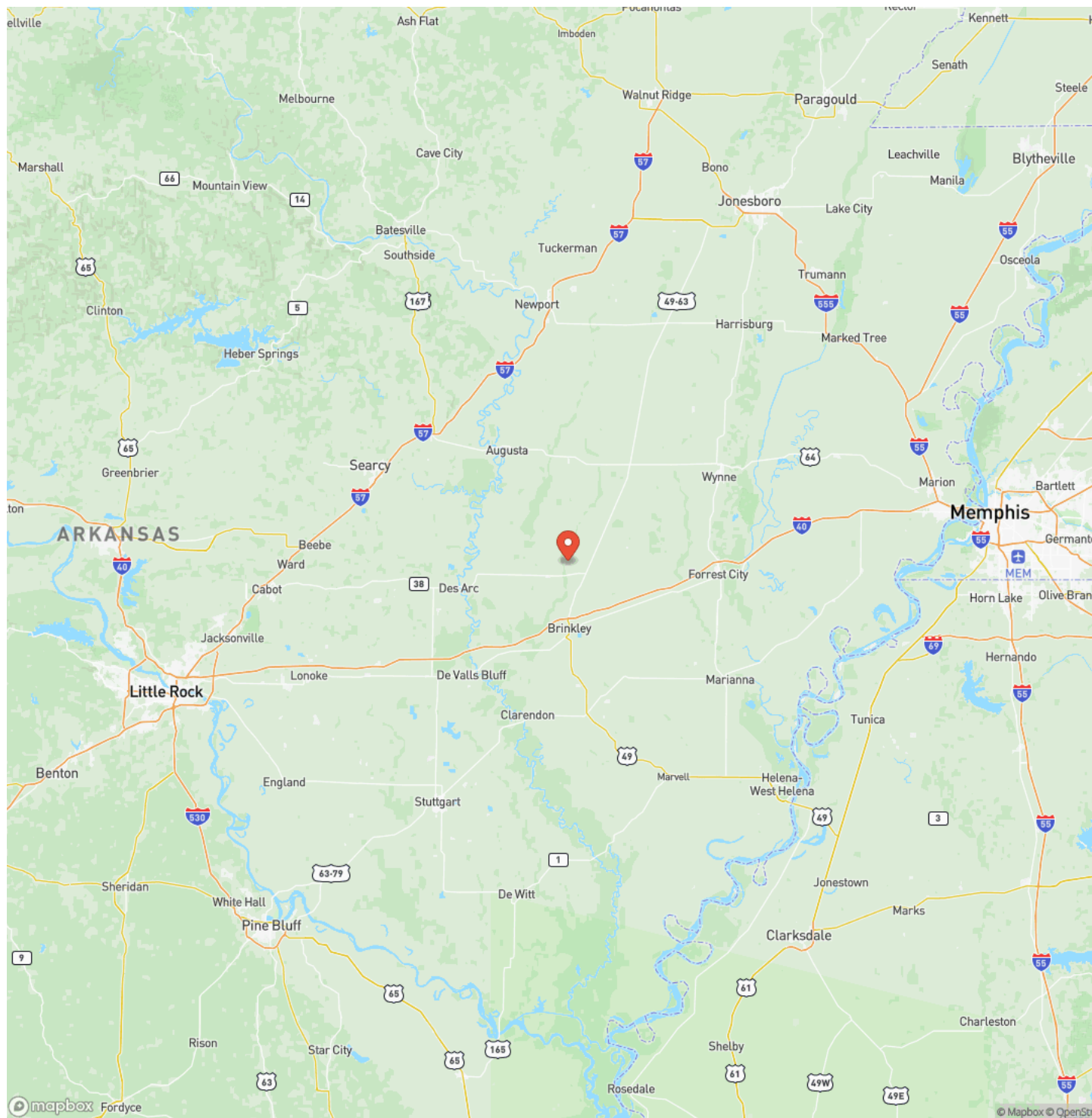
