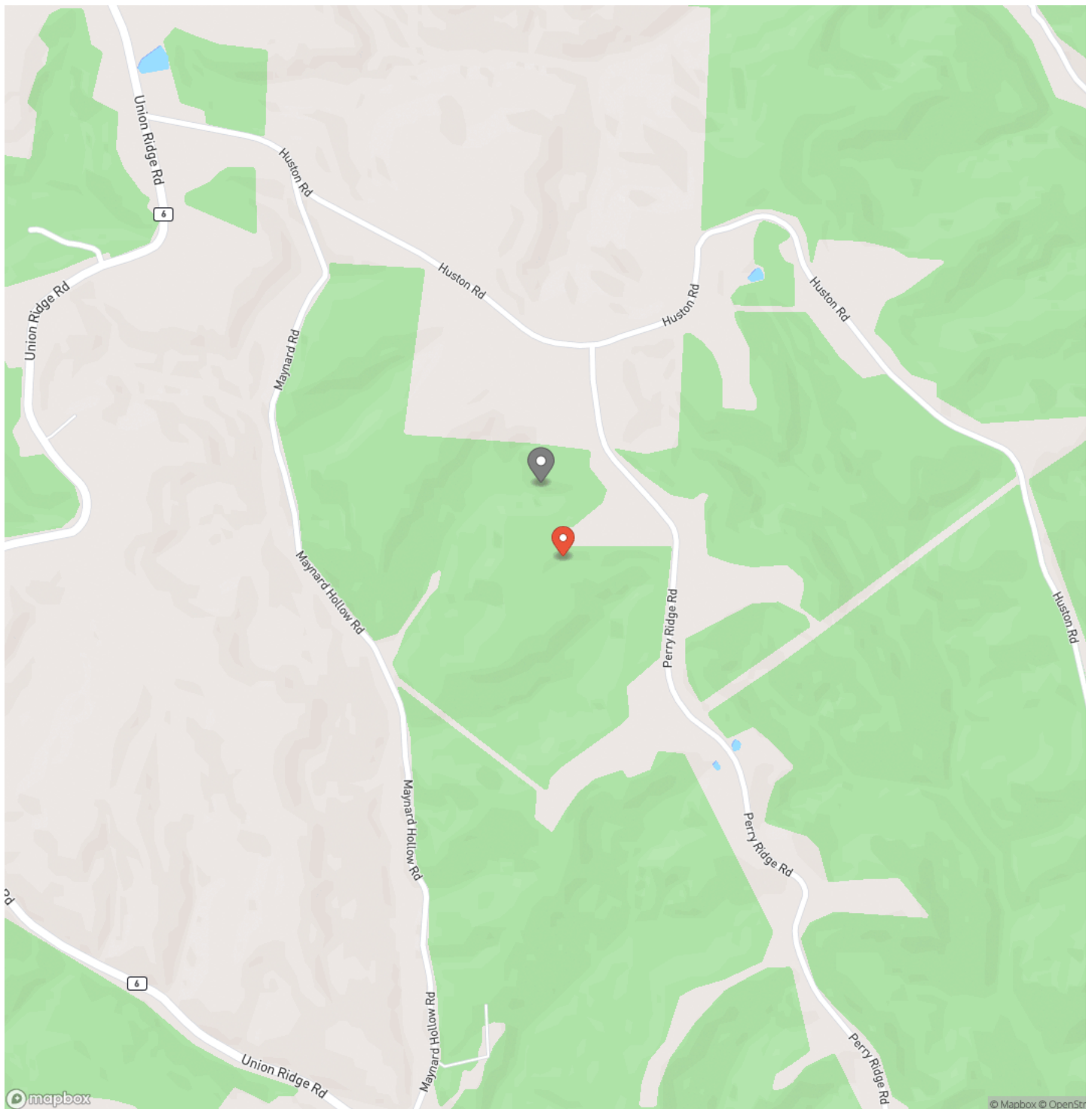
PROPERTY DESCRIPTION

Soil testing has already been completed for a septic system. The land features some mature timber along with rolling terrain and a ravine. The area is home to a diverse range of wildlife, including deer and turkey, making it a solid option for hunting or recreation. Located 1 hour and 44 minutes from Columbus, 28 minutes from Athens, and 30 minutes from Jackson, the property is easily accessible while still feeling tucked away. This 10-acre tract will be split from a larger parcel with a new survey to be completed if sold separately. An additional 28 acres is also available. Seller states they do not own the mineral rights. Annual taxes to be determined after a new survey is completed.

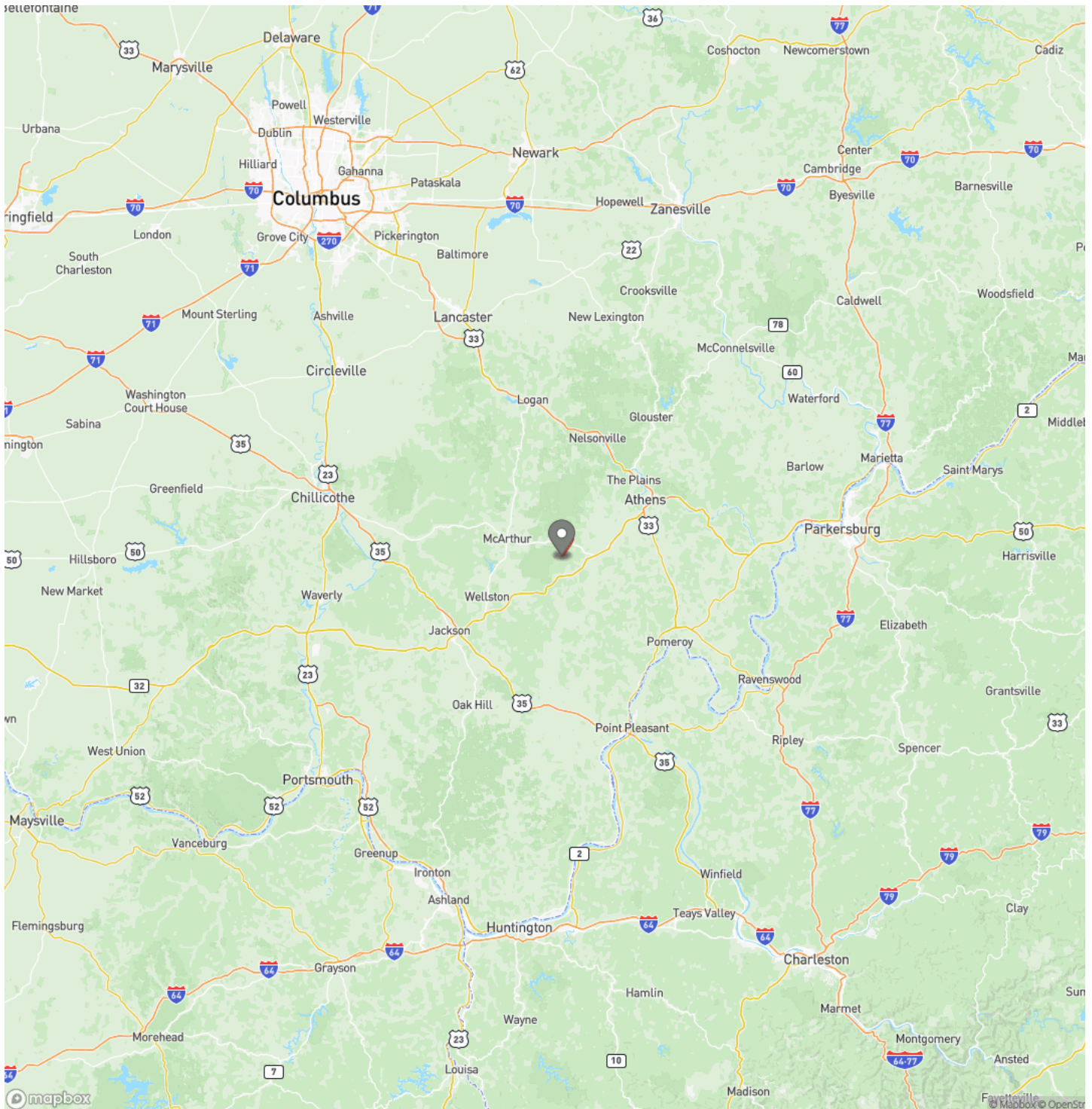
