- Ridge top view overlooking Chesapeake, Ohio

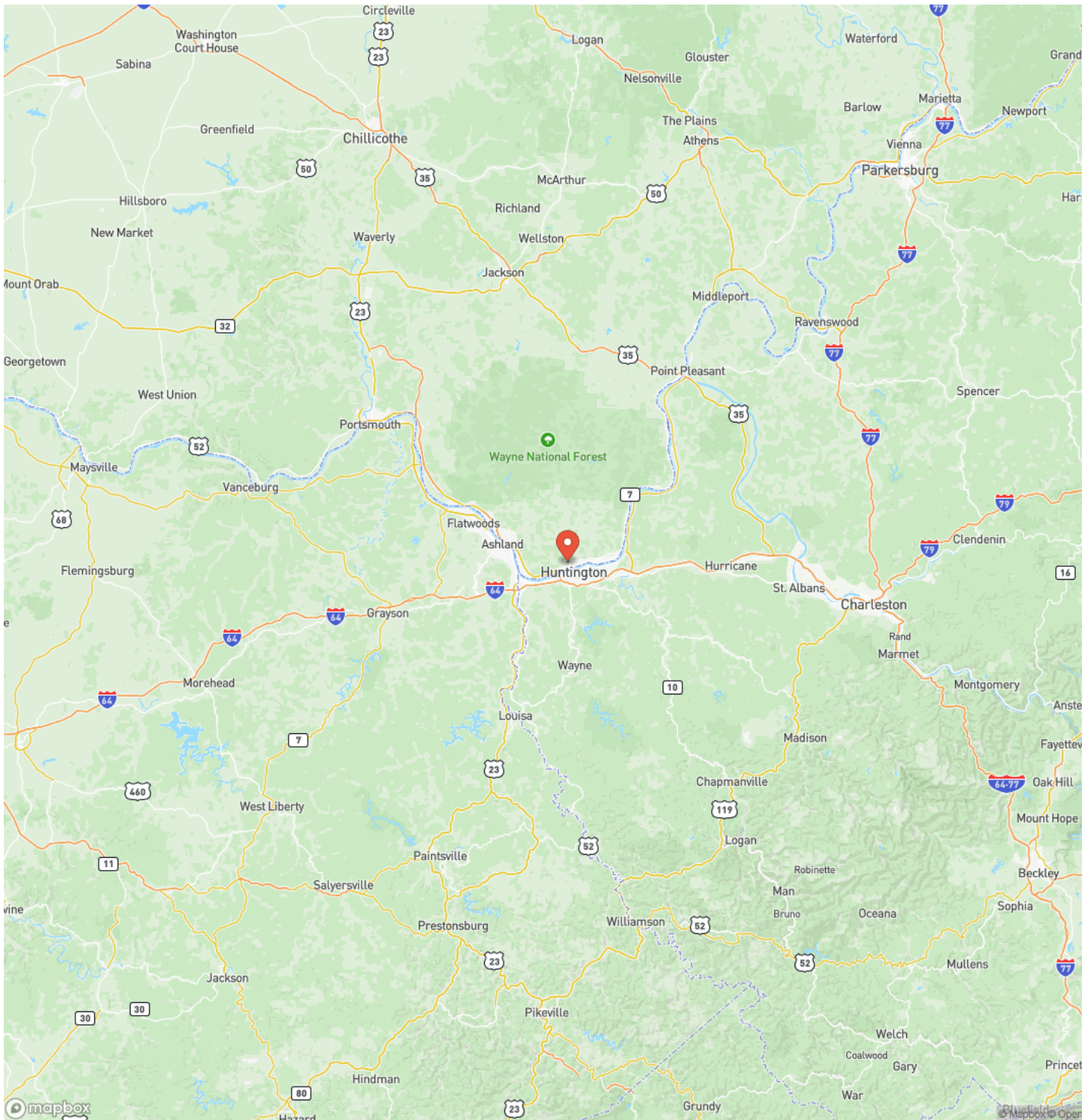

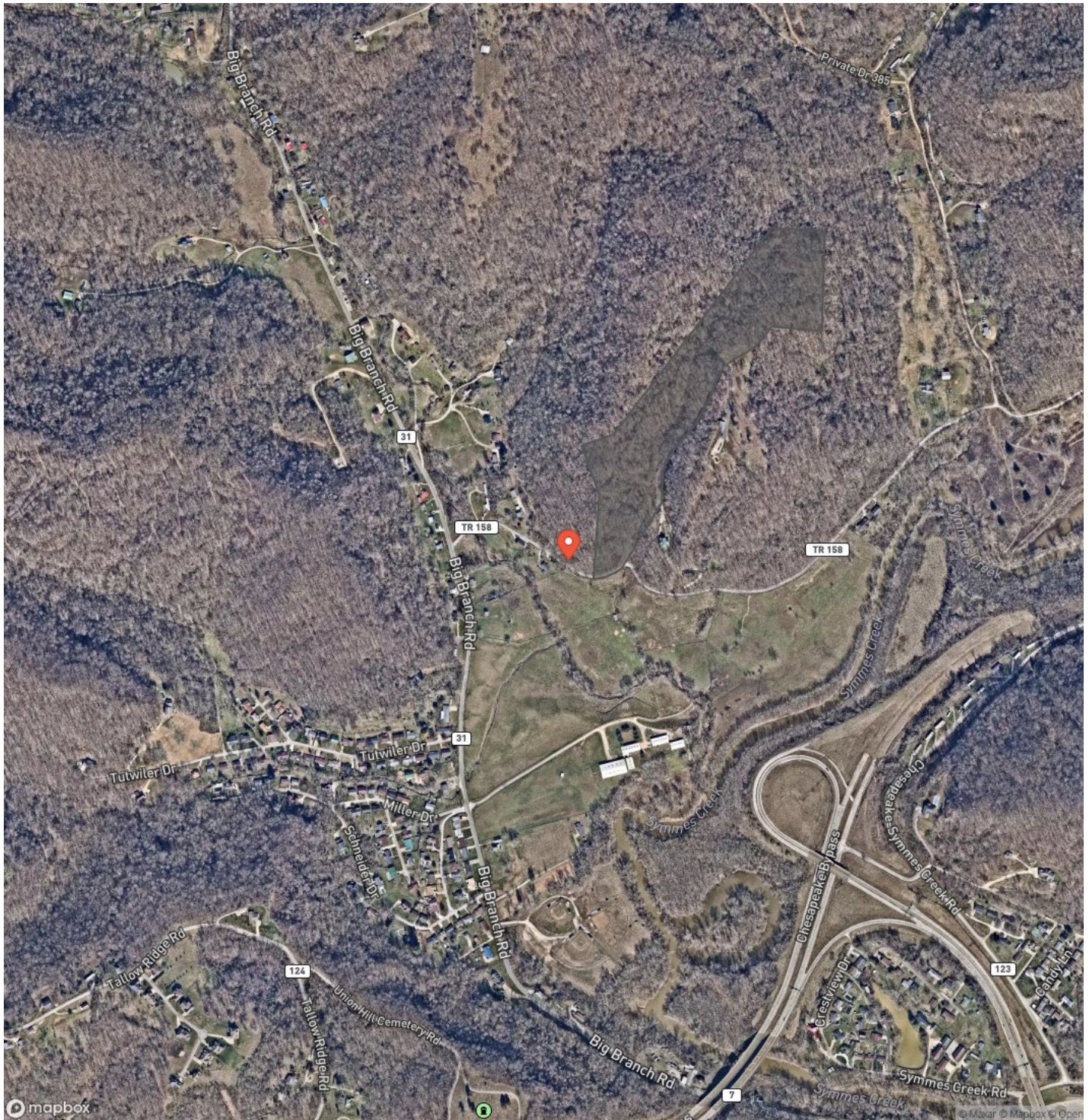
Locator Map
