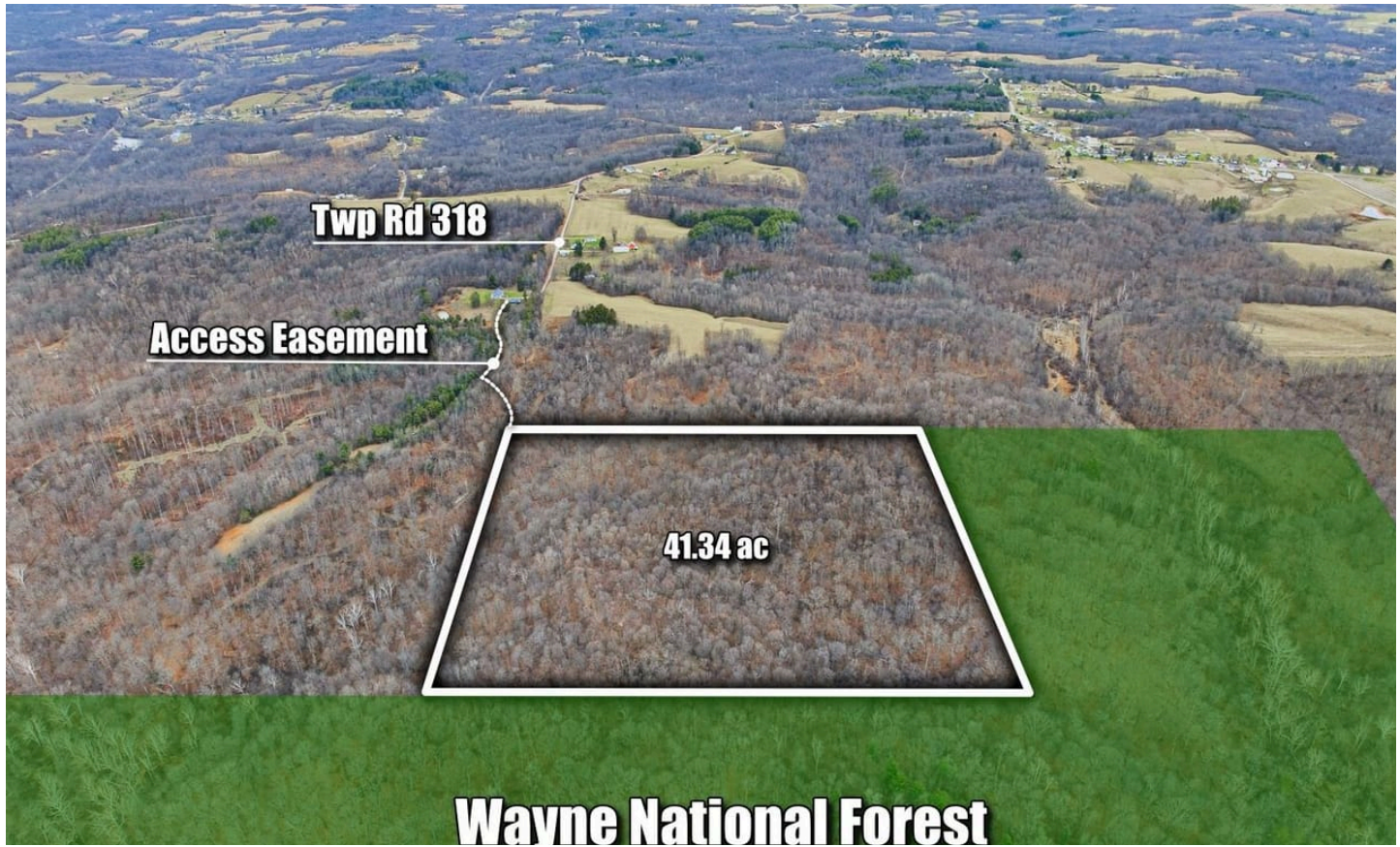

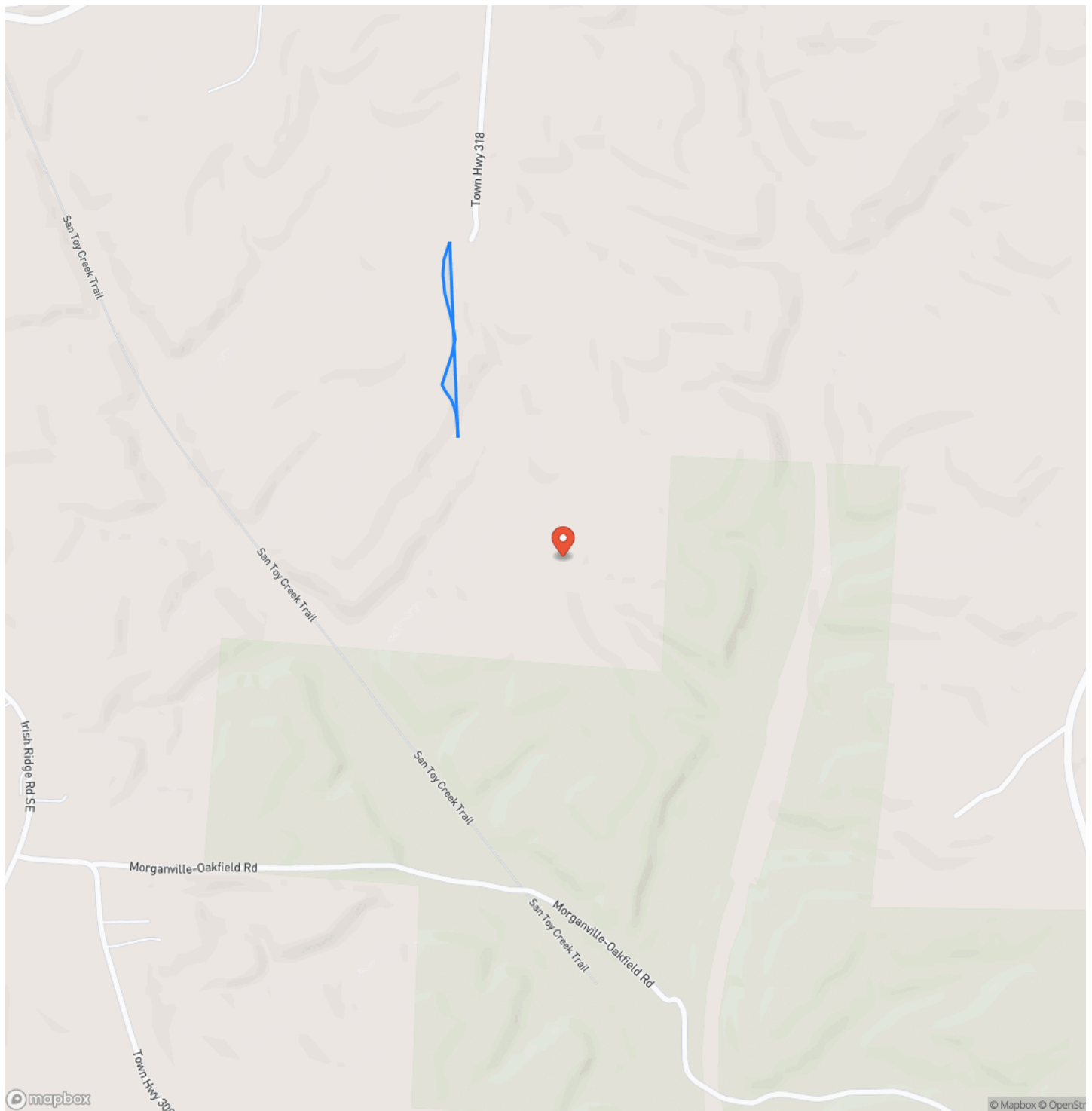
PROPERTY DESCRIPTION

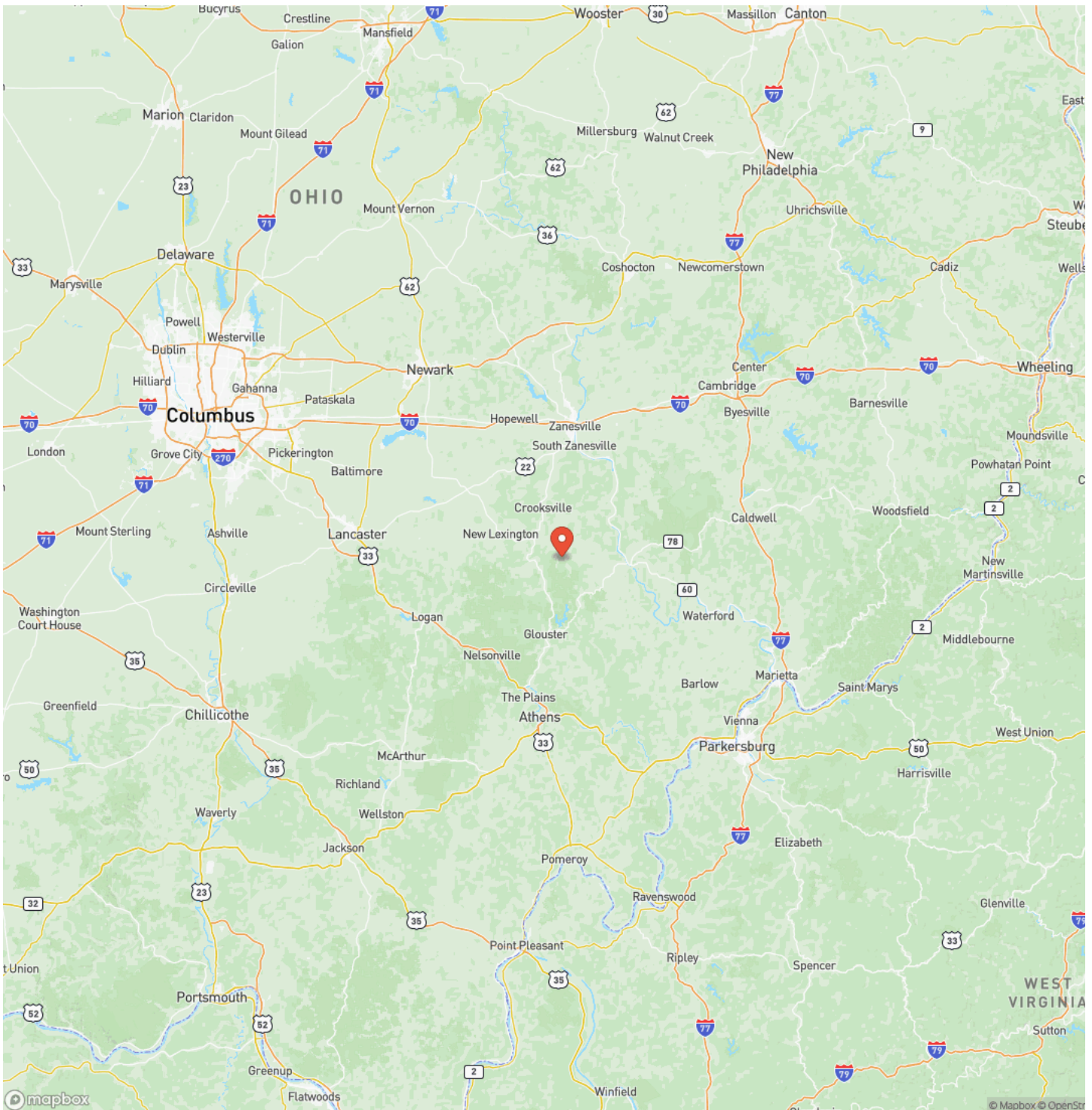

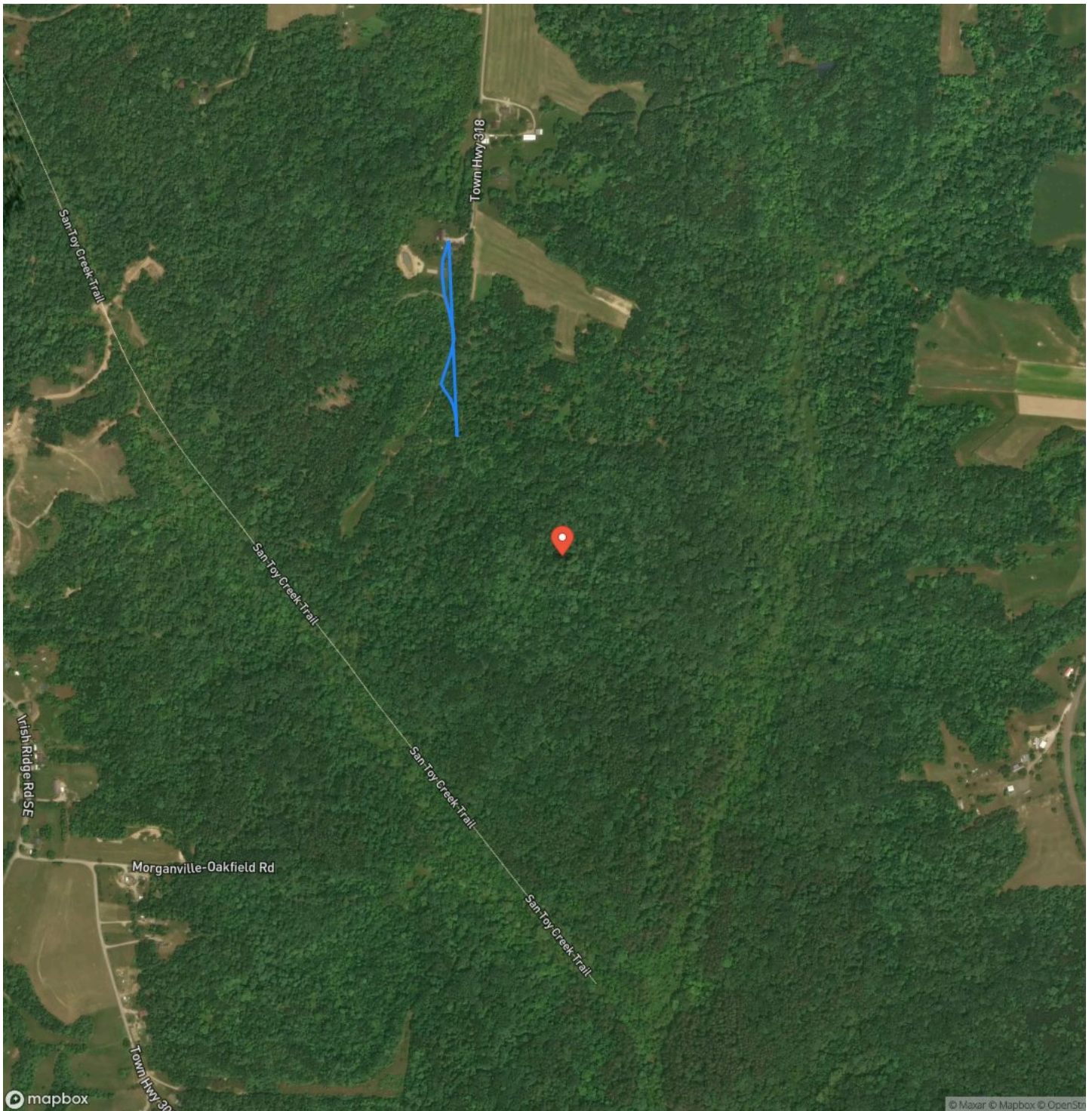
Locator Map
