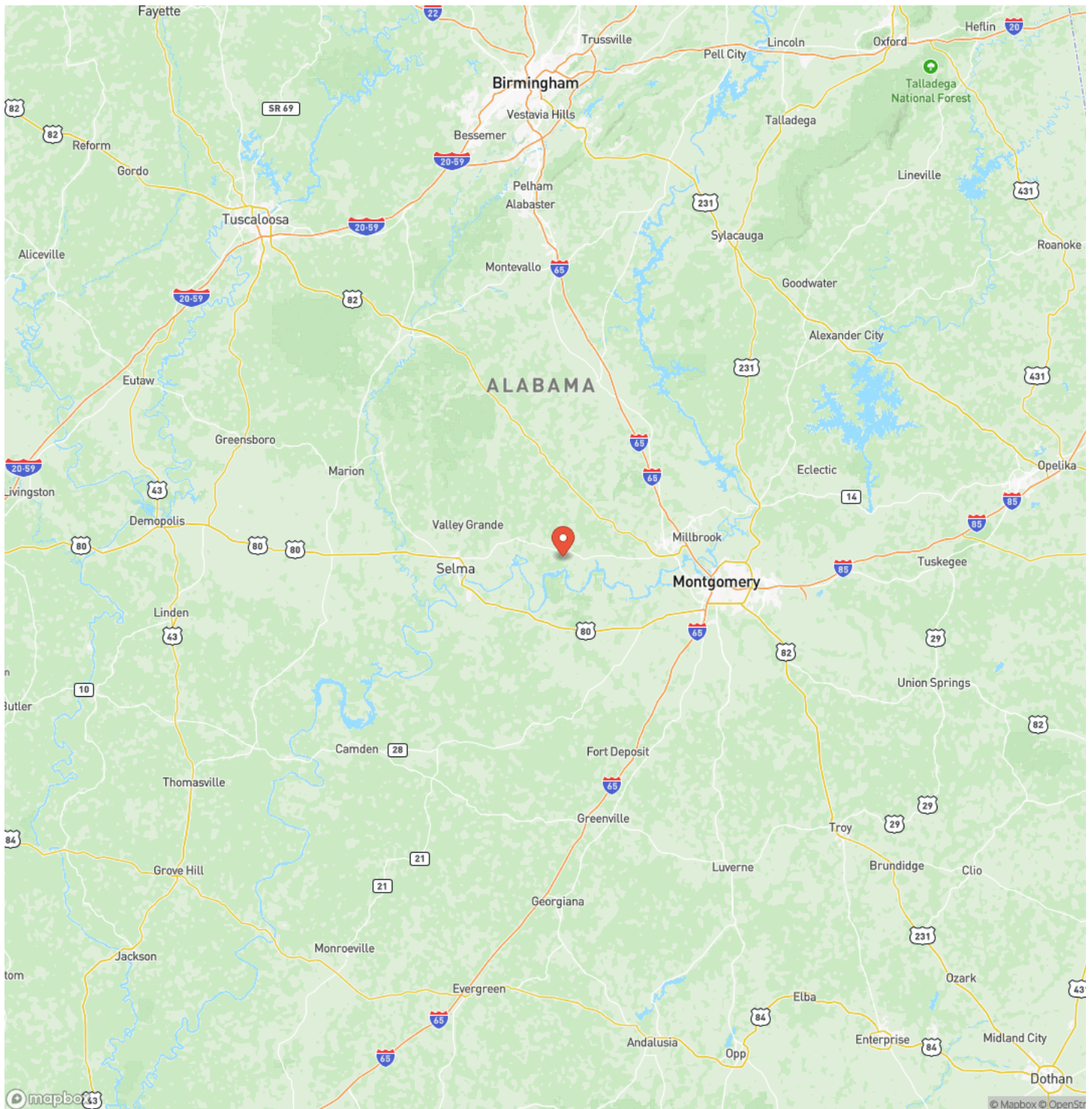


Locator Map
