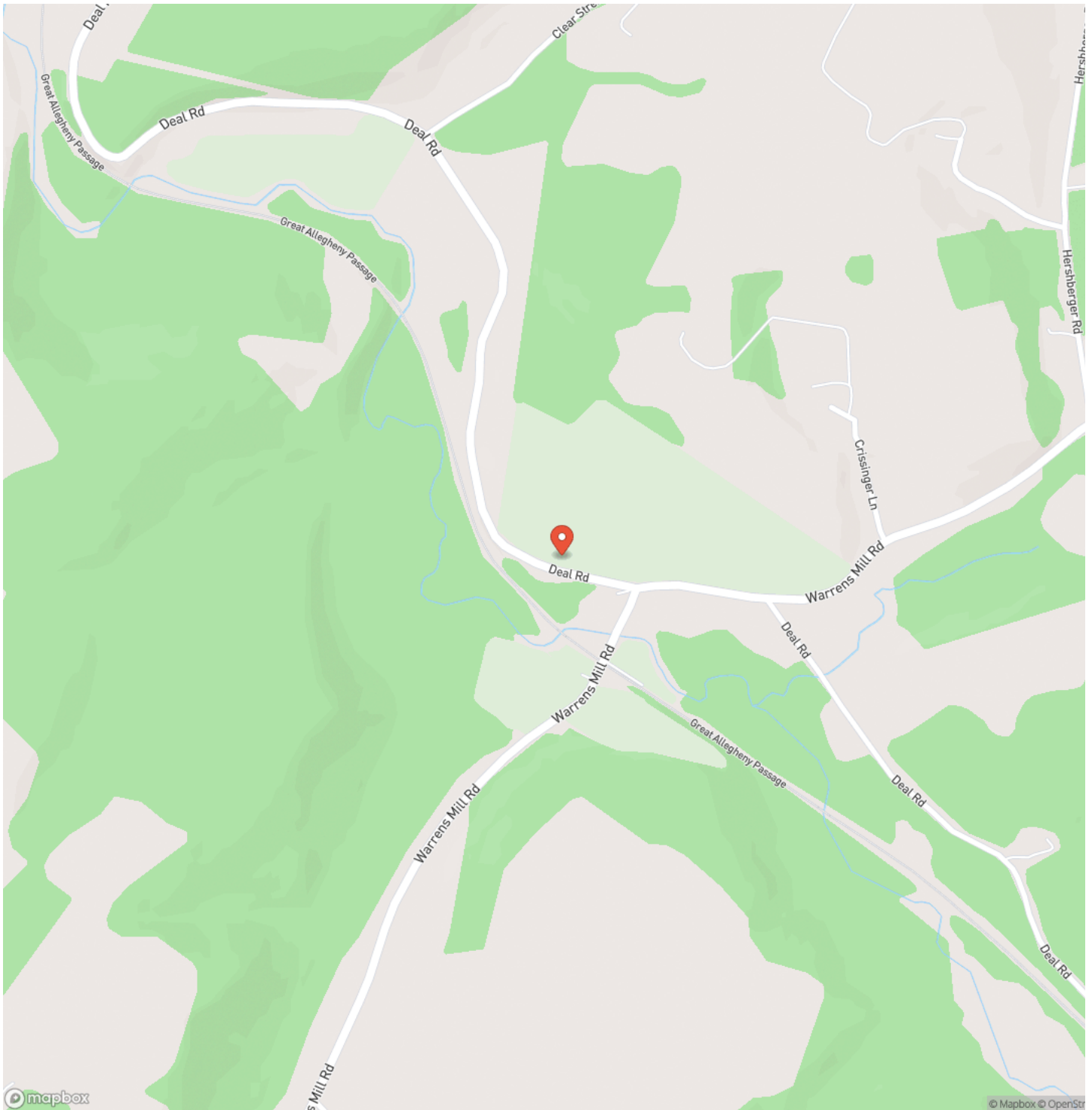

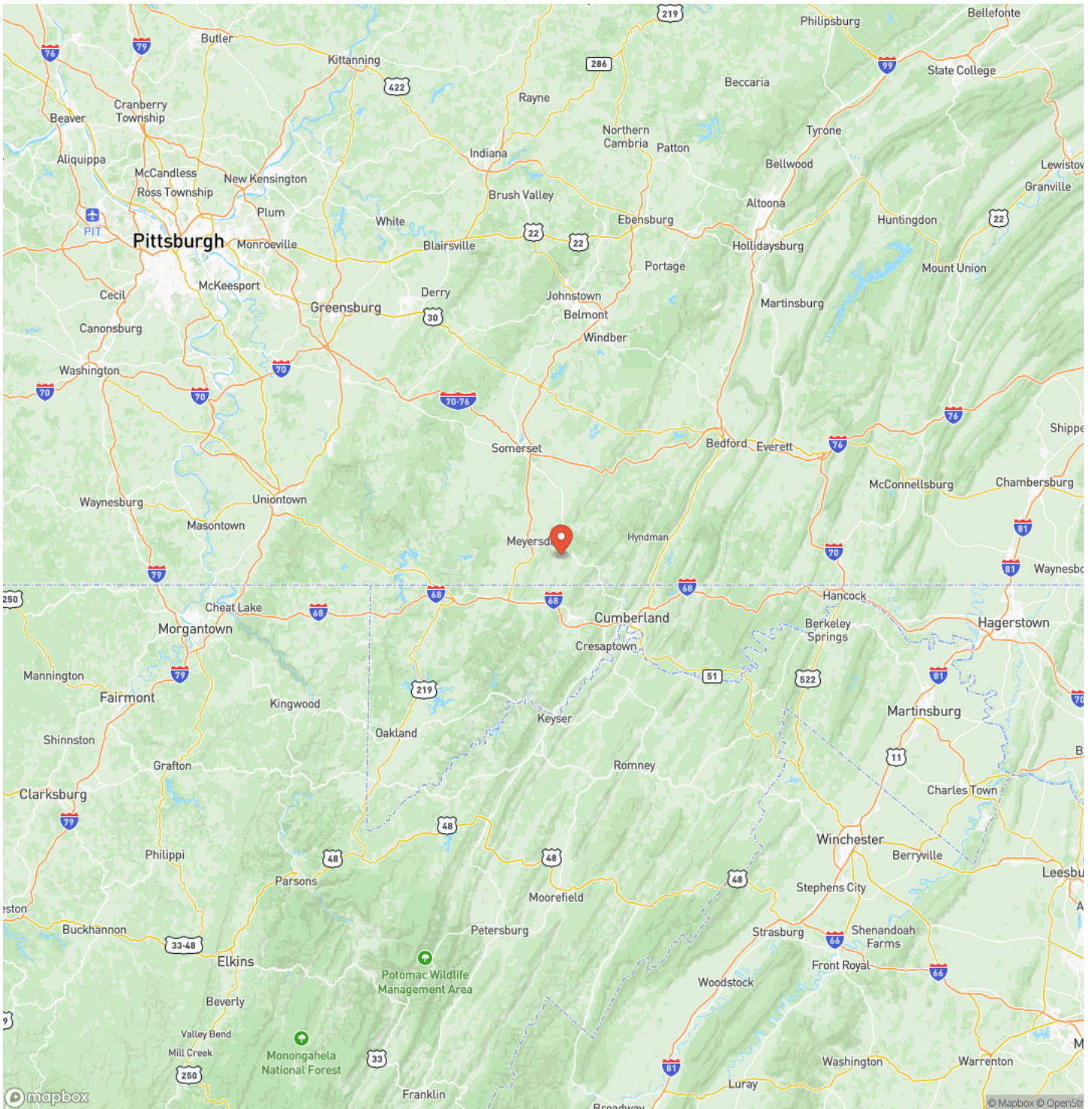


Locator Map
