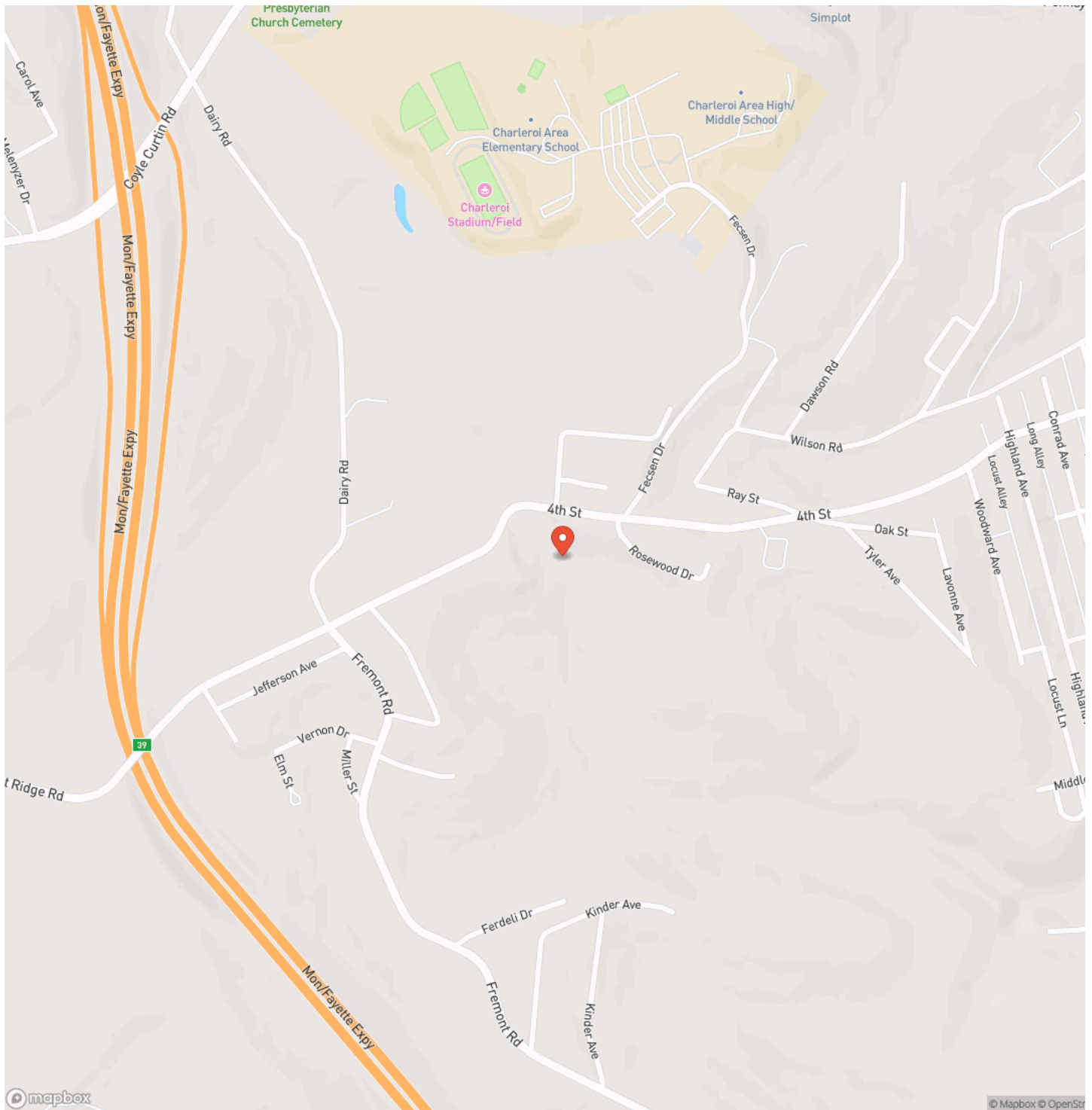

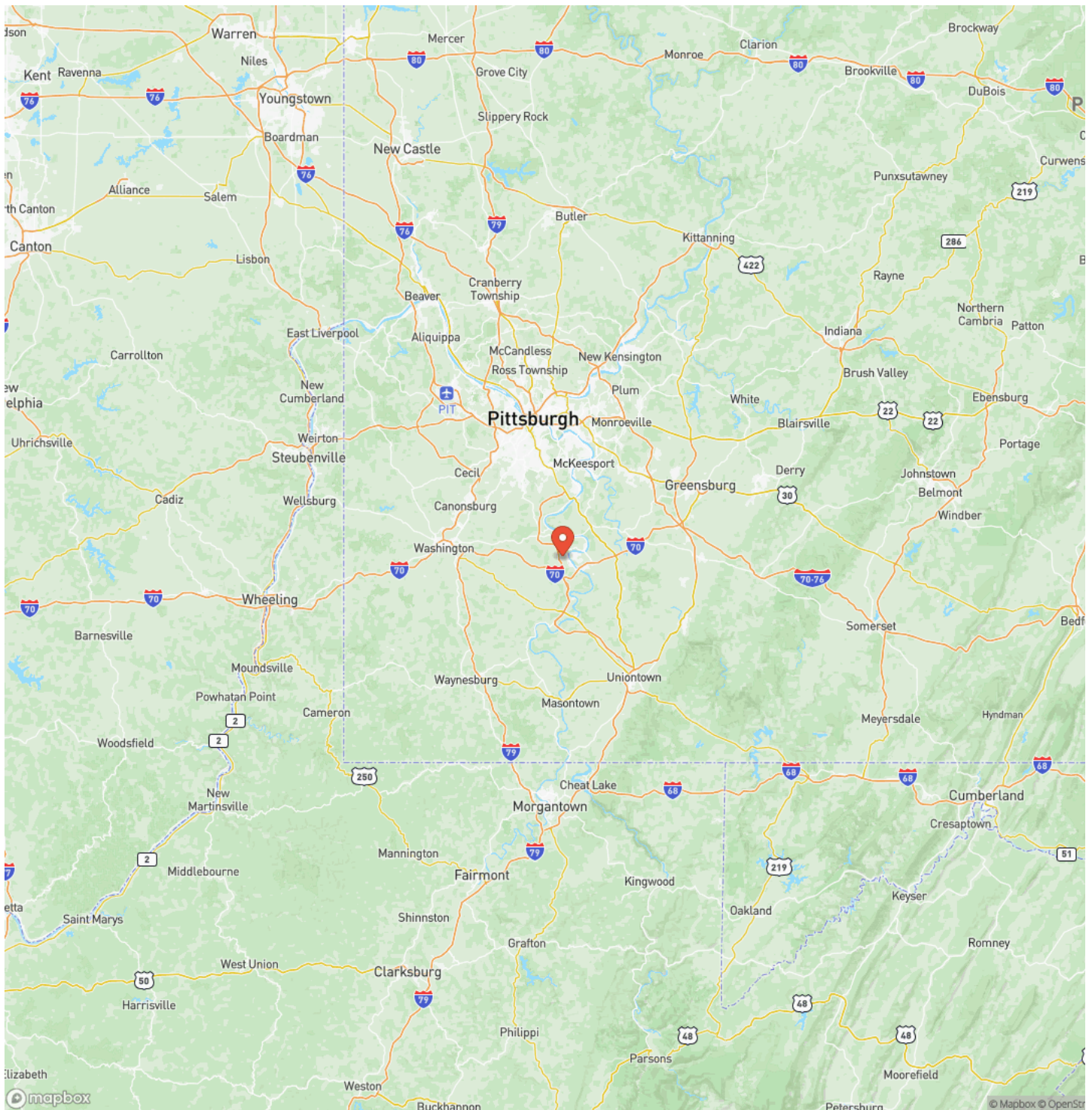

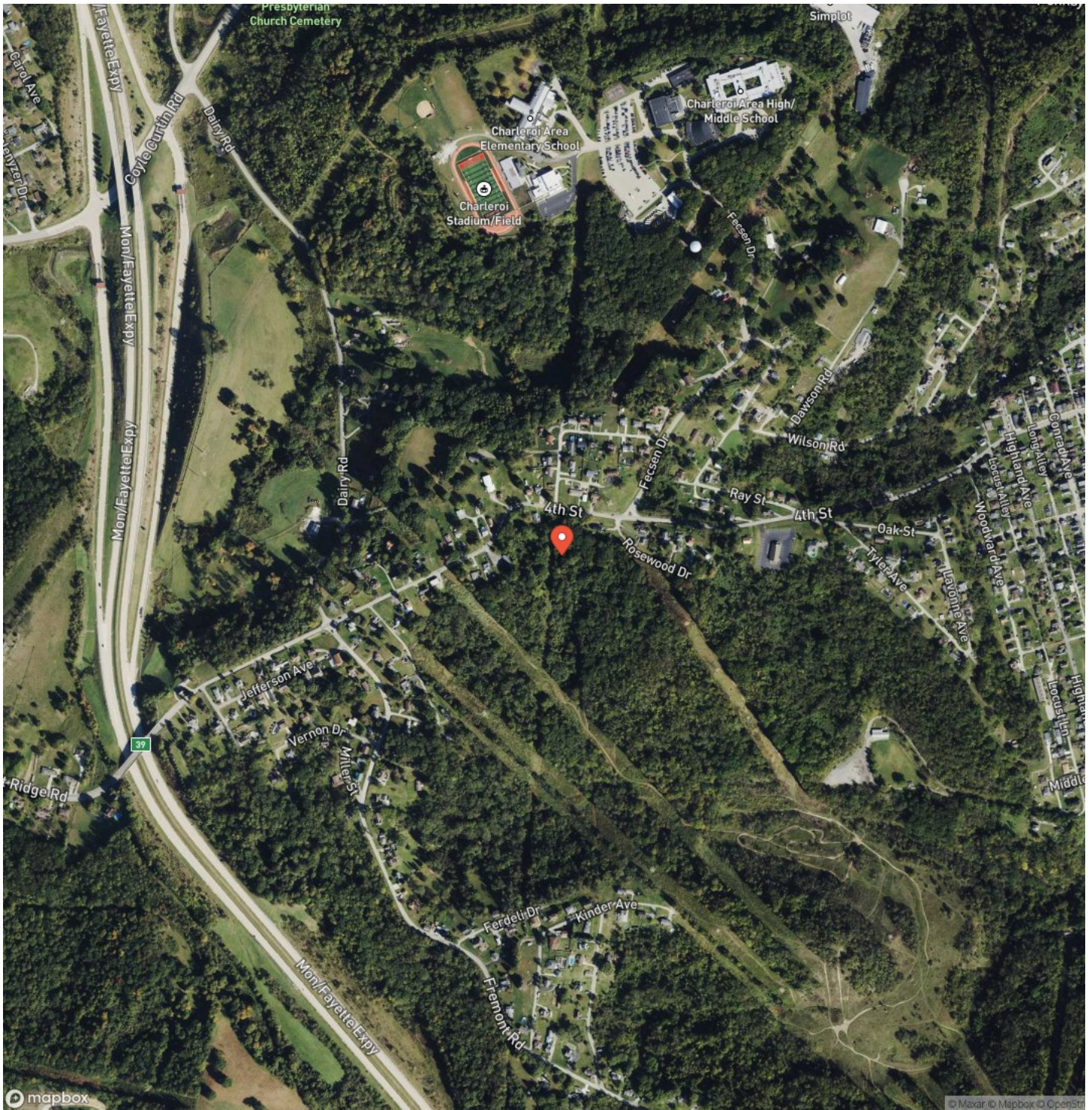
Locator Map
