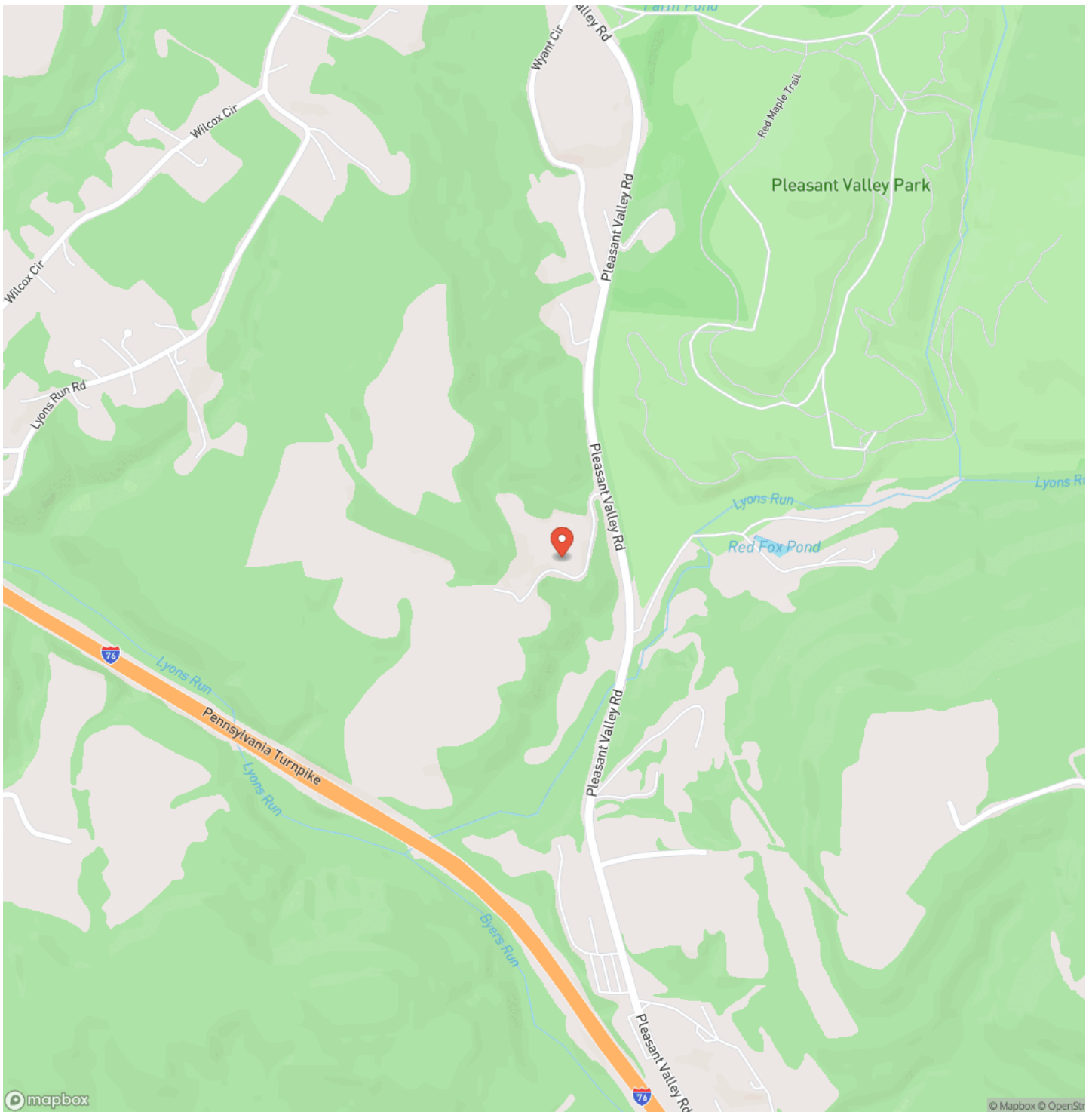

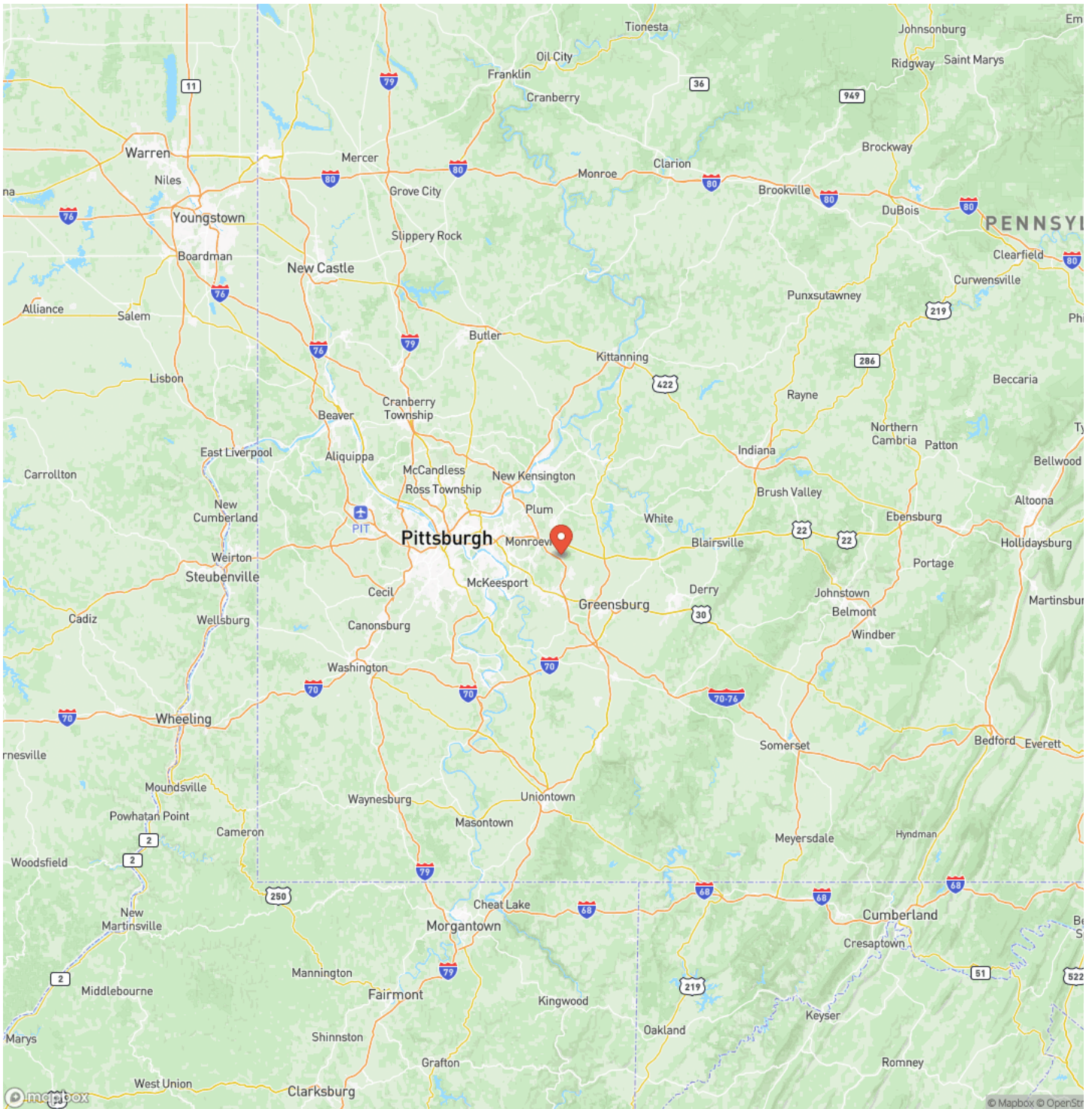


Locator Map
