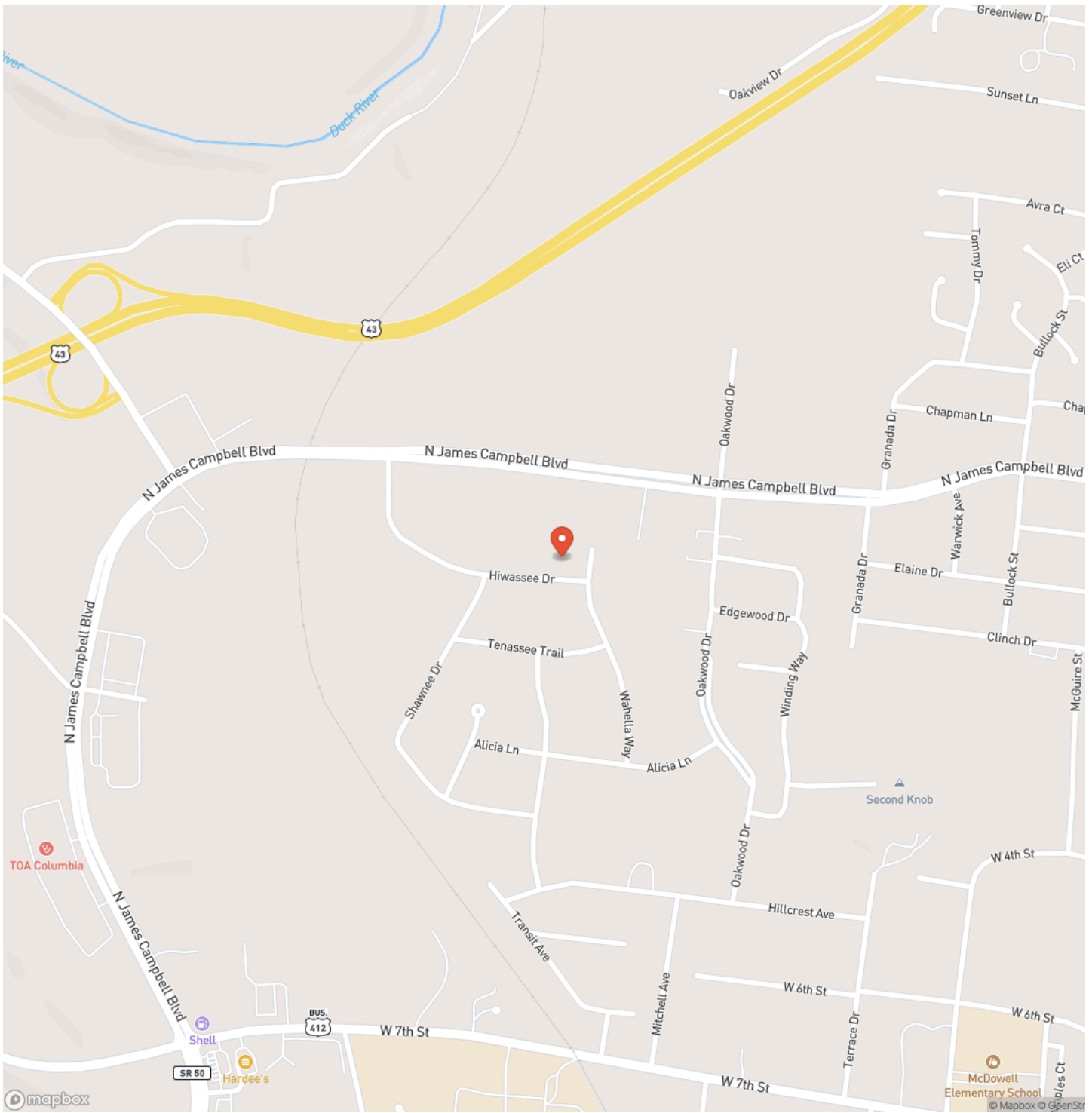

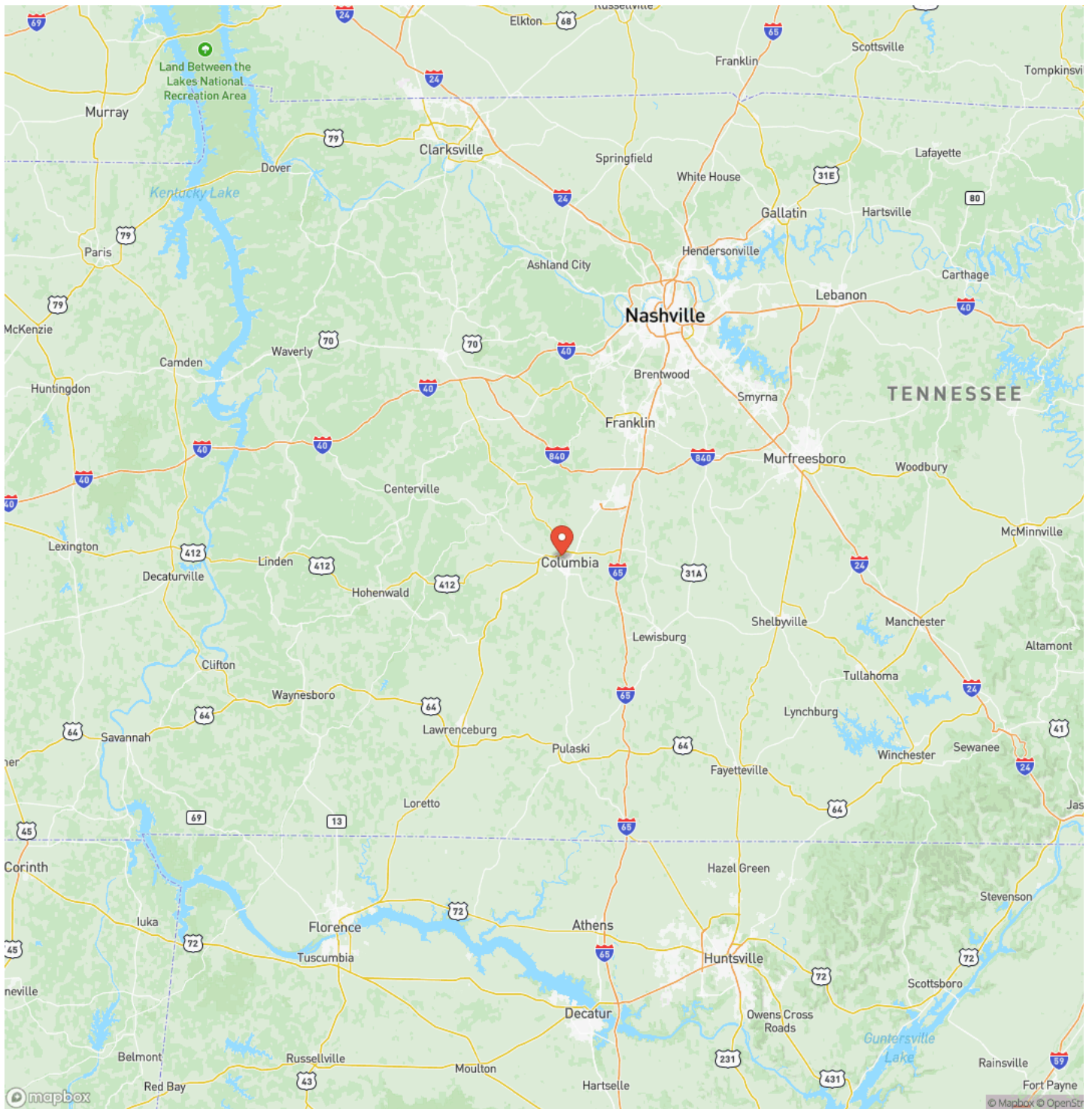
Locator Map



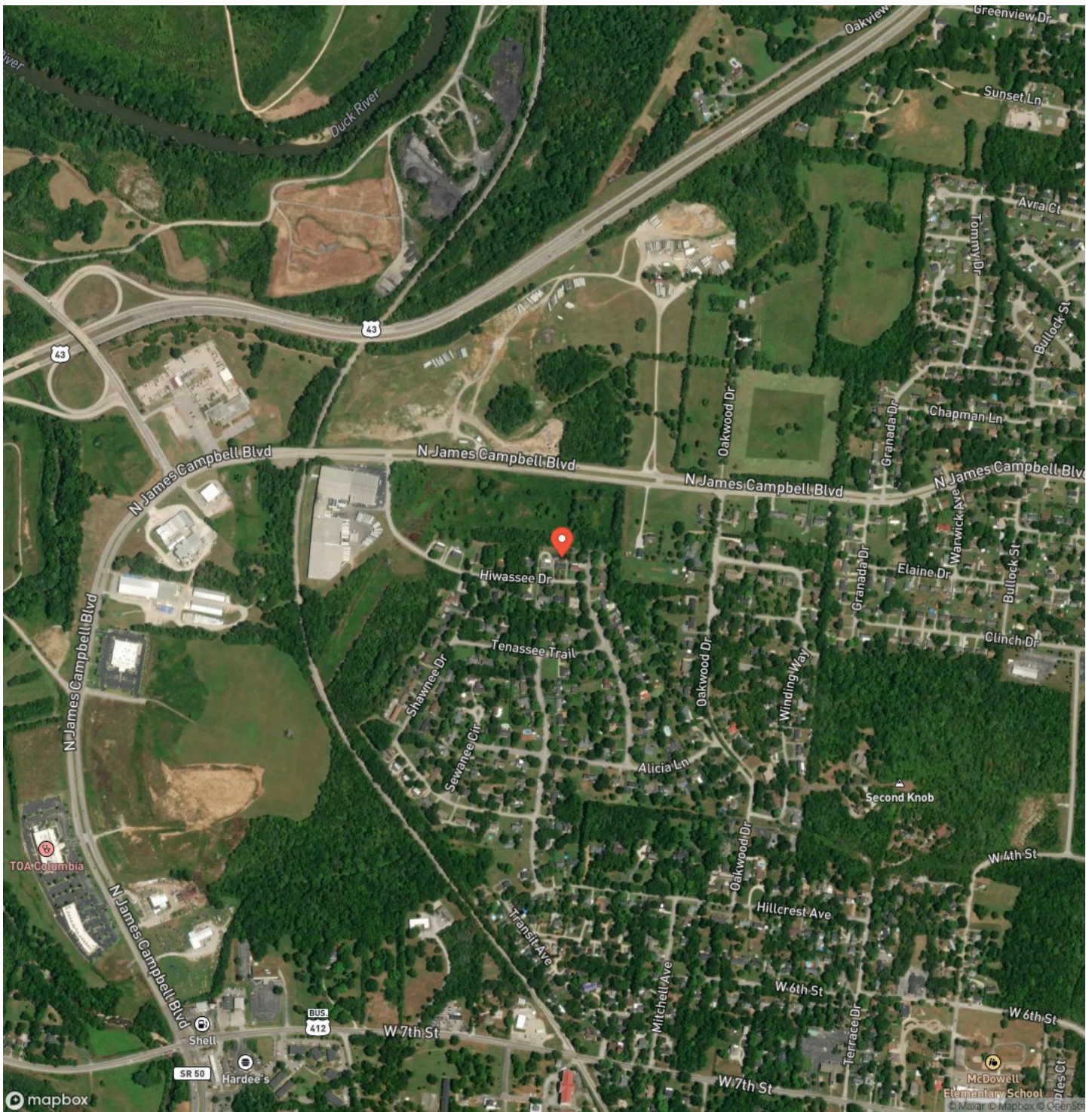
