PROPERTY DESCRIPTION

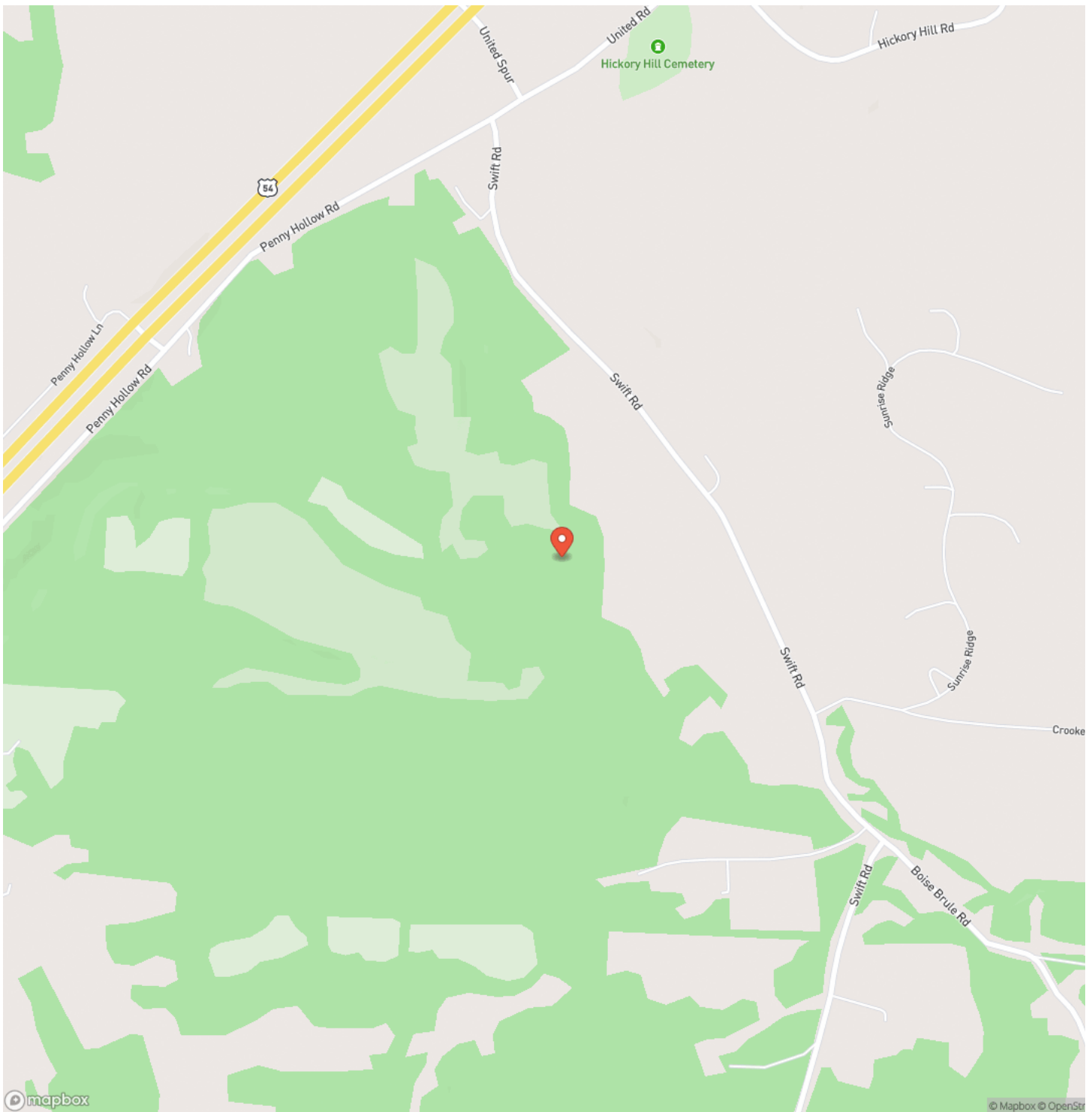
Just outside Jefferson City in Central Missouri, this 107-acre tract is a great opportunity for the outdoor enthusiast. With about 95% wooded cover, the property is full of wildlife and offers excellent hunting for deer, turkey, and more. The land features a mix of natural terrain with existing trails and paths that provide access throughout the property - ideal for ATVs, hiking, or horseback riding. A wet-weather creek and three small ponds add to the recreational appeal and enhance the habitat. Formerly known as the Hickory Hill Landfill which was open during the 1970s, the property does come with some restrictions, but it remains a prime spot for hunting, recreation, and enjoying the outdoors. Limited building opportunities exist along the outer edges, with electric service available along Swift Road. Centrally located between Jefferson City and Lake of the Ozarks, with quick access to Highway 54, this unique tract combines size, location, and recreational value at an affordable price.



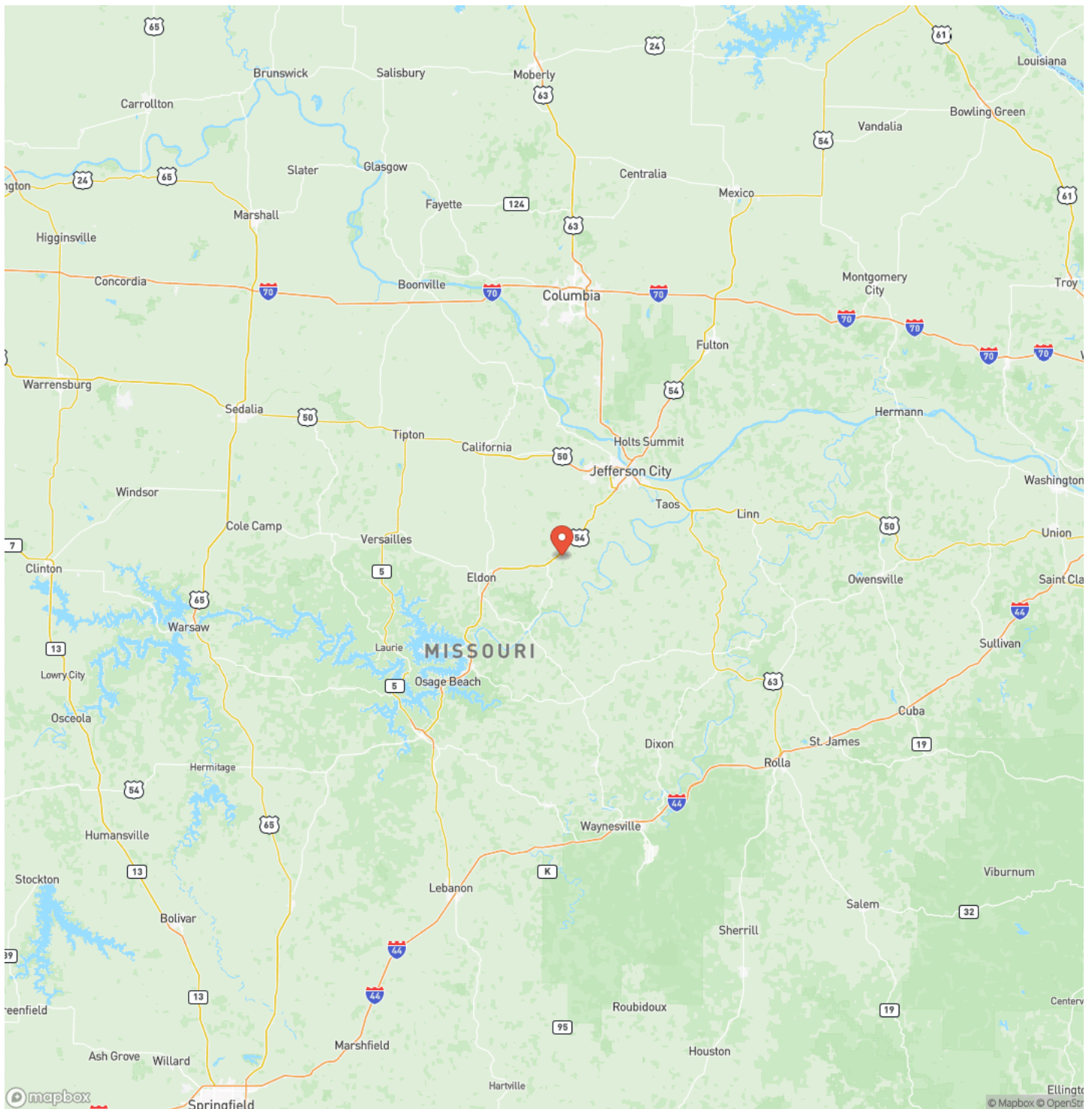

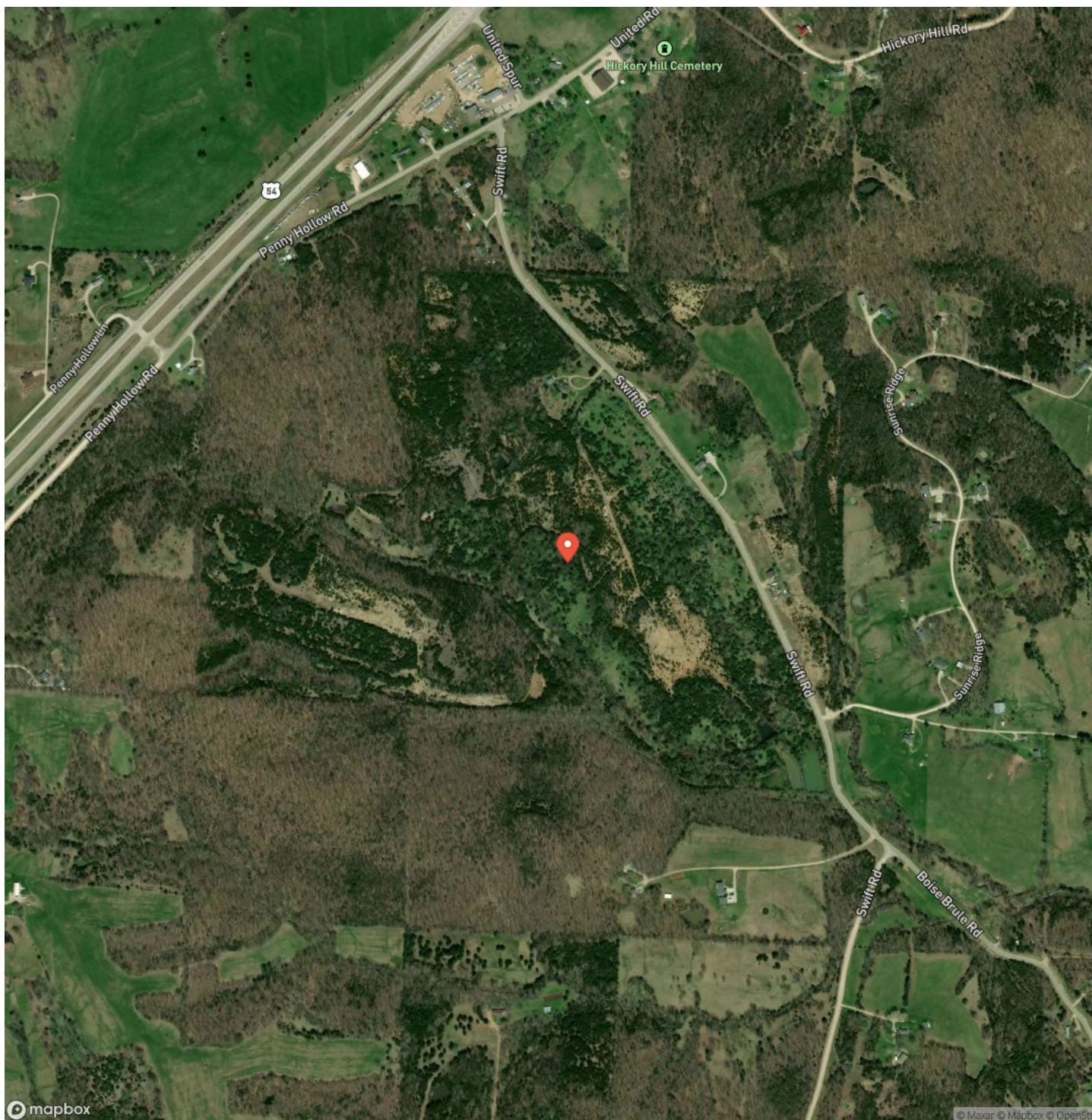
Locator Map
