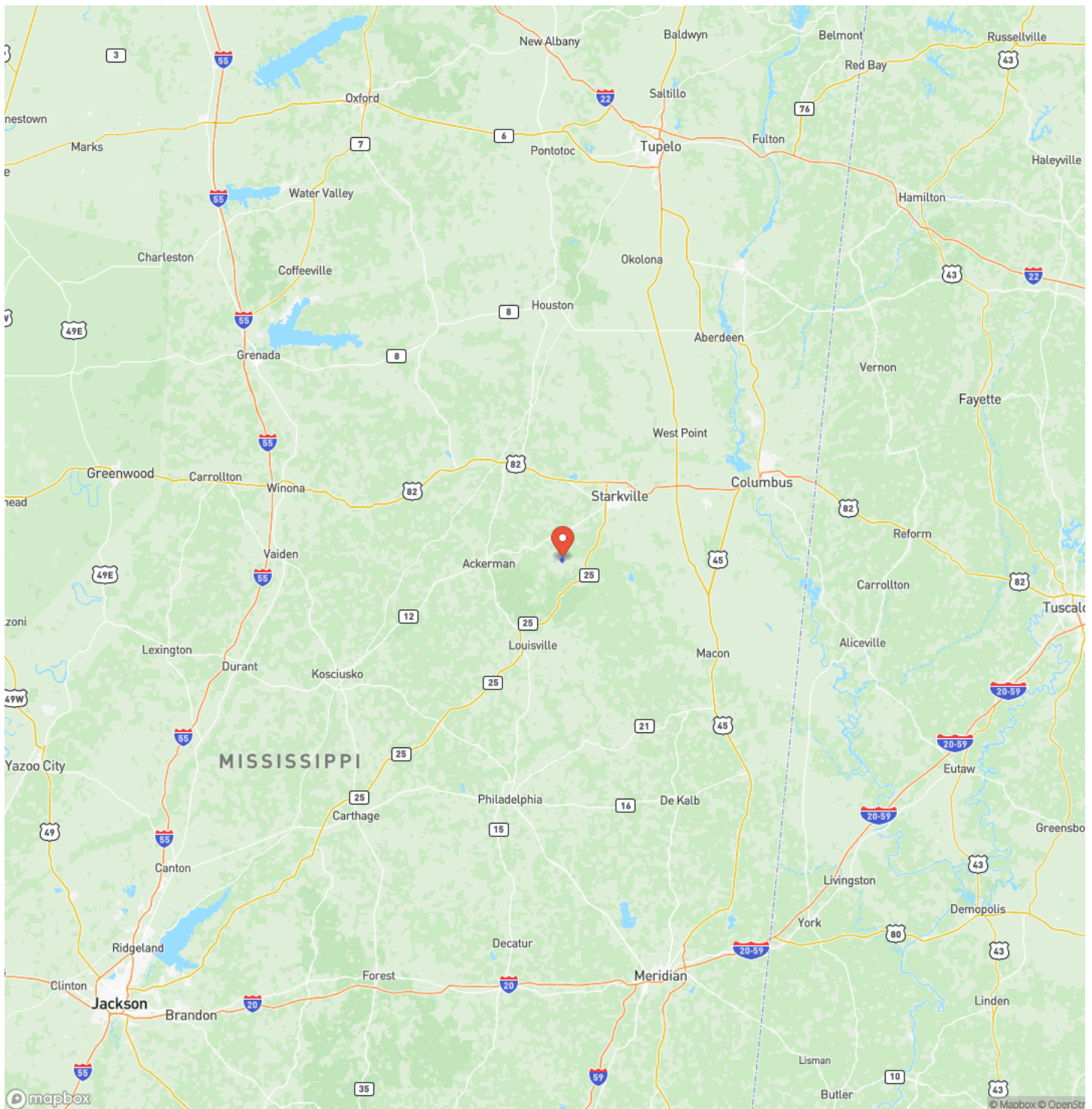


Locator Map

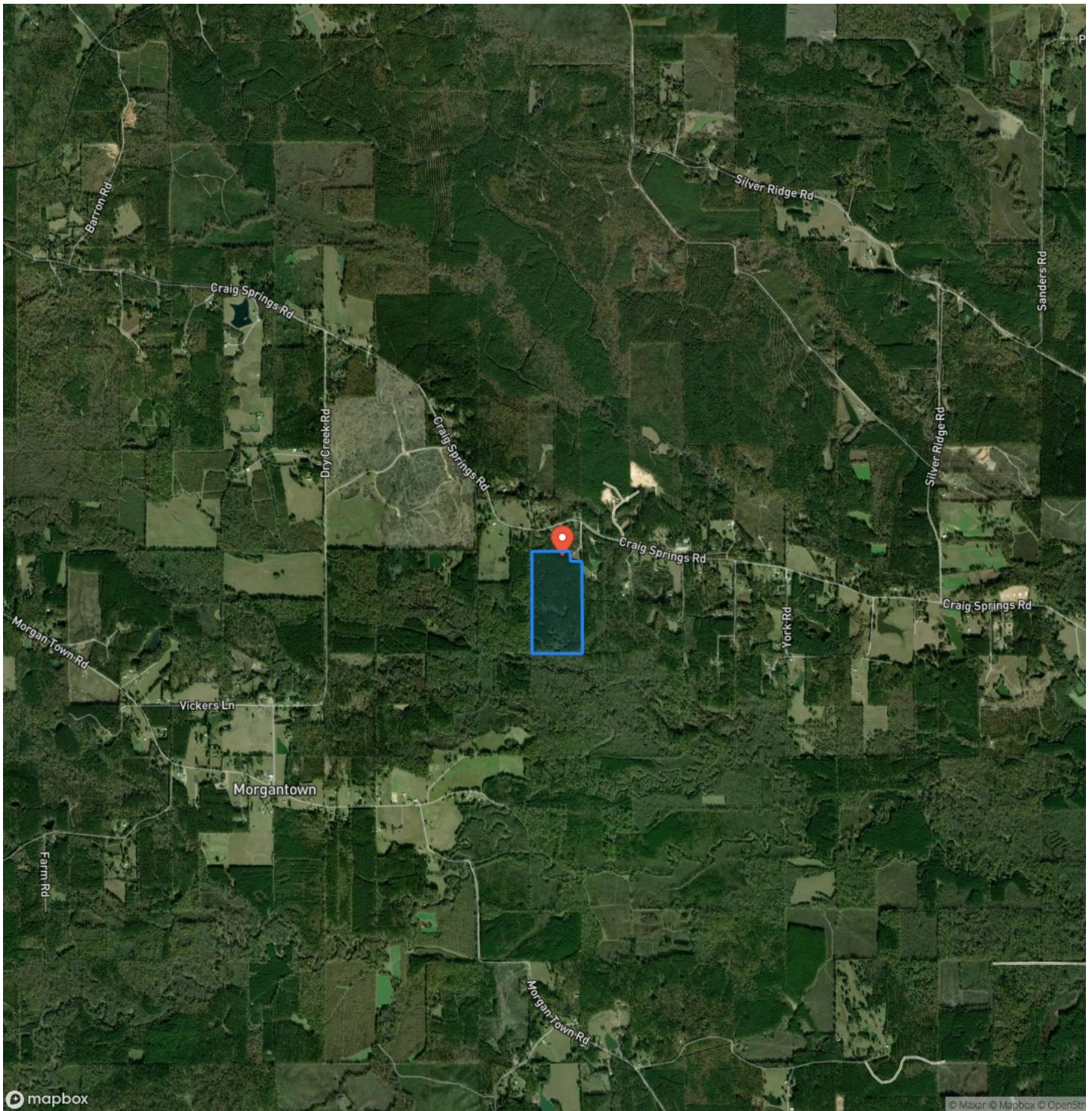
