#### **PROPERTY DESCRIPTION**

Dry Bayou Farm is in the southeastern portion of Quitman County, Mississippi, which happens to be the middle of waterfowl hunting paradise. It lies along the west side of Dry Bayou Road, on the south side of Terry Road, and the north side of Mattie Road. Crowder is just two and one-half miles miles to the northeast. The Coldwater River Refuge is less than two miles to the southeast. There is a single irrigat well with a turbine pump and gearhead for watering crops or filling the duck holes. The farm has good access on three sides and is relatiflat with some natural roll. It has been watered using the ridges to water down the row. Portions of the cropland are used for recreationa hunting and have not cropped in several years. These areas could be used for row-crops or continue being used for growing duck food. C around 310 acres are used for row-crop production. The soils consisted of 10.3% Class I Pearson silt loam, and Pearson silty clay loam, at 89.9% Class III Brittain silt clay loam, Brittain silt loam, and Waverly soils. There is an older brick farm house that has been used for a hun camp and a pole barn for storing boats, decoys or tractors, etc.


This farm is the right spot for continuing to develop for waterfowl hunting. A little ditch work and some landforming would dramatically improve the farming potential.








