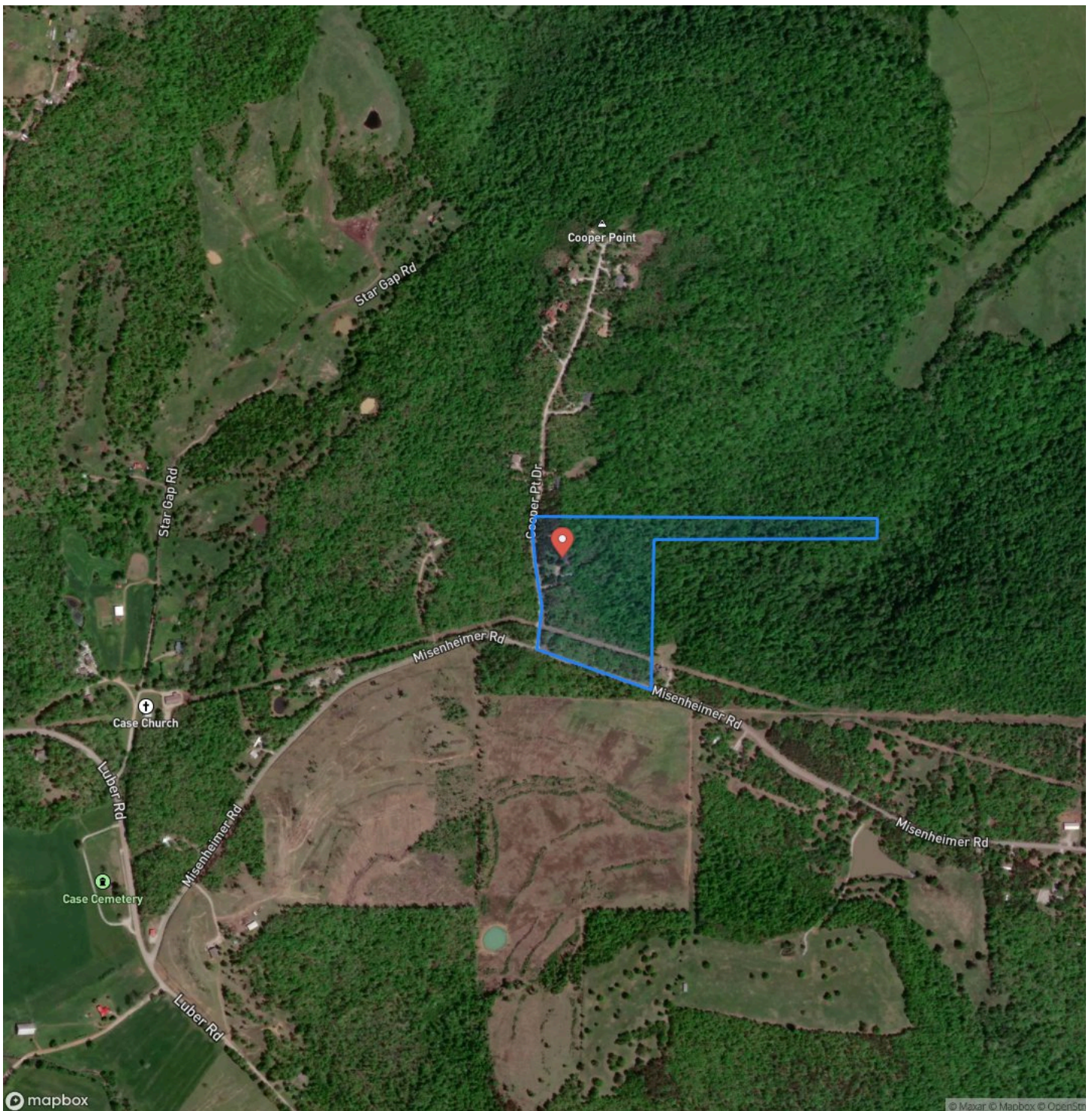
Locator Map
