Locator Map

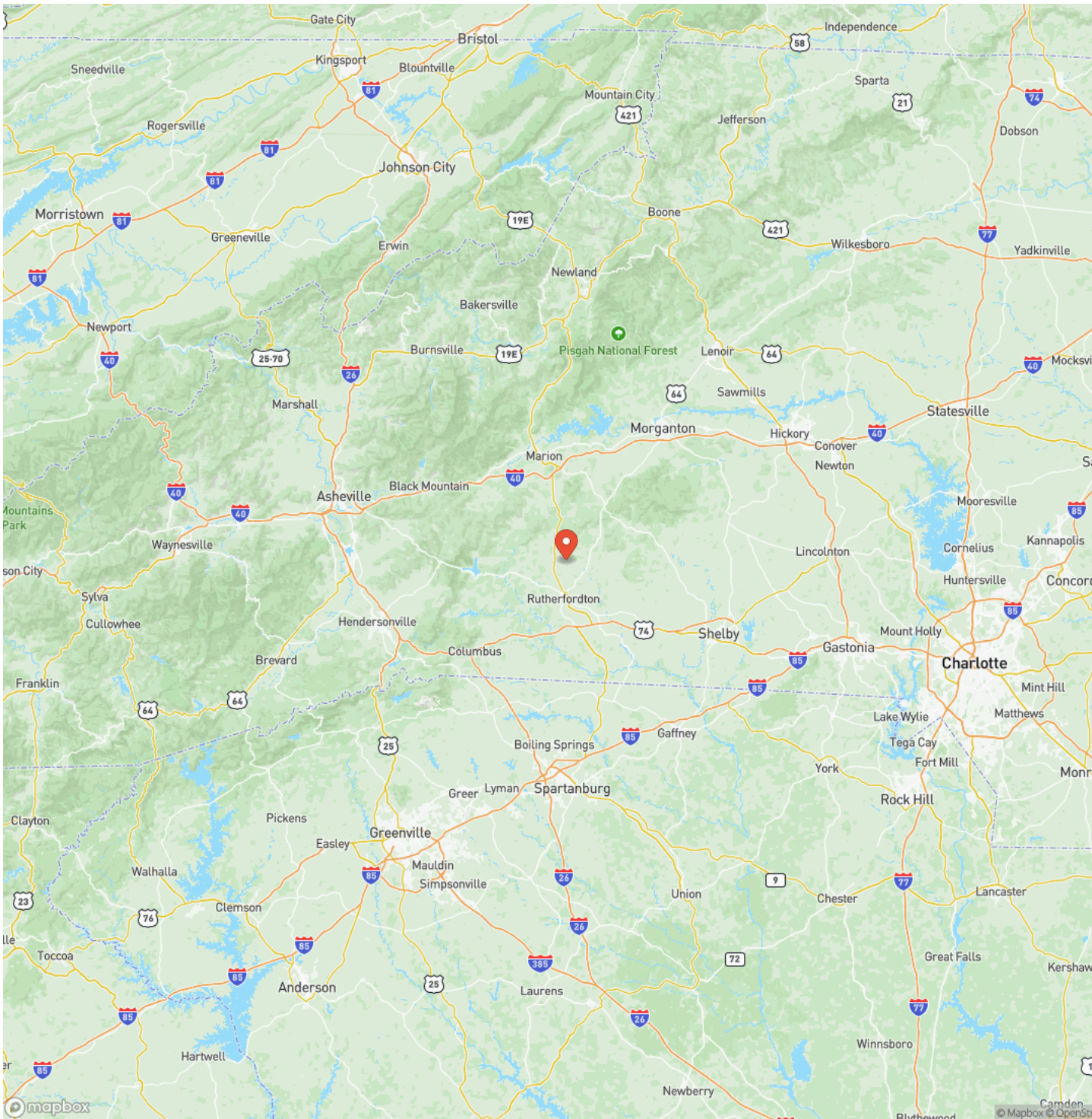

Locator Map

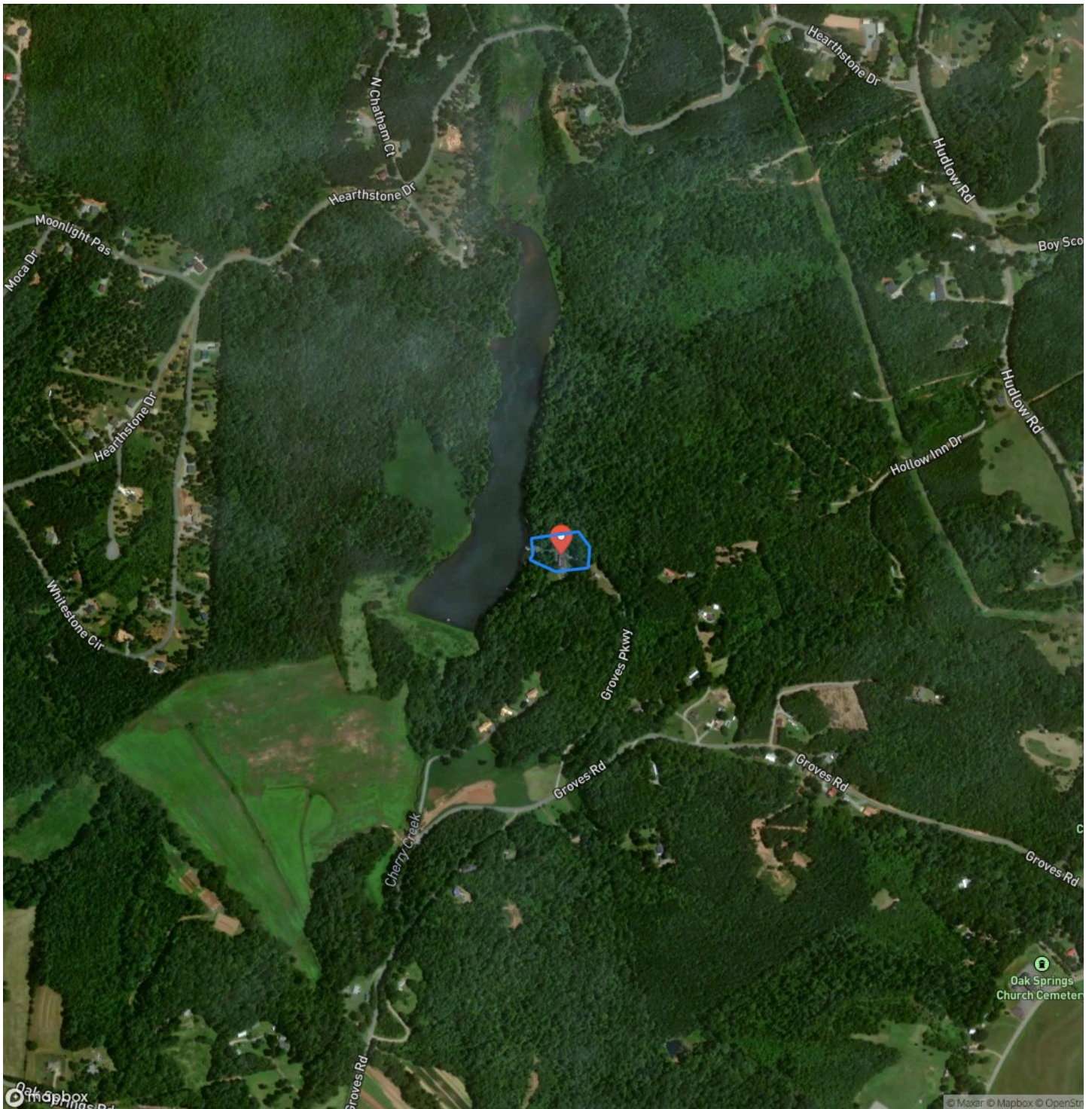
