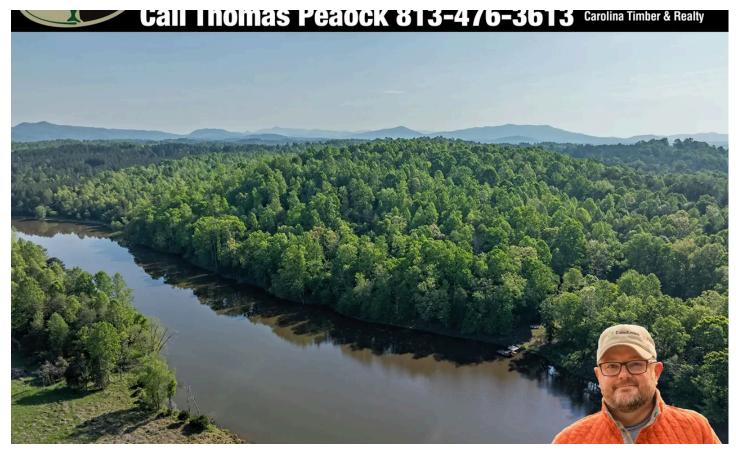

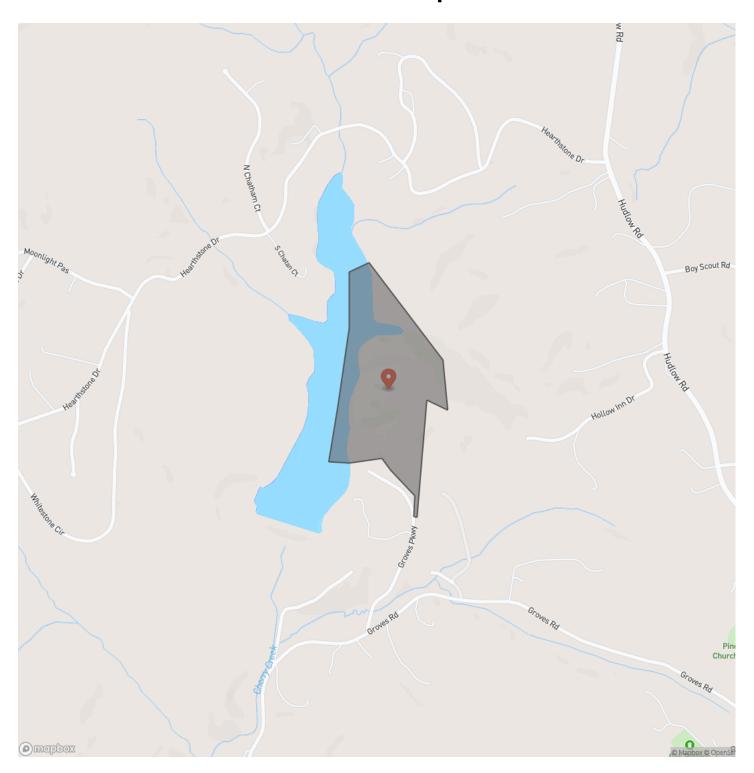

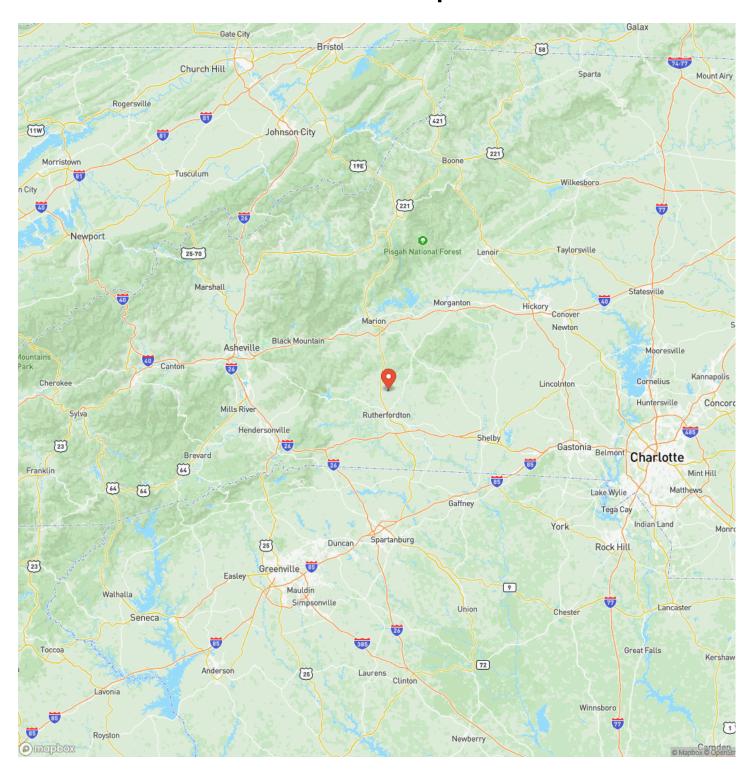


Locator Map
