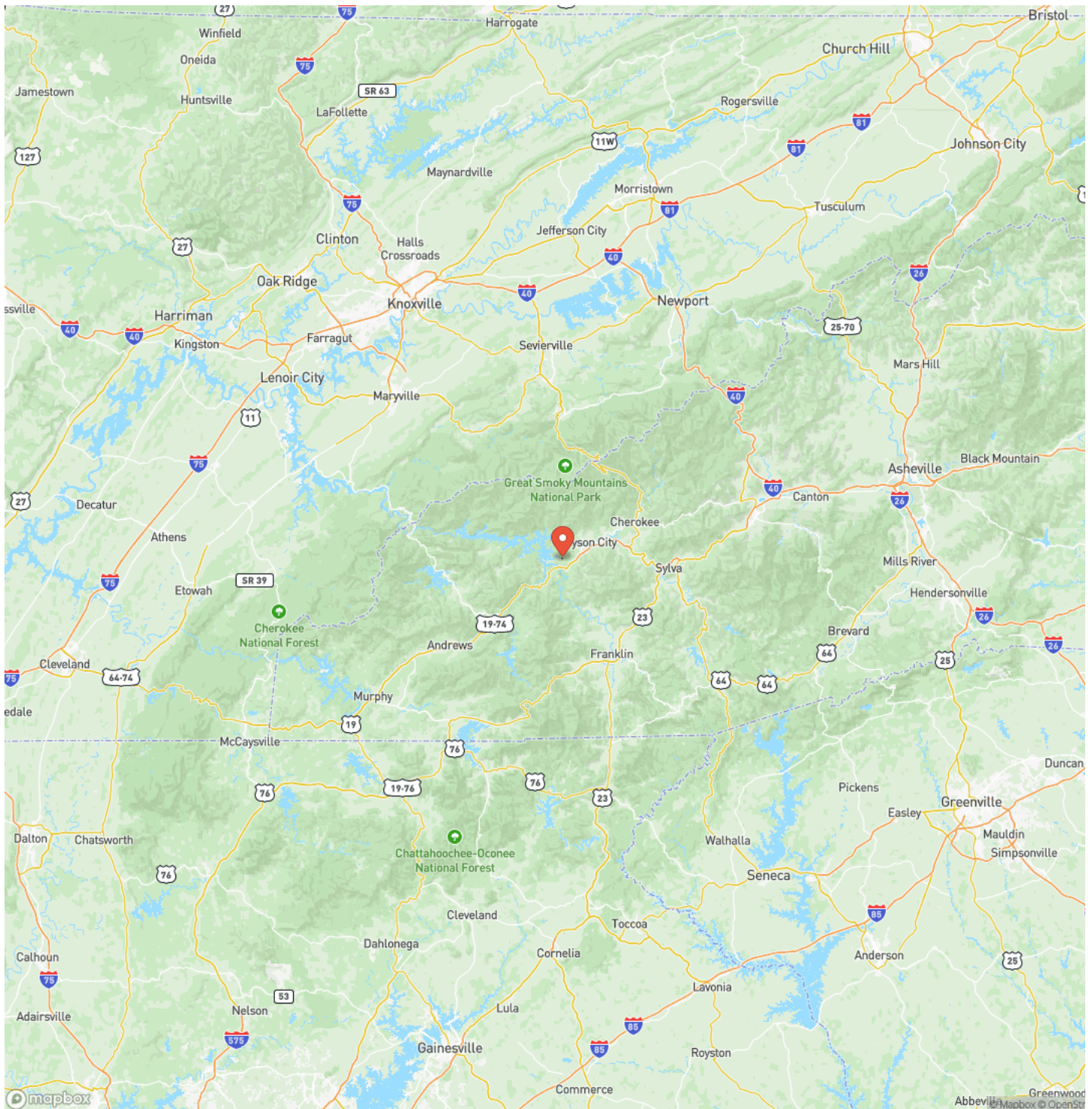


Locator Map
