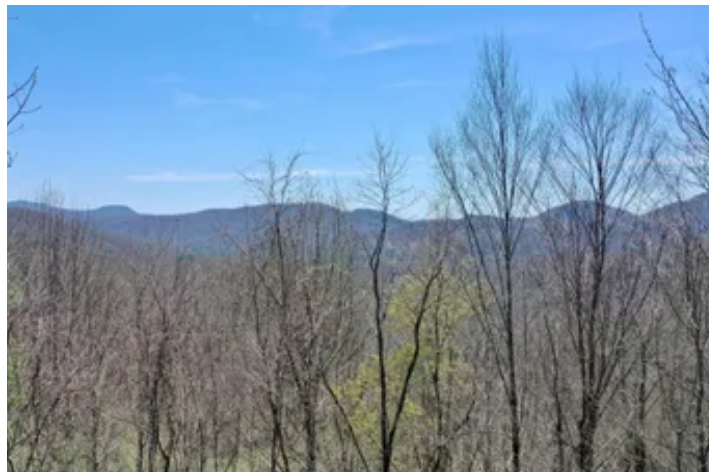

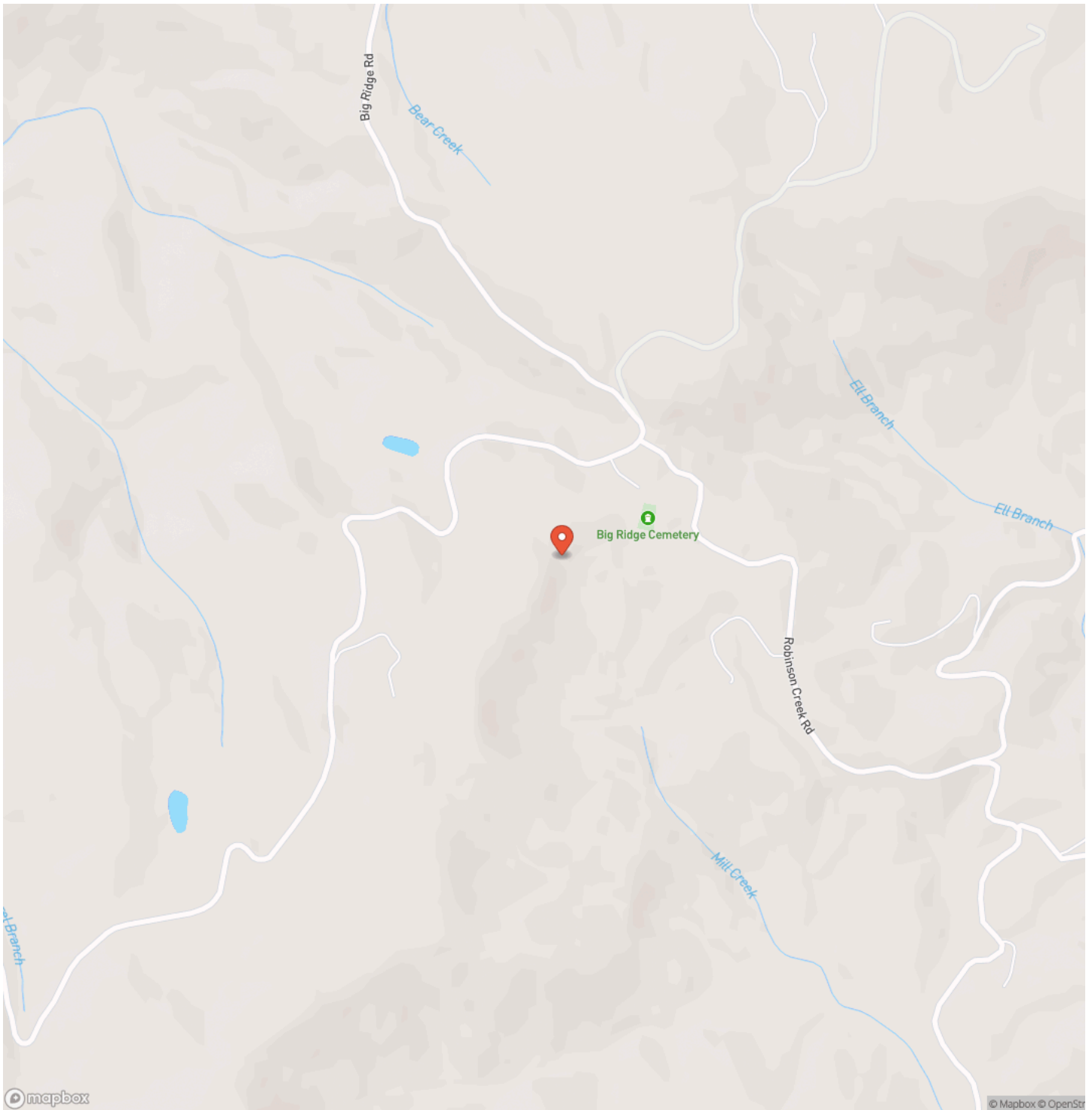

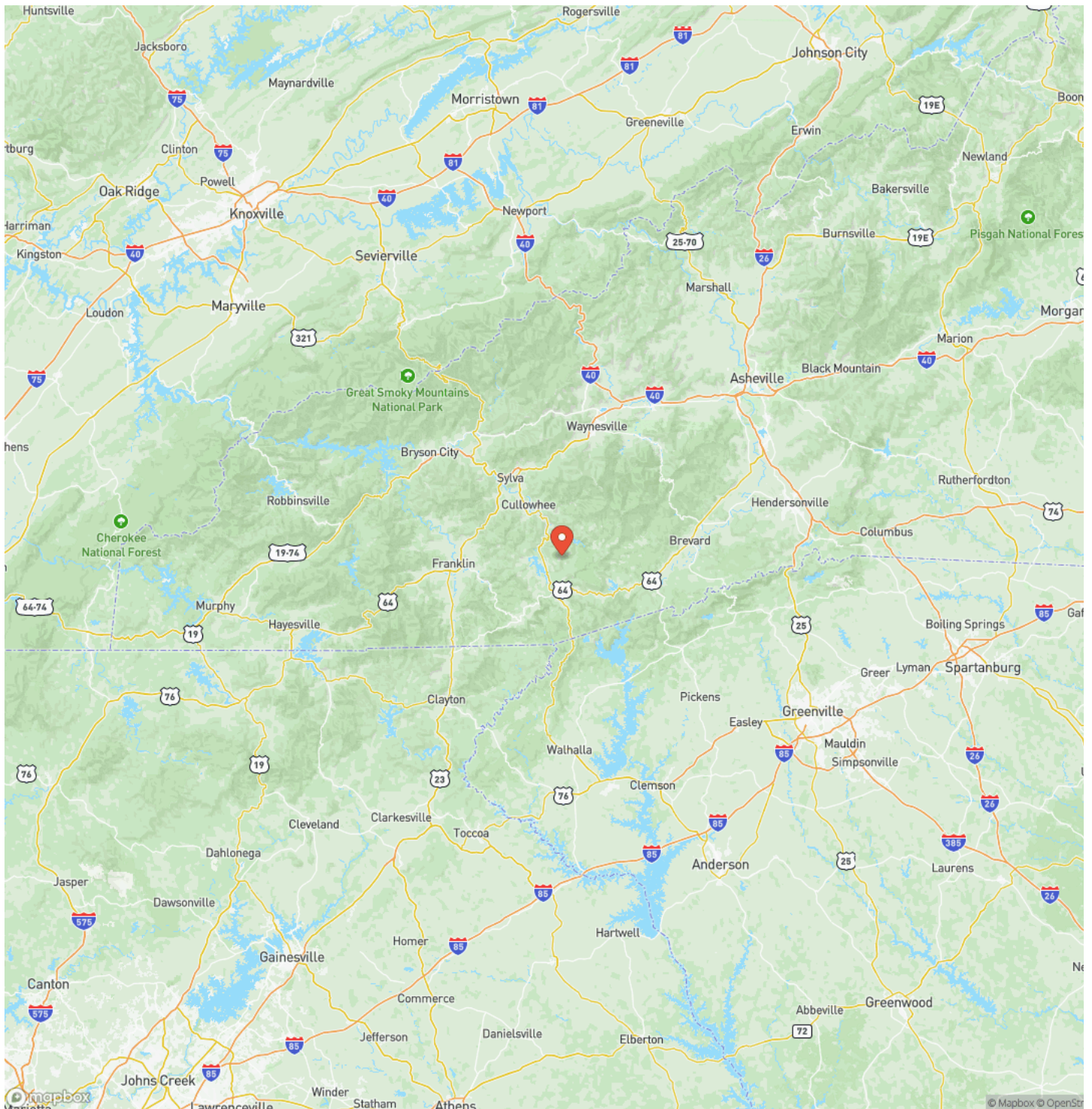

Locator Map



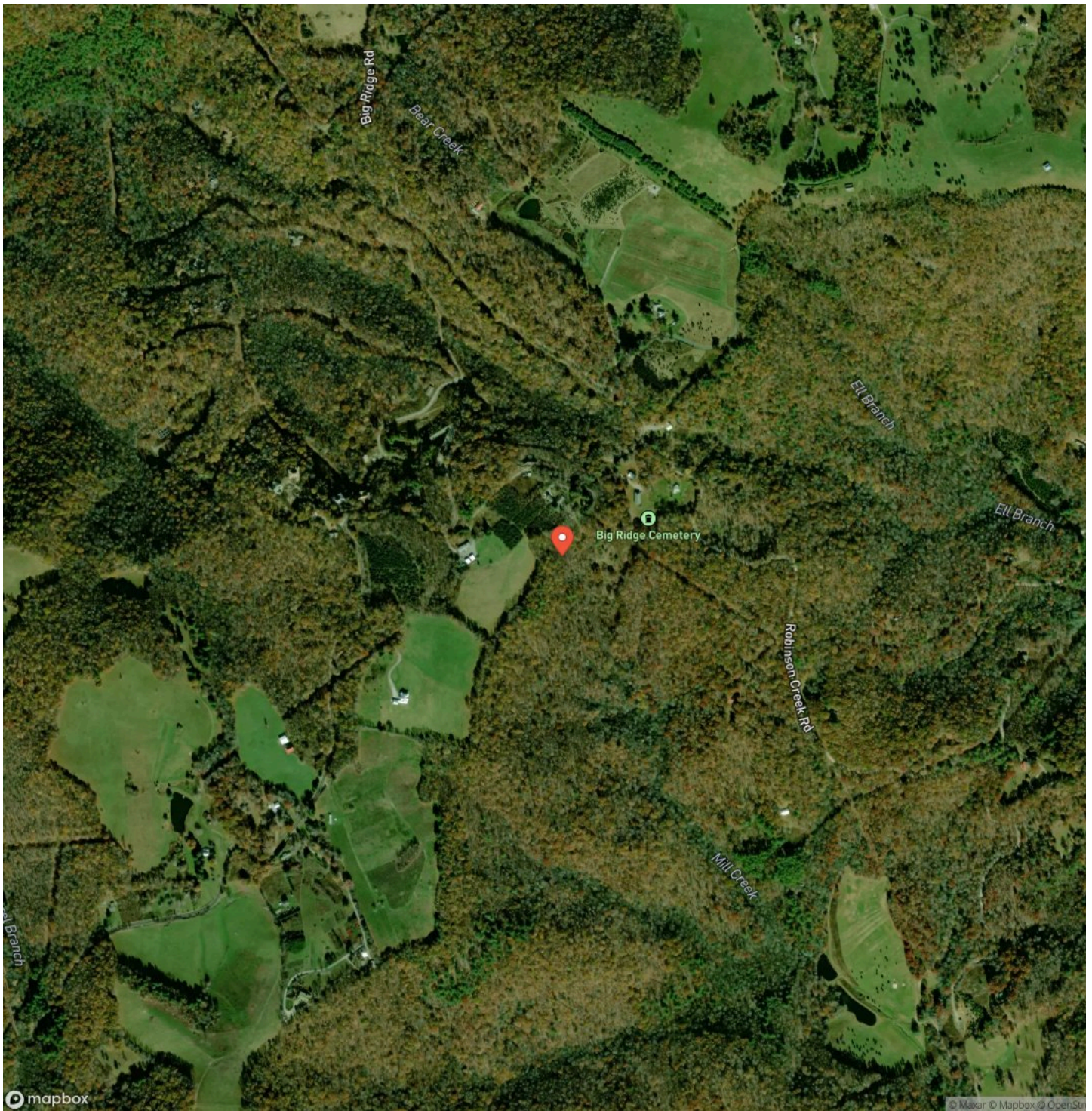
