That said Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) to him in hand paid, the receipt of which is hereby acknowledged, has remised and released and by these presents does remise, release, convey, and forever quitclaim unto the Grantee, his heirs and/or successors and assigns, all right, title, claim and interest of the Grantor in and to a certain lot or parcel of land lying and being in

Webster Township, Jackson County, North Carolina, and more particularly described as follows:

TRACT No. 1: "BEGINNING at an iron pin set located N. 29-19 W. 579.50 feet from a hub by a stake, the beginning corner of lands awarded to Helen Buchanan Ashe, and runs N. 27-19 W. 146.50 feet to an iron pin set; thence N. 75-44 E. 207.09 feet to an iron pin set; thence S. 23-23 E. 146.00 feet to an iron pin set; thence S. 76-16 W. 197.39 feet to the BEGINNING, containing 0.665 of an acre, more or less, as surveyed by Thomas H. Cabe, RLS, in August 1981. "

BEING AND COMPREHENDING the same lands and premises as described in a deed dated 16 November 1992 from William H. Henry and Wanda Henry to Brad C. Moses and recorded in Book 816 at page 535, Jackson County Public Registry.

TRACT NO. II: "BEGINNING at a hub by a stake found, the southeasternmost corner of the lands, and runs thence N. 63-40-10 W. 637.86 feet to an iron pin found; thence S. 69-41-50 W. 442.85 feet to a ten inch white oak; thence N. 03-41-50 E. 591.14 feet to an iron; thence N. 42-26-50 E. 75.90 feet to an iron; thence N. 06-35-40 E. 312.44 feet to an iron; thence N. 72-25-55 W. 243.23 feet to an iron; thence N. 05-55-35 E. 352.24 feet to a locust hub at the top of Kings Mountain; thence with the top of Kings Mountain N. 62-46-30 E. 246.77 feet to a stake at a 6 inch mountain oak; thence S. 27-19-10 E. 1,825.93 feet to the BEGINNING", consisting of 16 acres, more or less.

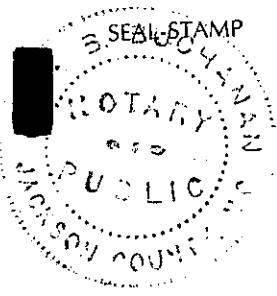
