

BEING Lot No. G-3 of the FOXFIRE ESTATES, CAROLINA VISTAS, INC., Property, Tuskeegee Creek, Stecoah Townshîp, Graham County, North Carolina, per plat of survey dated March 7, 1975, by W. G. Davis, R. L. S., 1115, Surveyor, said plat recorded in the Office of the Register of Deeds of Graham County, North Carolina, in Plat Book No. 3, at Page 106, and being more particularly described as follows:

BEGINNING on an iron pin located on a ridge, a corner common to Lot No. G-2; thence runs with said ridge N 89-24 E 248.51 feet to a planted rock; thence 534-01 W 414.06 feet to a point located in the centerline of a private ccess road and in the line of Lot No. F-1; thence runs with the centerline of said road and with a line common to Lot No. F-1 N 06-42 W 113.41 feet to a point located in the centerline of said private road and in the line of Lot No. F-1, and being a corner common to Lot No. G-2; thence runs with a line common to Lot No. G-2 N 06-10 E 279.30 feet to the BEGINNING, containing 1.194 acres.
