The varieties are as follows: Farthing, Kee脆isp, Meadowlark, and Optimus. This farm is also approved for Crop Insurance. The property has over 1,550' feet of paved road frontage on GA Hwy 110 and a 1,300'ft Gravel Drive way. There are multiple home sites on the property. Locator Map






