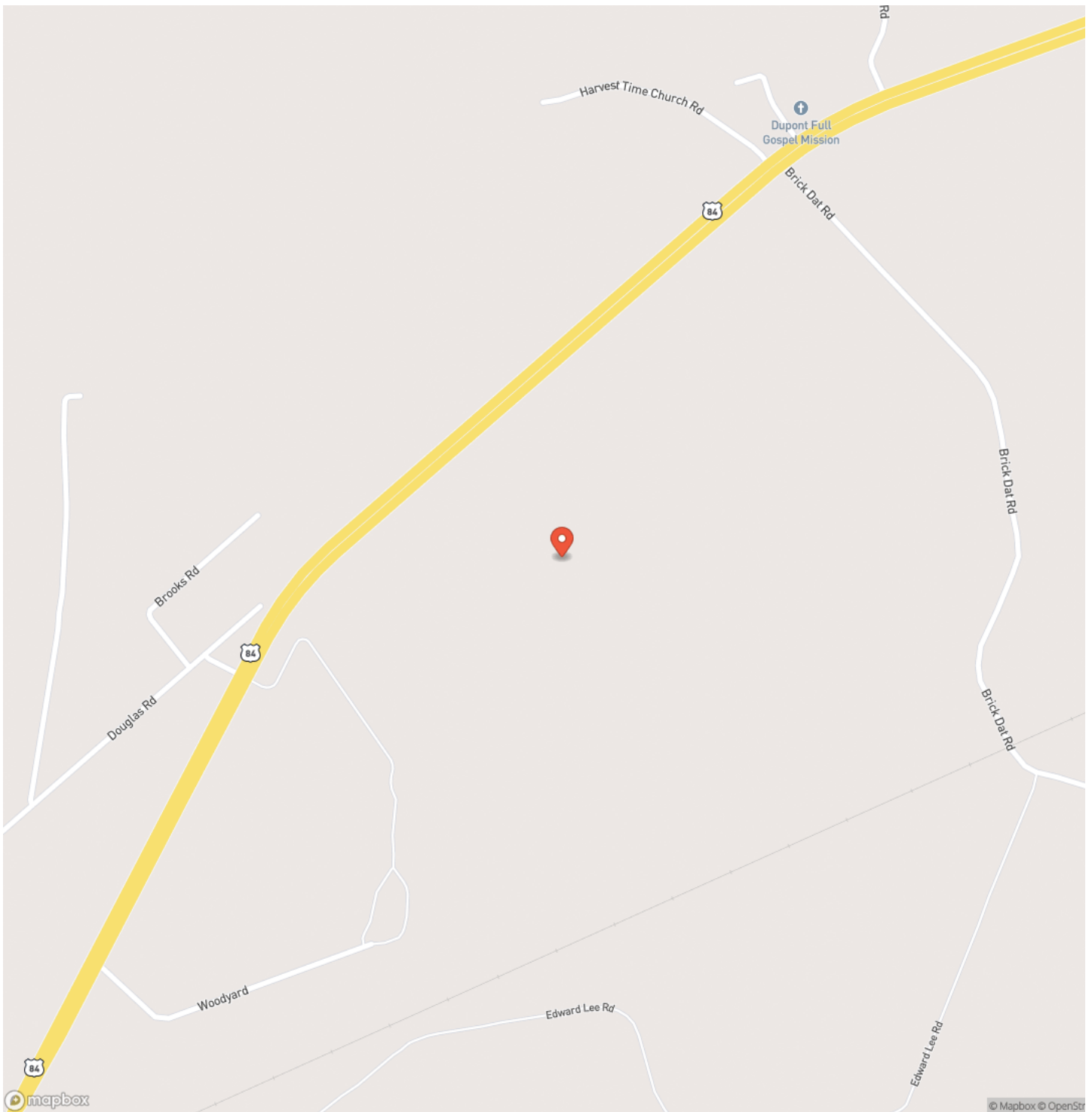

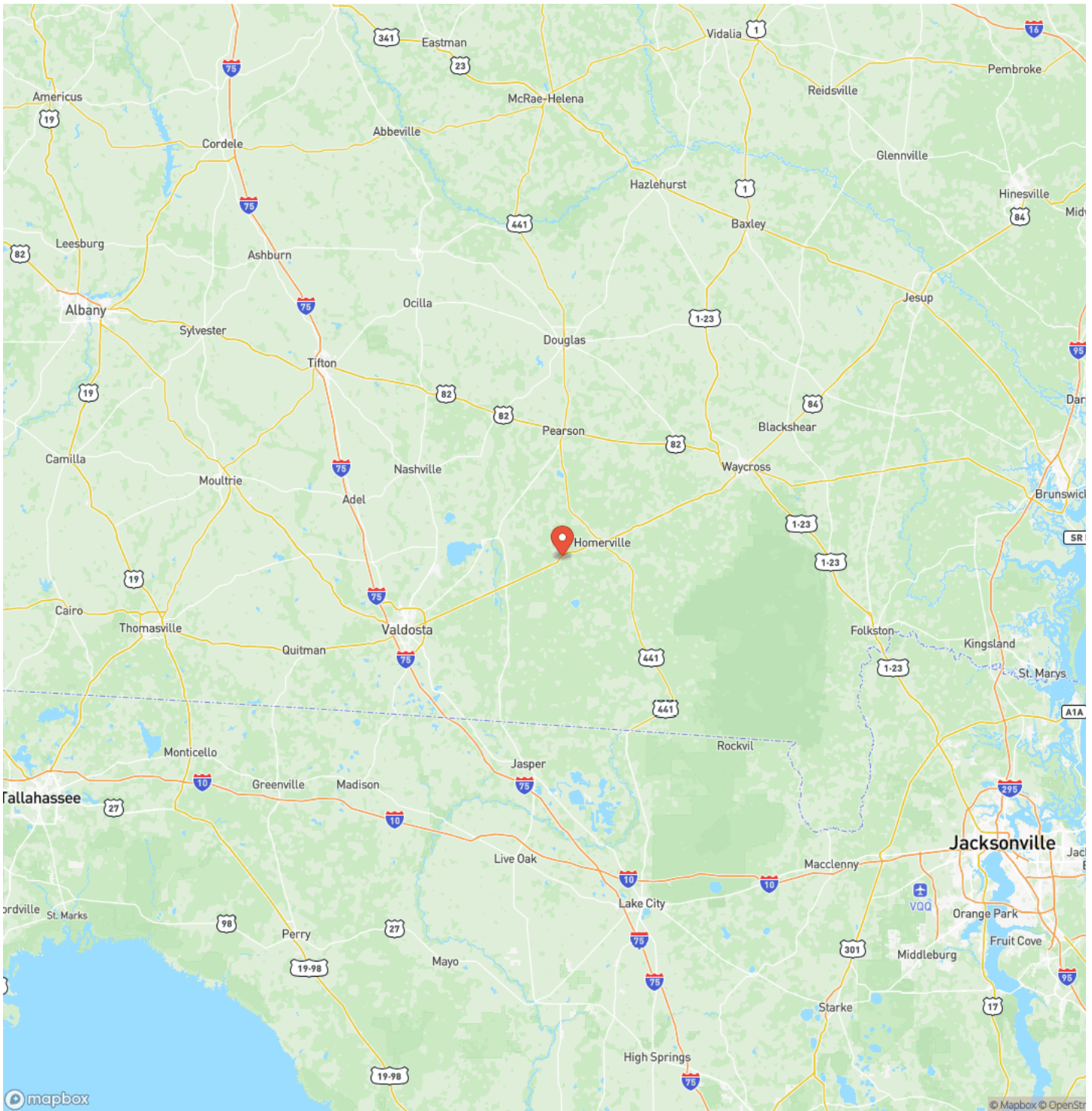

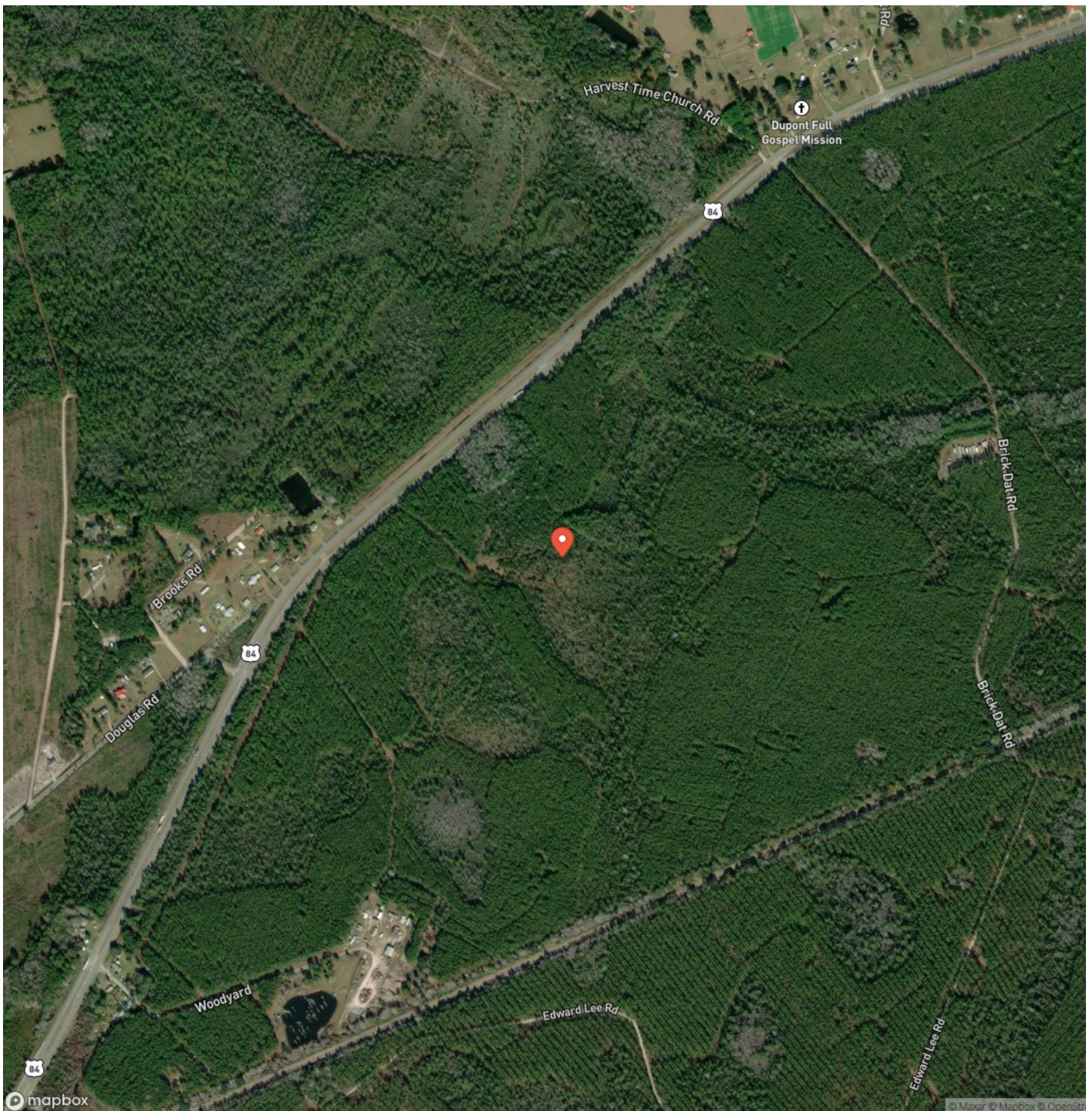
Locator Map

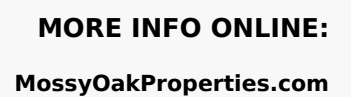
